# A BILL

To require the Director of the Office of Personnel Management to establish and maintain a public directory of the individuals occupying Government policy and supporting positions, and for other purposes.

1       *Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Periodically Listing  
 3 Updates to Management Act of 2022” or the “PLUM Act  
 4 of 2022”.

5 **SEC. 2. ESTABLISHMENT OF PUBLIC WEBSITE ON GOVERN-  
 6 MENT POLICY AND SUPPORTING POSITIONS.**

7 **(a) ESTABLISHMENT.—**

8 **(1) IN GENERAL.**—Subchapter I of chapter 33  
 9 of title 5, United States Code, is amended by adding  
 10 at the end the following:

11 **“§ 3330f. Government policy and supporting position  
 12 data**

13 **“(a) DEFINITIONS.**—In this section:

14 **“(1) AGENCY.**—The term ‘agency’ means—

15 **“(A)** any Executive agency, the United  
 16 States Postal Service, and the Postal Regu-  
 17 latory Commission;

18 **“(B)** the Architect of the Capitol, the Gov-  
 19 ernment Accountability Office, the Government  
 20 Publishing Office, and the Library of Congress;  
 21 and

22 **“(C)** the Executive Office of the President  
 23 and any component within that Office (includ-  
 24 ing any successor component), including—

25 **“(i)** the Council of Economic Advi-  
 26 sors;

1               “(ii) the Council on Environmental  
2               Quality;

3               “(iii) the National Security Council;

4               “(iv) the Office of the Vice President;

5               “(v) the Office of Policy Development;

6               “(vi) the Office of Administration;

7               “(vii) the Office of Management and  
8               Budget;

9               “(viii) the Office of the United States  
10              Trade Representative;

11              “(ix) the Office of Science and Tech-  
12              nology Policy;

13              “(x) the Office of National Drug Con-  
14              trol Policy; and

15              “(xi) the White House Office, includ-  
16              ing the White House Office of Presidential  
17              Personnel.

18              “(2) APPOINTEE.—The term ‘appointee’

19              “(A) means an individual serving in a pol-  
20              icy and supporting position; and

21              “(B) includes an individual serving in such  
22              a position temporarily in an acting capacity in  
23              accordance with—

1               “(i) sections 3345 through 3349d  
2               (commonly referred to as the ‘Federal Va-  
3               eancies Reform Act of 1998’);

4               “(ii) any other statutory provision de-  
5               scribed in section 3347(a)(1); or

6               “(iii) a Presidential appointment de-  
7               scribed in section 3347(a)(2).

8               “(3) COVERED WEBSITE.—The term ‘covered  
9               website’ means the website established and main-  
10               tained by the Director under subsection (b).

11               “(4) DIRECTOR.—The term ‘Director’ means  
12               the Director of the Office of Personnel Management.

13               “(5) POLICY AND SUPPORTING POSITION.—The  
14               term ‘policy and supporting position’ means—

15               “(A) a position that requires appointment  
16               by the President, by and with the advice and  
17               consent of the Senate;

18               “(B) a position that requires or permits  
19               appointment by the President or Vice Presi-  
20               dent, without the advice and consent of the  
21               Senate;

22               “(C) a position occupied by a limited term  
23               appointee, limited emergency appointee, or non-  
24               career appointee in the Senior Executive Serv-

1           iee, as defined under paragraphs (5), (6), and  
2           (7), respectively, of section 3132(a);

3           “(D) a position of a confidential or policy-  
4           determining character under schedule C of sub-  
5           part C of part 213 of title 5, Code of Federal  
6           Regulations, or any successor regulation;

7           “(E) a position in the Senior Foreign Serv-  
8           iee;

9           “(F) any career position at an agency that,  
10          but for this section and section 2(b)(3) of the  
11          PLUM Act of 2022, would be included in the  
12          publication entitled ‘United States Government  
13          Policy and Supporting Positions’, commonly re-  
14          ferred to as the ‘Plum Book’; and

15          “(G) any other position classified at or  
16          above level GS-14 of the General Schedule (or  
17          equivalent) that is excepted from the competi-  
18          tive service by law because of the confidential or  
19          policy-determining nature of the position duties.

20          “(b) ESTABLISHMENT OF WEBSITE.—Not later than  
21          1 year after the date of enactment of the PLUM Act of  
22          2022, the Director shall establish, and thereafter the Di-  
23          rector shall maintain, a public website containing the fol-  
24          lowing information for the President in office on the date  
25          of establishment and for each subsequent President:

1           “(1) Each policy and supporting position in the  
2       Federal Government, including any such position  
3       that is vacant.

4           “(2) The name of each individual who—

5           “(A) is serving in a position described in  
6       paragraph (1); or

7           “(B) previously served in a position de-  
8       scribed in such paragraph under the applicable  
9       President.

10          “(3) Information on—

11           “(A) any Government-wide or agency-wide  
12       limitation on the total number of positions in  
13       the Senior Executive Service under section  
14       3133 or 3132 or the total number of positions  
15       under schedule C of subpart C of part 213 of  
16       title 5, Code of Federal Regulations; and

17           “(B) the total number of individuals occu-  
18       pying such positions.

19          “(e) CONTENTS.—With respect to any policy and  
20       supporting position listed on the covered website, the Di-  
21       rector shall include—

22           “(1) the agency, and agency component, (in-  
23       cluding the agency and bureau code used by the Of-  
24       fice of Management and Budget) in which the posi-  
25       tion is located;

- 1                 “(2) the name of the position;
- 2                 “(3) the name of the individual occupying the
- 3                 position (if any);
- 4                 “(4) the geographic location of the position, in-
- 5                 cluding the city, State or province, and country;
- 6                 “(5) the pay system under which the position is
- 7                 paid;
- 8                 “(6) the level, grade, or rate of pay;
- 9                 “(7) the term or duration of the appointment
- 10                 (if any);
- 11                 “(8) the expiration date, in the case of a time-
- 12                 limited appointment;
- 13                 “(9) a unique identifier for each appointee to
- 14                 enable tracking the appointee across positions;
- 15                 “(10) whether the position is vacant; and
- 16                 “(11) for any position that is vacant—
- 17                         “(A) for a position for which appointment
- 18                 is required to be made by the President by and
- 19                 with the advice and consent of the Senate; the
- 20                 name of the acting official; and
- 21                         “(B) for other positions, the name of the
- 22                 official performing the duties of the vacant po-
- 23                 sition.

1       “(d) CURRENT DATA.—For each agency, the Director  
2 shall indicate in the information on the covered website  
3 the date that the agency last updated the data.

4       “(e) FORMAT.—The Director shall make the data on  
5 the covered website available to the public at no cost over  
6 the internet in a searchable, sortable, downloadable, and  
7 machine-readable format so that the data qualifies as an  
8 open Government data asset, as defined in section 3502  
9 of title 44.

10     “(f) AUTHORITY OF DIRECTOR.—

11       “(1) INFORMATION REQUIRED.—Each agency  
12 shall provide to the Director any information that  
13 the Director determines necessary to establish and  
14 maintain the covered website, including the informa-  
15 tion uploaded under paragraph (4).

16       “(2) REQUIREMENTS FOR AGENCIES.—Not  
17 later than 1 year after the date of enactment of the  
18 PLUM Act of 2022, the Director shall issue instruc-  
19 tions to agencies with specific requirements for the  
20 provision or uploading of information required under  
21 paragraph (1), including—

22           “(A) specific data standards that an agen-  
23 cy shall follow to ensure that the information is  
24 complete, accurate, and reliable;

25           “(B) data quality assurance methods; and

1               “(C) the timeframe during which an agen-  
2        cy shall provide or upload the information, in-  
3        cluding the timeframe described under para-  
4        graph (4).

5               “(3) PUBLIC ACCOUNTABILITY.—The Director  
6        shall identify on the covered website any agency that  
7        has failed to provide—

8               “(A) the information required by the Di-  
9        rector;

10               “(B) complete, accurate, and reliable infor-  
11        mation; or

12               “(C) the information during the timeframe  
13        specified by the Director.

14               “(4) MONTHLY UPDATES.—

15               “(A) IN GENERAL.—Not later than 90  
16        days after the date on which the covered  
17        website is established, and not less than once  
18        during each 30-day period thereafter, the head  
19        of each agency shall upload to the covered  
20        website updated information (if any) on—

21               “(i) the policy and supporting posi-  
22        tions in the agency;

23               “(ii) the appointees occupying such  
24        positions in the agency; and

1                 “(iii) the former appointees who  
2                 served in such positions in the agency  
3                 under the President then in office.

4                 “(B) SUPPLEMENT NOT SUPPLANT.—In-  
5                 formation provided under subparagraph (A)  
6                 shall supplement, not supplant, previously pro-  
7                 vided information under that subparagraph.

8                 “(5) OPM HELP DESK.—The Director shall es-  
9                 tablish a central help desk, to be operated by not  
10                 more than 1 full-time employee, to assist any agency  
11                 with implementing this section.

12                 “(6) COORDINATION.—The Director may des-  
13                 ignate 1 or more agencies to participate in the devel-  
14                 opment, establishment, operation, and support of the  
15                 covered website. With respect to any such designa-  
16                 tion, the Director may specify the scope of the re-  
17                 sponsibilities of the agency so designated.

18                 “(7) DATA STANDARDS AND TIMING.—The Di-  
19                 rector shall make available on the covered website  
20                 information regarding data collection standards,  
21                 quality assurance methods, and time frames for re-  
22                 porting data to the Director.

23                 “(8) REGULATIONS.—The Director may pre-  
24                 scribe regulations necessary for the administration  
25                 of this section.

1       “**(g) RESPONSIBILITY OF AGENCIES.**—

2               “(1) PROVISION OF INFORMATION.—Each agen-  
3        cy shall comply with the instructions and guidance  
4        issued by the Director to carry out this section; and,  
5        upon request of the Director, shall provide appro-  
6        priate assistance to the Director to ensure the suc-  
7        cessful operation of the covered website in the man-  
8        ner and within the timeframe specified by the Direc-  
9        tor under subsection (f)(2).

10              “(2) ENSURING COMPLETENESS, ACCURACY,  
11        AND RELIABILITY.—With respect to any submission  
12        of information described in paragraph (1), the head  
13        of an agency shall include—

14               “(A) an explanation of how the agency en-  
15        sured the information is complete, accurate,  
16        and reliable; and

17               “(B) a certification that the information is  
18        complete, accurate, and reliable.

19        “**(h) INFORMATION VERIFICATION.**—

## 20              “(1) SEMIANNUAL CONFIRMATION.—

21               “(A) IN GENERAL.—Not less frequently  
22        than semiannually, the Director, in coordination  
23        with the White House Office of Presidential  
24        Personnel, shall confirm that the information

1           on the covered website is complete, accurate, reliable, and up-to-date.

3           **“(B) CERTIFICATION.**—On the date on  
4           which the Director makes a confirmation under  
5           subparagraph (A), the Director shall publish on  
6           the covered website a certification that the con-  
7           firmation has been made.

8           **“(2) AUTHORITY OF DIRECTOR.**—In carrying  
9           out paragraph (1), the Director may—

10           **“(A)** request additional information from  
11           an agency; and

12           **“(B)** use any additional information pro-  
13           vided to the Director or the White House Office  
14           of Presidential Personnel for the purposes of  
15           verification.

16           **“(3) PUBLIC COMMENT.**—The Director shall es-  
17           tablish a process under which members of the public  
18           may provide feedback regarding the accuracy of the  
19           information on the covered website.

20           **“(i) DATA ARCHIVING.**—

21           **“(1) IN GENERAL.**—As soon as practicable  
22           after a transitional inauguration day (as defined in  
23           section 3349a), the Director, in consultation with  
24           the Archivist of the United States, shall archive the

1 data that was compiled on the covered website for  
2 the preceding presidential administration.

3           “(2) PUBLIC AVAILABILITY.—The Director  
4 shall make the data described in paragraph (1) pub-  
5 licly available over the internet—

6           “(A) on, or through a link on, the covered  
7 website;

8           “(B) at no cost; and

9           “(C) in a searchable, sortable,  
10 downloadable, and machine-readable format.

11       “(j) REPORTS.—

12       “(1) IN GENERAL.—Not later than 1 year after  
13 the covered website is established, and every year  
14 thereafter, the Director, in coordination with the  
15 White House Office of Presidential Personnel, shall  
16 publish a report on the covered website that—

17           “(A) contains summary-level information  
18 on the demographics of each appointee; and

19           “(B) provide the information in a struc-  
20 tured data format that—

21           “(i) is searchable, sortable, and  
22 downloadable;

23           “(ii) makes use of common identifiers  
24 wherever possible; and

1                 “(iii) contains current and historical  
2                 data regarding the information.

3                 “(2) CONTENTS.—

4                 “(A) IN GENERAL.—Each report published  
5                 under paragraph (1) shall—

6                 “(i) include self-identified data with  
7                 respect to each type of appointee on race,  
8                 ethnicity, Tribal affiliation, gender, dis-  
9                 ability, sexual orientation, veteran status,  
10                 and whether the appointee is over the age  
11                 of 40; and

12                 “(ii) allow for users of the covered  
13                 website to view the type of appointee by  
14                 agency or component, along with the data  
15                 described in clause (i), alone and in com-  
16                 bination, to the greatest level detail pos-  
17                 sible without allowing the identification of  
18                 individual appointees.

19                 “(B) OPTION TO NOT SPECIFY.—When  
20                 each category of data described in subpara-  
21                 graph (A)(i) is collected, each appointee shall be  
22                 allowed an option to not specify with respect to  
23                 any such category.

24                 “(C) CONSULTATION.—The Director shall  
25                 consult with the Committee on Homeland Secu-

1              rity and Governmental Affairs of the Senate  
 2              and the Committee on Oversight and Reform of  
 3              the House of Representatives regarding reports  
 4              published under this subsection and the infor-  
 5              mation in the reports to determine whether the  
 6              intent of this section is being fulfilled and if ad-  
 7              ditional information or other changes are need-  
 8              ed for the reports.

9              **“(3) EXCLUSION OF CAREER POSITIONS.**—For  
 10          purposes of applying the term ‘appointee’ in this  
 11          subsection, that term does not include any individual  
 12          appointed to a position described in subsection  
 13          (a)(5)(F).”.

14              **(2) CLERICAL AMENDMENT.**—The table of sec-  
 15          tions for subchapter I of chapter 33 of title 5,  
 16          United States Code, is amended by adding at the  
 17          end the following:

“3330f. Government policy and supporting position data.”.

18              **(b) OTHER MATTERS.—**

19              **(1) DEFINITIONS.**—In this subsection, the  
 20          terms “agency”, “covered website”, “Director”, and  
 21          “policy and supporting position” have the meanings  
 22          given those terms in section 3330f of title 5, United  
 23          States Code, as added by subsection (a).

24              **(2) GAO REVIEW AND REPORT.**—Not later than  
 25          1 year after the date on which the Director estab-

1       lishes the covered website, the Comptroller General  
2       of the United States shall conduct a review of, and  
3       issue a briefing or report on, the implementation of  
4       this Act and the amendments made by this Act,  
5       which shall include—

6                 (A) the quality of data required to be col-  
7       lected and whether the data is complete, accu-  
8       rate, timely, and reliable;

9                 (B) any challenges experienced by agencies  
10      in implementing this Act and the amendments  
11      made by this Act; and

12                 (C) any suggestions or modifications to en-  
13       hance compliance with this Act and the amend-  
14       ments made by this Act, including best prac-  
15       tices for agencies to follow.

16                 (3) SUNSET OF PLUM BOOK.—Beginning on  
17      January 1, 2024—

18                 (A) the covered website shall serve as the  
19       public directory for policy and supporting posi-  
20       tions in the Government; and

21                 (B) the publication entitled “United States  
22       Government Policy and Supporting Positions”,  
23       commonly referred to as the “Plum Book”,  
24       shall no longer be issued or published.

25                 (4) FUNDING.—

1                   (A) IN GENERAL.—No additional amounts  
2                   are authorized to be appropriated to carry out  
3                   this Act or the amendments made by this Act.

4                   (B) OTHER FUNDING.—The Director shall  
5                   carry out this Act and the amendments made  
6                   by this Act using amounts otherwise available  
7                   to the Director.

20                 “(a) *DEFINITIONS.*—In this section:

1               “(B) the Architect of the Capitol, the Government

5               “(C) the Executive Office of the President  
6               and any component within that Office (including—  
7               any successor component), including—

8                       “(i) the Council of Economic Advisers;

9                       “(ii) the Council on Environmental  
10               Quality;

11                       “(iii) the National Security Council;

12                       “(iv) the Office of the Vice President;

13                       “(v) the Office of Policy Development;

14                       “(vi) the Office of Administration;

15                       “(vii) the Office of Management and  
16               Budget;

17                       “(viii) the Office of the United States  
18               Trade Representative;

19                       “(ix) the Office of Science and Tech-  
20               nology Policy;

21                       “(x) the Office of National Drug Con-  
22               trol Policy; and

23                       “(xi) the White House Office, including  
24               the White House Office of Presidential Per-  
25               sonnel.

1       “(2) *APPOINTEE.*—The term ‘appointee’—

2               “(A) means an individual serving in a pol-  
3               icy and supporting position; and

4               “(B) includes an individual serving in such  
5               a position temporarily in an acting capacity in  
6               accordance with—

7               “(i) sections 3345 through 3349d (com-  
8               monly known as the ‘Federal Vacancies Re-  
9               form Act of 1998’);

10               “(ii) any other statutory provision de-  
11               scribed in section 3347(a)(1); or

12               “(iii) a Presidential appointment de-  
13               scribed in section 3347(a)(2).

14       “(3) *COVERED WEBSITE.*—The term ‘covered  
15               website’ means the website established and main-  
16               tained by the Director under subsection (b).

17       “(4) *DIRECTOR.*—The term ‘Director’ means the  
18               Director of the Office of Personnel Management.

19       “(5) *POLICY AND SUPPORTING POSITION.*—The  
20               term ‘policy and supporting position’—

21               “(A) means any position at an agency, as  
22               determined by the Director, that, but for this sec-  
23               tion and section 2(b)(3) of the PLUM Act of  
24               2022, would be included in the publication enti-  
25               tled ‘United States Government Policy and Sup-

1           *porting Positions' (commonly referred to as the  
2           *'Plum Book')*; and*

3           *"(B) may include—*

4               *"(i) a position on any level of the Executive  
5            Schedule under subchapter II of chapter 53, or another position with an  
6            equivalent rate of pay;*

7  
8               *"(ii) a general position (as defined in section 3132(a)(9)) in the Senior Executive  
9            service;*

10  
11              *"(iii) a position in the Senior Foreign Service;*

12  
13              *"(iv) a position of a confidential or policy-determining character under schedule C of subpart C of part 213 of title 5, Code of Federal Regulations, or any successor regulation; and*

14  
15  
16  
17              *"(v) any other position classified at or above level GS-14 of the General Schedule (or equivalent) that is excepted from the competitive service by law because of the confidential or policy-determining nature of the position duties.*

18  
19  
20  
21  
22  
23  
24           *"(b) ESTABLISHMENT OF WEBSITE.—Not later than 1  
25 year after the date of enactment of the PLUM Act of 2022,*

1   *the Director shall establish, and thereafter the Director shall*  
2   *Maintain, a public website containing the following infor-*  
3   *mation for the President in office on the date of establish-*  
4   *ment and for each subsequent President:*

5           “(1) *Each policy and supporting position in the*  
6   *Federal Government, including any such position*  
7   *that is vacant.*

8           “(2) *The name of each individual who—*  
9              “(A) *is serving in a position described in*  
10   *paragraph (1); or*

11           “(B) *previously served in a position de-*  
12   *scribed in such paragraph under the applicable*  
13   *President.*

14           “(3) *Information on—*  
15              “(A) *any Government-wide or agency-wide*  
16   *limitation on the total number of positions in*  
17   *the Senior Executive Service under section 3133*  
18   *or 3134 or the total number of positions under*  
19   *schedule C of subpart C of part 213 of title 5,*  
20   *Code of Federal Regulations; and*

21              “(B) *the total number of individuals occu-*  
22   *pying such positions.*

23           “(c) *CONTENTS.—With respect to any policy and sup-*  
24   *porting position listed on the covered website, the Director*  
25   *shall include—*

1           “(1) the agency, and agency component, (including  
2           the agency and bureau code used by the Office of  
3           Management and Budget) in which the position is lo-  
4           cated;

5           “(2) the name of the position;

6           “(3) the name of the individual occupying the  
7           position (if any);

8           “(4) the geographic location of the position, in-  
9           cluding the city, State or province, and country;

10          “(5) the pay system under which the position is  
11          paid;

12          “(6) the level, grade, or rate of pay;

13          “(7) the term or duration of the appointment (if  
14          any);

15          “(8) the expiration date, in the case of a time-  
16          limited appointment;

17          “(9) a unique identifier for each appointee;

18          “(10) whether the position is vacant; and

19          “(11) for any position that is vacant—

20           “(A) for a position for which appointment  
21           is required to be made by the President, by and  
22           with the advice and consent of the Senate, the  
23           name of the acting official; and

1           “(B) for other positions, the name of the of-  
2       ficial performing the duties of the vacant posi-  
3       tion.

4       “(d) CURRENT DATA.—For each agency, the Director  
5       shall indicate in the information on the covered website the  
6       date that the agency last updated the data.

7       “(e) FORMAT.—The Director shall make the data on  
8       the covered website available to the public at no cost over  
9       the internet in a searchable, sortable, downloadable, and  
10      machine-readable format so that the data qualifies as an  
11      open Government data asset, as defined in section 3502 of  
12      title 44.

13       “(f) AUTHORITY OF DIRECTOR.—

14       “(1) INFORMATION REQUIRED.—Each agency  
15       shall provide to the Director any information that the  
16       Director determines necessary to establish and main-  
17       tain the covered website, including the information  
18       uploaded under paragraph (4).

19       “(2) REQUIREMENTS FOR AGENCIES.—Not later  
20       than 1 year after the date of enactment of the PLUM  
21       Act of 2022, the Director shall issue instructions to  
22       agencies with specific requirements for the provision  
23       or uploading of information required under para-  
24       graph (1), including—

1               “(A) specific data standards that an agency  
2 shall follow to ensure that the information is  
3 complete, accurate, and reliable;

4               “(B) data quality assurance methods; and

5               “(C) the timeframe during which an agency  
6 shall provide or upload the information, includ-  
7 ing the timeframe described under paragraph  
8 (4).

9               “(3) PUBLIC ACCOUNTABILITY.—The Director  
10 shall identify on the covered website any agency that  
11 has failed to provide—

12               “(A) the information required by the Direc-  
13 tor;

14               “(B) complete, accurate, and reliable infor-  
15 mation; or

16               “(C) the information during the timeframe  
17 specified by the Director.

18               “(4) ANNUAL UPDATES.—

19               “(A) IN GENERAL.—Not later than 90 days  
20 after the date on which the covered website is es-  
21 tablished, and not less than once during each  
22 year thereafter, the head of each agency shall  
23 upload to the covered website updated informa-  
24 tion (if any) on—

1                   “(i) the policy and supporting posi-  
2                   tions in the agency;

3                   “(ii) the appointees occupying such po-  
4                   sitions in the agency; and

5                   “(iii) the former appointees who served  
6                   in such positions in the agency under the  
7                   President then in office.

8                   “(B) SUPPLEMENT NOT SUPPLANT.—Infor-  
9                   mation provided under subparagraph (A) shall  
10                  supplement, not supplant, previously provided  
11                  information under that subparagraph.

12                  “(5) OPM HELP DESK.—The Director shall es-  
13                  tablish a central help desk, to be operated by not more  
14                  than 1 full-time employee, to assist any agency with  
15                  implementing this section.

16                  “(6) COORDINATION.—The Director may des-  
17                  ignate 1 or more agencies to participate in the devel-  
18                  opment, establishment, operation, and support of the  
19                  covered website. With respect to any such designation,  
20                  the Director may specify the scope of the responsibil-  
21                  ties of the agency so designated.

22                  “(7) DATA STANDARDS AND TIMING.—The Direc-  
23                  tor shall make available on the covered website infor-  
24                  mation regarding data collection standards, quality

1       *assurance methods, and time frames for reporting*  
2       *data to the Director.*

3       “(8) *REGULATIONS.*—*The Director may pre-*  
4       *scribe regulations necessary for the administration of*  
5       *this section.*

6       “(g) *RESPONSIBILITY OF AGENCIES.*—

7           “(1) *PROVISION OF INFORMATION.*—*Each agency*  
8       *shall comply with the instructions and guidance*  
9       *issued by the Director to carry out this section, and,*  
10      *upon request of the Director, shall provide appro-*  
11      *priate assistance to the Director to ensure the success-*  
12      *ful operation of the covered website in the manner*  
13      *and within the timeframe specified by the Director*  
14      *under subsection (f)(2).*

15       “(2) *ENSURING COMPLETENESS, ACCURACY, AND*  
16      *RELIABILITY.*—*With respect to any submission of in-*  
17      *formation described in paragraph (1), the head of an*  
18      *agency shall include—*

19           “(A) *an explanation of how the agency en-*  
20      *sured the information is complete, accurate, and*  
21      *reliable; and*

22           “(B) *a certification that the information is*  
23      *complete, accurate, and reliable.*

24       “(h) *INFORMATION VERIFICATION.*—

25           “(1) *CONFIRMATION.*—

1                 “(A) *IN GENERAL.*—On the date that is 90  
2                 days after the date on which the covered website  
3                 is established, the Director, in coordination with  
4                 the White House Office of Presidential Personnel,  
5                 shall confirm that the information on the covered  
6                 website is complete, accurate, reliable, and up-to-  
7                 date.

8                 “(B) *CERTIFICATION.*—On the date on  
9                 which the Director makes a confirmation under  
10                 subparagraph (A), the Director shall publish on  
11                 the covered website a certification that the con-  
12                 firmation has been made.

13                 “(2) *AUTHORITY OF DIRECTOR.*—In carrying out  
14                 paragraph (1), the Director may—

15                 “(A) request additional information from  
16                 an agency; and

17                 “(B) use any additional information pro-  
18                 vided to the Director or the White House Office  
19                 of Presidential Personnel for the purposes of  
20                 verification.

21                 “(3) *PUBLIC COMMENT.*—The Director shall es-  
22                 tablish a process under which members of the public  
23                 may provide feedback regarding the accuracy of the  
24                 information on the covered website.

25                 “(i) *DATA ARCHIVING.*—

1           “(1) *IN GENERAL.*—As soon as practicable after  
2        a transitional inauguration day (as defined in sec-  
3        tion 3349a), the Director, in consultation with the  
4        Archivist of the United States, shall archive the data  
5        that was compiled on the covered website for the pre-  
6        ceding presidential administration.

7           “(2) *PUBLIC AVAILABILITY.*—The Director shall  
8        make the data described in paragraph (1) publicly  
9        available over the internet—

10          “(A) on, or through a link on, the covered  
11        website;

12          “(B) at no cost; and

13          “(C) in a searchable, sortable, downloadable,  
14        and machine-readable format.”.

15          (2) *CLERICAL AMENDMENT.*—The table of sec-  
16        tions for subchapter I of chapter 33 of title 5, United  
17        States Code, is amended by adding at the end the fol-  
18        lowing:

“3330f. Government policy and supporting position data.”.

19          (b) *OTHER MATTERS.*—

20           (1) *DEFINITIONS.*—In this subsection, the terms  
21        “agency”, “covered website”, “Director”, and “policy  
22        and supporting position” have the meanings given  
23        those terms in section 3330f of title 5, United States  
24        Code, as added by subsection (a).

1                             (2) *GAO REVIEW AND REPORT.*—Not later than  
2     1 year after the date on which the Director establishes  
3     the covered website, the Comptroller General of the  
4     United States shall conduct a review of, and issue a  
5     briefing or report on, the implementation of this Act  
6     and the amendments made by this Act, which shall  
7     include—

- 8                             (A) the quality of data required to be col-  
9     lected and whether the data is complete, accu-  
10    rate, timely, and reliable;
- 11                             (B) any challenges experienced by agencies  
12     in implementing this Act and the amendments  
13     made by this Act; and
- 14                             (C) any suggestions or modifications to en-  
15     hance compliance with this Act and the amend-  
16     ments made by this Act, including best practices  
17     for agencies to follow.

18                             (3) *SUNSET OF PLUM BOOK.*—Beginning on  
19     January 1, 2026—

- 20                             (A) the covered website shall serve as the  
21     public directory for policy and supporting posi-  
22     tions in the Government; and
- 23                             (B) the publication entitled “United States  
24     Government Policy and Supporting Positions”,

1           *commonly referred to as the “Plum Book”, shall*  
2           *no longer be issued or published.*

3           (4) *FUNDING.—*

4           (A) *IN GENERAL.—No additional amounts*  
5           *are authorized to be appropriated to carry out*  
6           *this Act or the amendments made by this Act.*

7           (B) *OTHER FUNDING.—The Director shall*  
8           *carry out this Act and the amendments made by*  
9           *this Act using amounts otherwise available to the*  
10          *Director.*
