Mr. BROWN of Massachusetts (for himself, Mr. KERRY, and Mr. MORAN) introduced the following bill; which was read twice and referred to the Committee on Homeland Security and Governmental Affairs

A BILL

To designate the facility of the United States Postal Service located at 6 Nichols Street in Westminister, Massachusetts, as the “Lieutenant Ryan Patrick Jones Post Office Building”.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Lieutenant Ryan Pat-

5 rick Jones Post Office Designation Act”.

6 **SEC. 2. FINDINGS.**

7 Congress finds the following:

1 (1) First Lieutenant Ryan Patrick Jones volun-
2 teered to serve the United States in the Army.

3 (2) Lieutenant Jones earned his rank, the
4 Army Achievement Medal, the Purple Heart, the
5 Bronze Star, the Iraqi Freedom Medal, the Combat
6 Action Badge, and the War on Terrorism Badge
7 through his dedication to the highest ideals of the
8 United States.

9 (3) Lieutenant Jones chose from a young age
10 to generously volunteer his talents to his community,
11 and was recognized with academic, social, and ath-
12 letic leadership positions throughout his life.

13 (4) Lieutenant Jones committed himself to ex-
14 cellence in all aspects of his life, including earning
15 a Bachelor of Science degree, with honors, in civil
16 and environmental engineering.

17 (5) While earning his engineering degree at
18 Worcester Polytechnic Institute, Lieutenant Jones
19 was awarded a Reserve Officers' Training Corps
20 scholarship.

21 (6) Lieutenant Jones faithfully and expertly led
22 his fellow soldiers as a platoon leader in the Army's
23 First Infantry Division while deployed to Iraq in
24 2007.

1 (7) Lieutenant Jones made the ultimate sac-
2 rifice for the United States on May 2, 2007, when
3 he was killed in action by an improvised explosive
4 device set by the enemy.

5 (8) Lieutenant Jones' life of service, courage,
6 and honor was made possible by his dedicated par-
7 ents, Mr. Kevin Jones and Mrs. Elaine Jones, who
8 reside in Westminster, Massachusetts.

9 (9) Mr. and Mrs. Jones organized the shipment
10 of supplies to soldiers serving alongside their son,
11 thereby supporting the morale of the members of the
12 Armed Forces.

13 (10) Before entering combat, Lieutenant Jones
14 made arrangements to ensure that his life insurance
15 policy proceeds would become a scholarship fund to
16 benefit others, a request that Mr. and Mrs. Jones
17 fulfilled.

18 (11) Lieutenant Jones is remembered by his
19 family, his friends, and the people of the United
20 States as a role model for his fellow citizens to emu-
21 late.

22 (12) Lieutenant Jones' spirit of generosity has
23 been commemorated by organizations ranging from
24 the Commonwealth of Massachusetts to the Boston
25 Celtics.
