A BILL

To require the President to submit reports and certifications to Congress on the duties of certain employees who are appointed without the advice and consent of the Senate, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Czar Accountability
- 5 Act of 2010".
- 6 SEC. 2. DEFINITIONS.
- 7 In this Act:

1	(1) Appropriate congressional commit-
2	TEES.—The term "appropriate congressional com-
3	mittees" means—
4	(A) the Committee on the Judiciary of the
5	Senate;
6	(B) the Committee on Foreign Relations of
7	the Senate; and
8	(C) the Committee on Homeland Security
9	and Governmental Affairs of the Senate.
10	(2) COVERED EMPLOYEE.—The term "covered
11	employee" means—
12	(A) any employee of the Executive Office
13	of the President who—
14	(i) is not appointed by and with the
15	advice and consent of the Senate; and
16	(ii) reports directly to the President;

18	(B) any employee of the Department of
19	State who—
20	(i) is not appointed by and with the
21	advice and consent of the Senate; and
22	(ii) is an envoy or special representa-
23	tive.

- 11 (a) In General.—The President shall include in
- 12 each report submitted under section 3 a certification to
- 13 Congress of each covered employee who meets the condi-
- 14 tions under subsection (b).
- 15 (b) CERTIFICATION CONDITIONS.—The conditions
- 16 referred to under subsection (a) are—
- 17 (1) with respect to each covered employee de-
- scribed under section 2(2)(A), that the employee is
- 19 not exercising significant authority under the laws of
- the United States;
- 21 (2) with respect to each covered employee de-
- scribed under section 2(2)(B), that the employee is
- 23 not an ambassador, other public minister, or consul;
- 24 and
- 25 (3) with respect to each covered employee, that
- the employee is not exercising any power that has

- 1 been expressly delegated to the President by the
- 2 United States Constitution.
