A BILL

To amend the Sherman Act to make oil-producing and exporting cartels illegal.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "No Oil Producing and
- 5 Exporting Cartels Act of 2011" or "NOPEC".

1 SEC. 2. SHERMAN ACT.

- The Sherman Act (15 U.S.C. 1 et seq.) is amended
- 3 by adding after section 7 the following:
- 4 "SEC. 7A. OIL PRODUCING CARTELS.
- 5 "(a) IN GENERAL.—It shall be illegal and a violation
- 6 of this Act for any foreign state, or any instrumentality
- 7 or agent of any foreign state, to act collectively or in com-
- 8 bination with any other foreign state, any instrumentality
- 9 or agent of any other foreign state, or any other person,
- 10 whether by cartel or any other association or form of co-
- 11 operation or joint action—
- "(1) to limit the production or distribution of
- oil, natural gas, or any other petroleum product;
- "(2) to set or maintain the price of oil, natural
- gas, or any petroleum product; or
- 16 "(3) to otherwise take any action in restraint of
- trade for oil, natural gas, or any petroleum product;
- 18 when such action, combination, or collective action has a
- 19 direct, substantial, and reasonably foreseeable effect on
- 20 the market, supply, price, or distribution of oil, natural
- 21 gas, or other petroleum product in the United States.
- 22 "(b) Sovereign Immunity.—A foreign state en-
- 23 gaged in conduct in violation of subsection (a) shall not
- 24 be immune under the doctrine of sovereign immunity from
- 25 the jurisdiction or judgments of the courts of the United
- 26 States in any action brought to enforce this section.

1	"(c) Inapplicability of Act of State Doc-
2	TRINE.—No court of the United States shall decline
3	based on the act of state doctrine, to make a determina-
4	tion on the merits in an action brought under this section
5	"(d) Enforcement.—
6	"(1) In General.—The Attorney General of
7	the United States may bring an action to enforce
8	this section in any district court of the United
9	States as provided under the antitrust laws.
10	"(2) No private right of action.—No pri-
11	vate right of action is authorized under this sec-
12	tion.".
13	SEC. 3. SOVEREIGN IMMUNITY.
14	Section 1605(a) of title 28, United States Code, is
15	amended—
16	(1) in paragraph (6), by striking "or" after the
17	semicolon;
18	(2) in paragraph (7), by striking the period and
19	inserting "; or"; and
20	(3) by adding at the end the following:
21	"(8) in which the action is brought under sec-
22	tion 7A of the Sherman Act.".
