A BILL

To require the Secretary of Commerce to provide training and guidance relating to human rights abuses, including such abuses perpetrated against the Uyghur population by the Government of the People's Republic of China, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Combating Human
3 Rights Abuses Act of 2022”.

4 **SEC. 2. TRAINING FOR EMPLOYEES OF THE DEPARTMENT**
5 **OF COMMERCE RELATING TO AWARENESS OF**
6 **HUMAN RIGHTS ABUSES.**

7 (a) IN GENERAL.—The Secretary of Commerce shall
8 provide training described in subsection (b) to such em-
9 ployees of the Department of Commerce who provide coun-
10 seling services to businesses engaged in interstate com-
11 merce or foreign direct investment as the Secretary con-
12 siders appropriate.

13 (b) CONTENTS OF TRAINING.—The training required
14 under subsection (a) shall be—

15 (1) designed to raise awareness about emerging
16 trends and issues with respect to human rights
17 abuses occurring worldwide, such as human rights
18 abuses perpetrated by the Government of the Peo-
19 ple’s Republic of China, including the use of forced
20 labor, against Uyghurs and other ethnic minority
21 populations in the Xinjiang Uyghur Autonomous Re-
22 gion; and

23 (2) incorporated to the greatest extent possible
24 into existing training provided by the Department of
25 Commerce.

1 (c) TIMING.—The training required under subsection
2 (a) shall be offered and updated at such times as the Sec-
3 retary considers appropriate.

4 **SEC. 3. GUIDANCE FOR UNITED STATES BUSINESSES RE-**
5 **LATING TO AWARENESS OF HUMAN RIGHTS**
6 **ABUSES.**

7 (a) IN GENERAL.—The Secretary of Commerce
8 shall—

9 (1) offer guidance for United States businesses
10 engaged in interstate commerce or foreign direct in-
11 vestment, including such businesses that are, or are
12 considering, conducting transactions with entities
13 subject to the control or influence of jurisdictions
14 where significant human rights abuses have oc-
15 curred, such as the People’s Republic of China; and

16 (2) incorporate the guidance required under
17 paragraph (1) into any counseling services that the
18 Department of Commerce provides to such busi-
19 nesses as the Secretary considers appropriate.

20 (b) CONTENTS OF GUIDANCE.—The guidance re-
21 quired under subsection (a) shall—

22 (1) provide information about emerging trends
23 and issues involving human rights abuses, such as
24 information that describes—

1 (A) human rights abuses perpetrated by
2 the Government of the People's Republic of
3 China, including the use of forced labor, against
4 Uyghurs and other ethnic minority populations
5 in the Xinjiang Uyghur Autonomous Region;

6 (B) risk factors that may be used to iden-
7 tify entities subject to the influence or control
8 of jurisdictions such as the People's Republic of
9 China that may be implicated in human rights
10 abuses;

11 (C) ways to avoid doing business with enti-
12 ties described in subparagraph (B); and

13 (D) potential reputational, economic, legal,
14 and other risks of conducting transactions with
15 an entity described in subparagraph (B); and

16 (2) make clear that the guidance is for advisory
17 purposes and that the Department of Commerce is
18 not responsible for certifying the accuracy or com-
19 pleteness of the information provided in the guid-
20 ance.
