## A BILL

To require the Federal Bureau of Investigation to place on the No Fly List individuals who have supported foreign terrorist organizations, encouraged crimes of violence against Jewish persons, or been disciplined by an institution of higher education in relation to such conduct.

1       *Be it enacted by the Senate and House of Representa-  
2 tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “No Flights for Terror-  
5 ists Act”.

1   **SEC. 2. PLACEMENT ON NO FLY LIST OF INDIVIDUALS WHO**  
2                   **SUPPORT TERRORISTS.**

3       (a) DEFINITION OF INSTITUTION OF HIGHER EDU-  
4     CATION.—In this section, the term “institution of higher  
5     education” has the meaning given the term in section 102  
6     of the Higher Education Act of 1965 (20 U.S.C. 1002).

7       (b) PLACEMENT ON NO FLY LIST.—The Director of  
8     the Federal Bureau of Investigation shall place on the No  
9     Fly List maintained by the Terrorist Screening Center—

10                  (1) any individual who has openly pledged sup-  
11     port for, or espoused allegiance or affiliation to, any  
12     organization that has been designated as a foreign  
13     terrorist organization by the Secretary of State  
14     under section 219 of the Immigration and Nation-  
15     ality Act (8 U.S.C. 1189), including—

16                  (A) the Islamic Revolutionary Guard Corps  
17     (IRGC);

18                  (B) HAMAS;

19                  (C) the Al-Aqsa Martyrs Brigade (AAMB);

20                  (D) Hizballah;

21                  (E) Palestine Islamic Jihad (PIJ);

22                  (F) the Palestine Liberation Front (PLF);

23                  (G) the Popular Front for the Liberation  
24     of Palestine (PFLP);

25                  (H) Kata’ib Hizballah (KH);

26                  (I) the Abdallah Azzam Brigades; and

- 1                         (J) the al-Ashtar Brigades;
- 2                         (2) any individual who solicits, commands, in-
- 3                         duces, or otherwise endeavors to persuade another
- 4                         person to engage in a crime of violence against a
- 5                         Jewish person or the Jewish people because of their
- 6                         race or religion;
- 7                         (3) any student enrolled at an institution of
- 8                         higher education who has been the subject of a dis-
- 9                         ciplinary action by the institution of higher edu-
- 10                         cation relating to conduct described in paragraph (1)
- 11                         or (2); and
- 12                         (4) any professor employed by an institution of
- 13                         higher education who has been the subject of a dis-
- 14                         ciplinary action by the institution of higher edu-
- 15                         cation relating to conduct described in paragraph (1)
- 16                         or (2).
