Mr. CORNYN (for himself, Ms. SINEMA, Mr. TILLIS, Mr. RUBIO, Mr. OSSOFF, Ms. ERNST, and Mrs. FEINSTEIN) introduced the following bill; which was read twice and referred to the Committee on Armed Services

A BILL

To improve certain sexual assault and domestic violence prevention policies.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Protecting our
5 Servicemembers through Proven Methods Act of 2022”.

6 **SEC. 2. ANNUAL PRIMARY PREVENTION RESEARCH AGEN-**

7 **DA.**

8 Section 549A(c) of the National Defense Authoriza-
9 tion Act for Fiscal Year 2022 (Public Law 117–81) is
10 amended—

1 (1) by redesignating paragraphs (2), (3), and
2 (4) as paragraphs (5), (6), and (7), respectively;

3 (2) by inserting after paragraph (1) the fol-
4 lowing new paragraphs:

5 “(2) include a focus on whether and to what ex-
6 tent sub-populations of the military community may
7 be targeted for sexual assault, sexual harassment, or
8 domestic violence more than others;

9 “(3) seek to identify factors that influence the
10 prevention, perpetration, and victimization of sexual
11 assault, sexual harassment, and domestic violence;

12 “(4) seek to improve the collection and dissemi-
13 nation of data on hazing and bullying related to sex-
14 ual assault, sexual harassment, and domestic vio-
15 lence;”;

16 (3) in paragraph (6), as redesignated by para-
17 graph (1) of this section, by amending the text to
18 read as follows:

19 “(6) incorporate collaboration with other Fed-
20 eral departments and agencies, including the De-
21 partment of Health and Human Services and the
22 Centers for Disease Control and Prevention, State
23 governments, academia, industry, federally funded
24 research and development centers, nonprofit organi-
25 zations, and other organizations outside of the De-

1 partment of Defense, including civilian institutions
2 that conduct similar data-driven studies, collection,
3 and analysis; and”.

4 **SEC. 3. PRIMARY PREVENTION WORKFORCE.**

5 Section 549B of the National Defense Authorization
6 Act for Fiscal Year 2022 (Public Law 117–81) is amend-
7 ed—

8 (1) in subsection (c), by adding at the end the
9 following new paragraph:

10 “(3) **COMPTROLLER GENERAL REPORT.**—Not
11 later than one year after the date of the enactment
12 of this paragraph, the Comptroller General of the
13 United States shall submit to the congressional de-
14 fense committees a report comparing the sexual har-
15 assment and prevention training of the Department
16 of Defense with similar programs at other Federal
17 departments and agencies and including data col-
18 lected by colleges and universities and other relevant
19 outside entities.”; and

20 (2) by adding at the end the following new sub-
21 section:

22 “(e) **INCORPORATION OF RESEARCH AND FIND-**
23 **INGS.**—The Primary Prevention Workforce established
24 under subsection (a) shall, on a regular basis, incorporate
25 findings and conclusions from the primary prevention re-

1 search agenda established under section 549A, as appro-
2 priate, into the work of the workforce.”.
