## A BILL

To take certain Federal land located in Siskiyou County, California, and Humboldt County, California, into trust for the benefit of the Karuk Tribe, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*

2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “Katimiîn and

5       Ameekyáaraam Sacred Lands Act”.

6       **SEC. 2. LAND HELD IN TRUST FOR THE KARUK TRIBE.**

7       (a) FINDINGS.—Congress finds that—

1                   (1) the Katimiîn and Ameekyáaraam land is lo-  
2                   cated in the ancestral territory of the Karuk Tribe;  
3                   and

4                   (2) the Karuk Tribe has historically used, and  
5                   has an ongoing relationship with, the Katimiîn and  
6                   Ameekyáaraam land.

7                   (b) DEFINITIONS.—In this section:

8                   (1) KATIMIÎN AND AMEEKYÁARAAM LAND.—  
9                   The term “Katimiîn and Ameekyáaraam land”  
10                  means the approximately 1,031 acres of Federal  
11                  land, including improvements and appurtenances to  
12                  the Federal land, located in Siskiyou County, Cali-  
13                  fornia, and Humboldt County, California, and gen-  
14                  erally depicted as “Proposed Area” on the map of  
15                  the Forest Service entitled “Katimiîn Area Bound-  
16                  ary Proposal” and dated August 9, 2021.

17                  (2) SECRETARY.—The term “Secretary” means  
18                  the Secretary of the Interior.

19                  (c) ADMINISTRATIVE TRANSFER.—Administrative ju-  
20                  risdiction of the Katimiîn and Ameekyáaraam land is  
21                  hereby transferred from the Secretary of Agriculture to  
22                  the Secretary, subject to the condition that the Chief of  
23                  the Forest Service shall continue to manage the compo-  
24                  nent of the National Wild and Scenic Rivers System that  
25                  flows through the Katimiîn and Ameekyáaraam land.

1       (d) LAND HELD IN TRUST.—The Katimiîn and  
2 Ameekyáaraam land is hereby taken into trust by the Sec-  
3 retary for the benefit of the Karuk Tribe, subject to—

4               (1) valid existing rights, contracts, and manage-  
5 ment agreements relating to easements and rights-  
6 of-way; and

7               (2) continued access by the Chief of the Forest  
8 Service for the purpose of managing the component  
9 of the National Wild and Scenic Rivers System that  
10 flows through the Katimiîn and Ameekyáaraam  
11 land.

12       (e) SURVEY.—Not later than 180 days after the date  
13 of enactment of this Act, the Secretary of Agriculture shall  
14 provide to the Secretary a complete survey of the land  
15 taken into trust under subsection (d).

16       (f) USE OF LAND.—

17               (1) IN GENERAL.—Land taken into trust under  
18 subsection (d) may be used for traditional and cus-  
19 tomary uses for the benefit of the Karuk Tribe.

20               (2) GAMING.—Class II and class III gaming  
21 under the Indian Gaming Regulatory Act (25 U.S.C.  
22 2701 et seq.) shall not be allowed on the land taken  
23 into trust under subsection (d).

24       (g) WILD AND SCENIC RIVERS MANAGEMENT.—

1                             (1) IN GENERAL.—Nothing in this section af-  
2     fects the status or administration of any component  
3     of the National Wild and Scenic Rivers System, in-  
4     cluding any component that flows through the land  
5     taken into trust under subsection (d).

6                             (2) MEMORANDUM OF UNDERSTANDING.—The  
7     Secretary of Agriculture shall enter into a memo-  
8     randum of understanding with the Karuk Tribe,  
9     consistent with the obligations of the Secretary of  
10   Agriculture under subsection (c), to establish mutual  
11   goals for the protection and enhancement of the  
12   river values of any component of the National Wild  
13   and Scenic Rivers System that flows through the  
14   land taken into trust under subsection (d).
