## A BILL

To designate the area between the intersections of Wisconsin Avenue, Northwest and Davis Street, Northwest and Wisconsin Avenue, Northwest and Edmunds Street, Northwest in Washington, District of Columbia, as “Boris Nemtsov Plaza”, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. DESIGNATION OF BORIS NEMTSOV PLAZA.**

2 (a) DESIGNATION OF PLAZA.—

3 (1) IN GENERAL.—The area between the inter-  
 4 sections of Wisconsin Avenue, Northwest and Davis  
 5 Street, Northwest and Wisconsin Avenue, Northwest  
 6 and Edmunds Street, Northwest in Washington,  
 7 District of Columbia, shall be known and designated  
 8 as “Boris Nemtsov Plaza”.

9 (2) REFERENCES.—Any reference in a law,  
 10 map, regulation, document, paper, or other record of  
 11 the United States to the area referred to in para-  
 12 graph (1) shall be deemed to be a reference to Boris  
 13 Nemtsov Plaza.

14 (b) DESIGNATION OF ADDRESS.—

15 (1) DESIGNATION.—The address of 2650 Wis-  
 16 consin Avenue, Northwest, Washington, District of  
 17 Columbia, shall be redesignated as 1 Boris Nemtsov  
 18 Plaza.

19 (2) REFERENCES.—Any reference in a law,  
 20 map, regulation, document, paper, or other record of  
 21 the United States to the address referred to in para-  
 22 graph (1) shall be deemed to be a reference to 1  
 23 Boris Nemtsov Plaza.

24 (c) SIGNS.—The Administrator of General Services  
 25 shall construct street signs that shall—

26 (1) contain the phrase “Boris Nemtsov Plaza”;

1           (2) be similar in design to the signs used by  
2           Washington, District of Columbia, to designate the  
3           location of Metro stations; and

4           (3) be placed on—

5           (A) the parcel of Federal property that is  
6           closest to 1 Boris Nemtsov Plaza (as redesign-  
7           ated by subsection (b)(1)); and

8           (B) the street corners of Wisconsin Ave-  
9           nue, Northwest and Davis Street, Northwest  
10          and Wisconsin Avenue, Northwest and  
11          Edmunds Street, Northwest in Washington,  
12          District of Columbia.
