**A BILL**

To require the United States Postal Service to continue selling the Multinational Species Conservation Funds Semipostal Stamp until all remaining stamps are sold, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Multinational Species  
3 Conservation Funds Semipostal Stamp Reauthorization  
4 Act of 2021”.

5 **SEC. 2. REAUTHORIZATION; REQUIREMENT TO SELL ALL**  
6 **STAMPS.**

7 (a) IN GENERAL.—Section 2(c) of the Multinational  
8 Species Conservation Funds Semipostal Stamp Act of  
9 2010 (39 U.S.C. 416 note; Public Law 111–241) is  
10 amended—

11 (1) in paragraph (2)—

12 (A) by striking “of at least 6 years,”; and

13 (B) by inserting before the period at the  
14 end the following: “and ending not earlier than  
15 the date on which the United States Postal  
16 Service provides notice to Congress under para-  
17 graph (5)”;

18 (2) by adding at the end the following:

19 “(5) REQUIREMENT TO SELL ALL STAMPS  
20 PRINTED.—

21 “(A) IN GENERAL.—The United States  
22 Postal Service shall sell each copy of the Multi-  
23 national Species Conservation Fund Semipostal  
24 Stamp that the United States Postal Service  
25 prints under this Act.

1           “(B) NOTIFICATION OF CONGRESS.—The  
2           United States Postal Service shall notify the  
3           Committee on Homeland Security and Govern-  
4           mental Affairs of the Senate and the Committee  
5           on Oversight and Reform of the House of Rep-  
6           resentatives when all copies of the Multinational  
7           Species Conservation Fund Semipostal Stamp  
8           printed under this Act have been sold.”.

9           (b) RETROACTIVE APPLICABILITY.—

10           (1) IN GENERAL.—The amendments made by  
11           subsection (a) shall take effect as if enacted on the  
12           day after the date of enactment of the Multinational  
13           Species Conservation Funds Semipostal Stamp Re-  
14           authorization Act of 2013 (Public Law 113–165;  
15           128 Stat. 1878).

16           (2) CONSEQUENCE OF DESTRUCTION OF  
17           STAMPS.—If the United States Postal Service de-  
18           stroys 1 or more Multinational Species Conservation  
19           Fund Semipostal Stamps before the date of enact-  
20           ment of this Act, the United States Postal Service  
21           shall print and sell the same number of such stamps  
22           on or after that date of enactment.
