## A BILL

To prohibit the creation of an immigration-related registry program that classifies people on the basis of religion, race, age, gender, ethnicity, national origin, nationality, or citizenship.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLES.**

4 This Act may be cited as the “Protect American  
5 Families from Unnecessary Registration and Deportation  
6 Act of 2017” or the “Protect American Families Act”.

1 **SEC. 2. PROHIBITION OF CERTAIN IMMIGRATION-RELATED**  
2 **REGISTRY PROGRAMS.**

3 (a) PROHIBITION.—Subject to subsection (b) and  
4 notwithstanding any other provision of law, including sec-  
5 tions 263, 265, and 266 of the Immigration and Nation-  
6 ality Act (8 U.S.C. 1303, 1305, and 1306)—

7 (1) the Department of Homeland Security, the  
8 Department of Justice, or any other Federal depart-  
9 ment may not create or implement a law enforce-  
10 ment or national security program that requires, or  
11 has the effect of causing, people to register or check  
12 in on the basis of religion, race, age, gender, eth-  
13 nicity, national origin, nationality, or citizenship;  
14 and

15 (2) consistent with the prohibition under para-  
16 graph (1), no Federal funds may be used to create  
17 or implement an immigration registry or check-in  
18 program.

19 (b) INAPPLICABILITY TO CERTAIN FEDERAL PRO-  
20 GRAMS.—The prohibitions under subsection (a) shall not  
21 apply to any Federal program that—

22 (1) merely collects and compiles data about  
23 aliens entering or exiting the United States; or

24 (2) issues visas, grants United States citizen-  
25 ship, confers an immigration benefit to nationals of

- 1 a foreign country, or temporarily or permanently
- 2 protects noncitizens from removal.
