A BILL

To enhance citizen access to Government information and services by establishing that Government documents issued to the public must be written clearly, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-

- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Plain Writing Act of
- 5 2009".

1 SEC. 2. PURPOSE.

- 2 The purpose of this Act is to improve the effective-
- 3 ness and accountability of Federal agencies to the public
- 4 by promoting clear Government communication that the
- 5 public can understand and use.

6 SEC. 3. DEFINITIONS.

- 8 (1) AGENCY.—The term "agency" means an
- 9 Executive agency, as defined under section 105 of
- title 5, United States Code.
- 11 (2) COVERED DOCUMENT.—The term "covered
- document" means any document (other than a regu-
- lation) issued by an agency to the public, including
- documents and other text released in electronic
- form.
- 16 (3) Plain writing.—The term "plain writing"
- means writing that the intended audience can read-
- ily understand and use because that writing is clear,
- concise, well-organized, and follows other best prac-
- 20 tices of plain writing.

21 SEC. 4. RESPONSIBILITIES OF FEDERAL AGENCIES.
