**A BILL**

To amend title XVIII of the Social Security Act to provide for a five-year extension of the rural community hospital demonstration program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Rural Community Hos-  
3 pital Demonstration Extension Act of 2015”.

4 **SEC. 2. FIVE-YEAR EXTENSION OF THE RURAL COMMUNITY**  
5 **HOSPITAL DEMONSTRATION PROGRAM.**

6 (a) **EXTENSION.**—Section 410A of the Medicare Pre-  
7 scription Drug, Improvement, and Modernization Act of  
8 2003 (Public Law 108–173; 42 U.S.C. 1395ww note), as  
9 amended by sections 3123 and 10313 of the Patient Pro-  
10 tection and Affordable Care Act (Public Law 111–148),  
11 is amended—

12 (1) in subsection (a)(5), by striking “5-year ex-  
13 tension period” and inserting “10-year extension pe-  
14 riod”; and

15 (2) in subsection (g)—

16 (A) in the subsection heading, by striking  
17 “FIVE-YEAR” and inserting “TEN-YEAR”;

18 (B) in paragraph (1), by striking “addi-  
19 tional 5-year” and inserting “additional 10-  
20 year”; and

21 (C) by striking “5-year extension period”  
22 and inserting “10-year extension period” each  
23 place it appears ;

24 (b) **CHANGE IN TIMING FOR REPORT.**—Subsection  
25 (e) of such section 410A is amended by striking “Not later

1 than 6 months after the completion” and inserting “Not  
 2 later than 2 years prior to the completion”.

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Rural Community Hos-*  
 5 *pital Demonstration Extension Act of 2015”.*

6 **SEC. 2. FIVE-YEAR EXTENSION OF THE MEDICARE RURAL**  
 7 **COMMUNITY HOSPITAL DEMONSTRATION**  
 8 **PROGRAM.**

9 (a) *EXTENSION.*—Section 410A of the Medicare Pre-  
 10 scription Drug, Improvement, and Modernization Act of  
 11 2003 (Public Law 108–173; 42 U.S.C. 1395ww note), as  
 12 amended by sections 3123 and 10313 of the Patient Protec-  
 13 tion and Affordable Care Act (Public Law 111–148), is  
 14 amended—

15 (1) in subsection (a)(5), by striking “5-year ex-  
 16 tension period” and inserting “10-year extension pe-  
 17 riod”; and

18 (2) in subsection (g)—

19 (A) in the subsection heading, by striking  
 20 “FIVE-YEAR” and inserting “TEN-YEAR”;

21 (B) in paragraph (1), by striking “addi-  
 22 tional 5-year” and inserting “additional 10-  
 23 year”;

1           (C) by striking “5-year extension period”  
 2           and inserting “10-year extension period” each  
 3           place it appears;

4           (D) in paragraph (3), by adding at the end  
 5           the following new sentence: “Notwithstanding the  
 6           preceding sentence, after the date of the enact-  
 7           ment of this sentence, only hospitals described in  
 8           paragraph (4) or (5) may participate in dem-  
 9           onstration program under this section.”

10          (E) in paragraph (4)(B)—

11           (i) in the matter preceding clause (i),  
 12           by inserting “each 5-year period in” after  
 13           “hospital during”; and

14           (ii) in clause (i), by inserting “each  
 15           applicable 5-year period in” after “the first  
 16           day of”; and

17          (F) by adding at the end the following new  
 18          paragraph:

19          “(5) *OTHER HOSPITALS IN DEMONSTRATION*  
 20          *PROGRAM.*—During the second 5 years of the 10-year  
 21          extension period, the Secretary shall apply the provi-  
 22          sions of paragraph (4) to rural community hospitals  
 23          that are not described in paragraph (4) but are par-  
 24          ticipating in the demonstration program under this  
 25          section as of December 30, 2014, in a similar manner

1        *as such provisions apply to rural community hos-*  
2        *pitals described in paragraph (4).”.*

3        *(b) CHANGE IN TIMING FOR REPORT.—Subsection (e)*  
4        *of such section 410A is amended by striking “Not later than*  
5        *6 months after the completion” and inserting “Not later*  
6        *than August 1, 2018”.*

Amend the title so as to read: “A bill to provide for a five-year extension of the Medicare rural community hospital demonstration program.”.
