A BILL

To modify the boundary of Petersburg National Battlefield in the Commonwealth of Virginia, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. PETERSBURG NATIONAL BATTLEFIELD BOUND-**
 2 **ARY MODIFICATION.**

3 (a) IN GENERAL.—The boundary of the Petersburg
 4 National Battlefield is modified to include the land and
 5 interests in land as generally depicted on the map titled
 6 “Petersburg National Battlefield *Proposed* Boundary Ex-
 7 pansion”, numbered 325/80,080, and dated ~~June 2007~~
 8 *March 2016*. The map shall be on file and available for
 9 public inspection in the appropriate offices of the National
 10 Park Service.

11 ~~(b) ACQUISITION OF PROPERTIES.—The Secretary of~~
 12 *(b) ACQUISITION OF PROPERTIES.—*

13 (1) *AUTHORITY.—The Secretary of the Interior*
 14 *(referred to in this section as the “Secretary”)* is au-
 15 *thorized to acquire the land and interests in land,*
 16 *described in subsection (a), from willing sellers only,*
 17 *by donation, purchase with donated or appropriated*
 18 *funds, exchange, or transfer.*

19 (2) *TECHNICAL CORRECTION.—Section 313(a) of*
 20 *the National Parks and Recreation Act of 1978 (Pub-*
 21 *lic Law 95–625; 92 Stat. 3479) is amended by strik-*
 22 *ing “twenty-one” and inserting “23”.*

23 (c) ADMINISTRATION.—The Secretary shall admin-
 24 ister any land or interests in land acquired under sub-
 25 section (b) as part of the Petersburg National Battlefield
 26 in accordance with applicable laws and regulations.

1 (d) ADMINISTRATIVE JURISDICTION TRANSFER.—

2 (1) IN GENERAL.—There is transferred—

3 (A) from the Secretary to the Secretary of
4 the Army administrative jurisdiction over the
5 approximately 1.170-acre parcel of land de-
6 picted as “Area to be transferred to Fort Lee
7 Military Reservation” on the map described in
8 paragraph (2); and

9 (B) from the Secretary of the Army to the
10 Secretary administrative jurisdiction over the
11 approximately 1.171-acre parcel of land de-
12 picted as “Area to be transferred to Petersburg
13 National Battlefield” on the map described in
14 paragraph (2).

15 (2) MAP.—The land transferred is depicted on
16 the map titled “Petersburg National Battlefield Pro-
17 posed Transfer of Administrative Jurisdiction”,
18 numbered 325/80,801A, dated ~~May 2011~~ *March*
19 *2016*. The map shall be on file and available for pub-
20 lic inspection in the appropriate offices of the Na-
21 tional Park Service.

22 (3) CONDITIONS OF TRANSFER.—The transfer
23 of administrative jurisdiction under paragraph (1) is
24 subject to the following conditions:

1 (A) NO REIMBURSEMENT OR CONSIDER-
 2 ATION.—The transfer is without reimbursement
 3 or consideration.

4 ~~(B) MANAGEMENT.—~~The land conveyed to
 5 the Secretary under paragraph ~~(1)~~ shall be in-
 6 cluded within the boundary of the Petersburg
 7 National Battlefield and shall be administered
 8 as part of that park in accordance with applica-
 9 ble laws and regulations.

10 (B) MANAGEMENT.—

11 (i) LAND TRANSFERRED TO THE SEC-
 12 RETARY OF THE ARMY.—*The land trans-*
 13 *ferred to the Secretary of the Army under*
 14 *paragraph (1)(A) shall be excluded from the*
 15 *boundary of the Petersburg National Battle-*
 16 *field.*

17 (ii) LAND TRANSFERRED TO THE SEC-
 18 RETARY.—*The land transferred to the Sec-*
 19 *retary under paragraph (1)(B) shall—*

20 (I) *be included within the bound-*
 21 *ary of the Petersburg National Battle-*
 22 *field; and*

23 (II) *be administered as part of the*
 24 *Petersburg National Battlefield, in ac-*
