- 6 (1) the White Clay Creek watershed is 1 of only 7 a few relatively intact and unspoiled functioning 8 river systems remaining in the highly congested and 9 developed corridor between Philadelphia, Pennsyl-

- (2) Public Law 102–215 (16 U.S.C. 1271 note: 12 105 Stat. 1664) directed the Secretary of the Inte-13 rior, in cooperation and consultation with appro-14 priate State and local governments and affected 15 landowners, to conduct a study of the eligibility and 16 suitability of White Clay Creek, in the States of 17 Delaware and Pennsylvania, and the tributaries of 18 the creek for inclusion in the National Wild and Sce-19 nie Rivers System;
