Mr. REED submitted the following concurrent resolution; which was considered
and agreed to

CONCURRENT RESOLUTION

Directing the Clerk of the House of Representatives to make
a correction in the enrollment of the bill H.R. 5009.

1 *Resolved by the Senate (the House of Representatives*
2 *concurring)*, That in the enrollment of the bill H.R. 5009,
3 the Clerk of the House of Representatives shall make the
4 following corrections:

5 (1) In the table of contents in section 2(b),
6 strike the item relating to section 5705 and insert
7 the following:

Sec. 5705. Readmission requirements for servicemembers.

8 (2) In the table of section 601 regarding basic
9 pay for enlisted members, in the entry relating to a

1 member in pay grade E-5 with over 2 years, strike
2 “3,317.10” and insert “3,466.50”.

3 (3) In such table, in the entry relating to a
4 member in such pay grade with over 3 years, strike
5 “3,480.90” and insert “3,637.50”.

6 (4) In such table, in the entry relating to a
7 member in such pay grade with over 4 years, strike
8 “3,638.40” and insert “3,802.20”.

9 (5) In such table, in the entry relating to a
10 member in such pay grade with over 6 years, strike
11 “3,789.00” and insert “3,959.40”.

12 (6) In such table, in the entry relating to a
13 member in such pay grade with over 8 years, strike
14 “3,964.20” and insert “4,142.40”.

15 (7) In the table of contents preceding section
16 5701, strike the item relating to section 5705 and
17 insert the following:

Sec. 5705. Readmission requirements for servicemembers.

18 (8) Strike section 5705 and insert the following:

19 **SEC. 5705. READMISSION REQUIREMENTS FOR**
20 **SERVICEMEMBERS.**

21 Subsection (a) of section 484C of the Higher Edu-
22 cation Act of 1965 (20 U.S.C. 1091c(a)) is amended to
23 read as follows:

24 “(a) DEFINITION OF SERVICE IN THE UNIFORMED
25 SERVICES.—In this section, the term ‘service in the uni-

1 formed services' means service (whether voluntary or in-
2 voluntary) on active duty in the Armed Forces, including
3 such service by a member of the National Guard or Re-
4 serve.”.

5 (9) Amend the title so as to read: “An Act to
6 authorize appropriations for fiscal year 2025 for
7 military activities of the Department of Defense, for
8 military construction, and for defense activities of
9 the Department of Energy, to prescribe military per-
10 sonnel strengths for such fiscal year, and for other
11 purposes.”.
