Mr. PAUL introduced the following joint resolution; which was read twice and referred to the Committee on Foreign Relations

JOINT RESOLUTION

Relating to the disapproval of the proposed sale to the Government of Bahrain of certain defense articles and services.

1 *Resolved by the Senate and House of Representatives*
2 *of the United States of America in Congress assembled,*
3 That the issuance of a letter of offer with respect to any
4 of the following proposed sales to the Government of Bah-
5 rain (described in the certification Transmittal No. 19–
6 06, sent to the Speaker of the House of Representatives
7 and the chairman of the Committee on Foreign Relations
8 of the Senate pursuant to section 36(b)(1) of the Arms
9 Export Control Act (22 U.S.C. 2776(b)(1)) on May 6,
10 2019), is hereby prohibited:

1 (1) The proposed sale of sixty (60) Patriot Ad-
2 vanced Capability-3 (PAC-3) Missile Segment En-
3 hancement (MSE) missiles (Transmittal Numbered
4 19-06).

5 (2) The proposed sale of thirty-six (36) Patriot
6 MIM-104E Guidance Enhanced Missiles (GEM-T)
7 missiles with canisters (Transmittal Numbered 19-
8 06).

9 (3) The proposed sale of nine (9) M903
10 Launching Stations (LS) (Transmittal Numbered
11 19-06).

12 (4) The proposed sale of five (5) Antenna Mast
13 Groups (AMG) (Transmittal Numbered 19-06).

14 (5) The proposed sale of three (3) Electrical
15 Power Plants (EPP) III (Transmittal Numbered
16 19-06).

17 (6) The proposed sale of two (2) AN/MPQ-65
18 Radar Sets (RS) (Transmittal Numbered 19-06).

19 (7) The proposed sale of two (2) AN/MSQ-132
20 Engagement Control Stations (ECS) (Transmittal
21 Numbered 19-06).

22 (8) The proposed sale of communications equip-
23 ment, tools and test equipment, range and test pro-
24 grams, support equipment, prime movers, genera-
25 tors, publications and technical documentation,

1 training equipment, spare and repair parts, per-
2 sonnel training, Technical Assistance Field Team
3 (TAFT), U.S. Government and contractor technical,
4 engineering, and logistics support services, Systems
5 Integration and Checkout (SICO), field office sup-
6 port, and other related elements of logistics and pro-
7 gram support (Transmittal Numbered 19-06).
