RESOLUTION

Expressing support for the individuals impacted by the sense-

less attack at the Washington Navy Yard, and commending and thanking members of the military, law enforcement officers, first responders, and civil servants for their courage and professionalism.

Whereas, on September 16, 2013, a tragic mass shooting took place at the Washington Navy Yard in Washington, D.C.;

Whereas the people of the United States mourn the loss of the 12 innocent victims who were killed as a result of the mass shooting;

Whereas the Washington Navy Yard serves as headquarters of Naval District Washington and is the workplace of 18,000 military, civilian, and contractor personnel who serve the United States; and

Whereas military officials, law enforcement officers, and other first responders reacted swiftly and courageously to prevent additional loss of life: Now, therefore, be it

1 *Resolved*, That the Senate—

2 (1) offers its heartfelt condolences to the fami-
3 lies, friends, and loved ones of the innocent victims
4 killed or wounded during the horrific violence that
5 took place at the Washington Navy Yard on Sep-
6 tember 16, 2013;

7 (2) offers support and hope for all the individ-
8 uals who were wounded and discomfited by the
9 mass shooting at the Washington Navy Yard;

1 (3) recognizes the difficult healing and recovery
2 process that lies ahead for communities affected by
3 the mass shooting at the Washington Navy Yard;

4 (4) honors the courageous and professional
5 service of —

6 (A) the uniformed men and women of the
7 Navy and other members of the United States
8 Armed Forces;

9 (B) all civilian employees who provide sup-
10 port for the United States Armed Forces; and

11 (C) the law enforcement personnel, emer-
12 gency responders, and medical professionals
13 who responded to and assisted victims of the
14 mass shooting at the Washington Navy Yard;

15 (5) thanks those individuals for their selfless
16 and dedicated service; and

17 (6) remains committed to preventing the occur-
18 rence of tragedies similar to the mass shooting at
19 the Washington Navy Yard.
