Enactment of this legislation could generate an estimated \$28,000 in Dedicated Credits from individuals who purchase Off-Highway Vehicle Permits being charged a 3% electronic payment fee. This legislation could also increase revenues to the retitled Utah Geological Survey Restricted Account by an estimated \$2,183,200 ongoing beginning in FY 2025 from receiving 2.25% of Federal Mineral Lease proceeds. This increase would be offset by an equivalent reduction in Federal Mineral Lease revenue to the Utah Geological Survey line item.

Enactment of this legislation could increase Dedicated Credit expenditures by the Division of Outdoor Recreation by \$28,000 per year beginning in FY 2025 for electronic payment vendor fees. This legislation would also reduce \$2,280,400 ongoing beginning in FY 2025 from Federal Mineral Lease in the operating and capital budget of the Utah Geological Survey and replace it with an equivalent appropriation from the retitled Utah Geological Survey Restricted Account.

**Local Government**

UCA 36-12-13(2)(c)

Enactment of this legislation likely will not result in direct, measurable costs for local governments.

**Individuals & Businesses**

UCA 36-12-13(2)(c)

Enactment of this legislation could cost individuals who purchase Off-Highway Vehicle Permits an estimated \$0.90 per person or an estimated \$28,000 in total from the Division of Outdoor Recreation charging a 3% electronic payment fee.

**Regulatory Impact**

UCA 36-12-13(2)(d)

Enactment of this legislation could result in a small increase in the regulatory burden for Utah residents or businesses.

**Performance Evaluation**

This bill does not create a new program or significantly expand an existing program.

**Notes on Notes**

Fiscal notes estimate the direct costs or revenues of enacting a bill. The Legislature uses them to balance the budget. They do not measure a bill's benefits or non-fiscal impacts like opportunity costs, wait times, or inconvenience. A fiscal note is not an appropriation. The Legislature decides appropriations separately.
