<ul> <li>\$766,608,400 from the Education Fund;</li> </ul>
<ul> <li>\$885,242,700 from various sources as detailed in this bill.</li> </ul>
This bill appropriates \$16,500,000 in restricted fund and account transfers for fiscal year
2020, all of which is from the Education Fund.
