11	This bill modifies the Utah Performance Assessment System for Students (U-PASS),
12	including requiring school districts and charter schools to administer computer adaptive
13	tests aligned with the common core.
14	Highlighted Provisions:
15	This bill:
16	<ul> <li>requires school districts and charter schools to administer computer adaptive tests</li> </ul>
17	aligned with the common core beginning with the 2014-15 school year;
18	<ul><li>eliminates an assessment system pilot program;</li></ul>
19	requires the State Board of Education to make rules for:
20	<ul> <li>applying for and awarding money for computer adaptive tests;</li> </ul>
21	<ul> <li>allocating money for computer adaptive tests to school districts and charter</li> </ul>

62	Assessment System for Students, hereafter referred to as U-PASS;
63	(b) require the state superintendent of public instruction to submit and recommend
64	criterion-referenced achievement tests or online computer adaptive tests, a tenth grade basic
65	skills competency test, an online writing assessment for grades 5 and 8, and a test for students
66	in grade 3 to measure reading grade level to the board for approval and adoption and
67	distribution to each school district and charter school by the state superintendent;
68	(c) develop an assessment method to uniformly measure statewide performance, school
69	district performance, and school performance of students in grades 3 through 12 in mastering

- (b) security features to maintain the integrity of the system, which could include statewide uniform testing dates, multiple test forms, and test administration protocols;
- (c) the exemption of student test scores, by exemption category, such as limited English proficiency, mobility, and students with disabilities, with the percent or number of student test scores exempted being publically reported at a district level;
- (d) compiling of criterion-referenced, online computer adaptive, and online writing test scores and test score averages at the classroom level to allow for:
- (i) an annual review of those scores by parents of students and professional and other appropriate staff at the classroom level at the earliest point in time;
- (ii) the assessment of year-to-year student progress in specific classes, courses, and subjects;
- (iii) a teacher to review, prior to the beginning of a new school year, test scores from the previous school year of students who have been assigned to the teacher's class for the new school year; [and]
- [(iv)] (e) allowing a school district or charter school to have its tests administered and scored electronically to accelerate the review of test scores and their usefulness to parents and educators under [Subsections (3)(d)(i), (ii), and (iii)] Subsection (4)(d), without violating the integrity of U-PASS; and

- (i) scores on the tests and assessments required under Subsection (2)(a) and Subsection (3) shall be considered in determining a student's academic grade for the appropriate course and whether a student shall advance to the next grade level; and

165	(1) The Legislature recognizes the need for the State Board of Education to develop
166	and implement standards and assessment processes to ensure that student progress is measured
167	and that school boards and school personnel are accountable.
168	(2) (a) In addition to its responsibilities under Sections 53A-1-603 through 53A-1-605,
169	the State Board of Education, through the state superintendent of public instruction, shall
170	design a basic skills competency test to be administered in the tenth grade.
171	(b) Except as provided in [Subsections] Subsection (5) [and (6)] and Section
172	53A-1-1001, a student must pass the basic skills competency test, in addition to the established
173	requirements of the state and local board of education of the district in which the student
174	attends school, in order to receive a basic high school diploma of graduation.
175	(c) The state board shall include in the test, at a minimum, components on English
176	language arts and reading and mathematics.
177	(d) Except as provided in [Subsections] Subsection (5) [and (6)] and Section
178	53A-1-1001, a student who fails to pass all components of the test may not receive a basic high
179	school diploma but may receive a certificate of completion or alternative completion diploma
