7 **LONG TITLE**

8 **General Description:**

9 This bill modifies the Women in the Economy Commission Act and the Legislative
10 Oversight and Sunset Act.

11 **Highlighted Provisions:**

12 This bill:

- 13 ▶ defines terms;
- 14 ▶ modifies the reporting requirements of the Women in the Economy Commission;
- 15 ▶ repeals the sunset date of the Women in the Economy Commission Act, which has
16 the effect of allowing the commission to continue beyond July 1, 2016; and
- 17 ▶ makes technical changes.
