35	Section 1. Section 62A-15-120 is enacted to read:		
36	62A-15-120. Mental health resources for first responders grant program.		
37	(1) As used in this section:		
38	(a) "First responder" means:		
39	(i) a law enforcement officer, as defined in Section 53-13-103;		
40	(ii) an emergency medical technician, as defined in Section 26-8c-102;		
41	(iii) an advanced emergency medical technician, as defined in Section 26-8c-102;		
42	(iv) a paramedic, as defined in Section 26-8c-102;		
43	(v) a firefighter, as defined in Section 34A-3-113;		
44	(vi) a dispatcher, as defined in Section 53-6-102; or		
45	(vii) a correctional officer, as defined in Section 53-13-104.		
46	(b) "First responder agency" means a local district, municipality, interlocal entity, or		
47	other political subdivision that employs a first responder to provide fire protection, paramedic,		
48	law enforcement, or emergency services.		
49	(c) "Mental health resources" means:		
50	(i) an assessment to determine appropriate mental health treatment that is performed by		
51	a mental health therapist;		
52	(ii) outpatient mental health treatment provided by a mental health therapist; or		
53	(iii) peer support services provided by a peer support specialist who is qualified to		
54	provide peer support services under Subsection 62A-15-103(2)(h).

57	(e) "Project" means a project to implement or expand a program that provides mental
58	health resources to first responders for which the division awards a grant under this section.
59	(2) On or before July 1, 2021, the division shall issue a request for proposals in
60	accordance with this section to award a grant to one or more first responder agencies to
61	implement a project.
62	(3) The purpose of a project is to provide mental health resources for first responders.
63	(4) An application for a grant under this section shall:
64	(a) explain how first responders will benefit from the provision of mental health
65	resources; and
66	(b) provide details regarding:
67	(i) how the proposed project plans to provide mental health resources to first
68	responders in the first responder agency;
69	(ii) the number of first responders served by the proposed project;
70	(iii) how the proposed project will ensure timely and effective provision of mental
