LONG TITLE

General Description:

This bill imposes requirements on a school district regarding seismic safety evaluations of school buildings.

Highlighted Provisions:

This bill:

- ▶ defines terms;
- ▶ requires a school district to conduct or update a seismic safety evaluation of a school district building constructed before 1975 if the school district issues certain general obligation bonds on or after July 1, 2013;
- ▶ provides that a school district is not required to conduct or update a seismic safety evaluation of a building constructed before 1975 if a seismic safety evaluation was performed on the building within the 25-year period before the school district issues certain general obligation bonds; and
- ▶ provides that the creation of a seismic safety evaluation of a school, or a list of schools needing seismic upgrades, shall not be construed as expanding or changing the state's or a school district's common law duty of care for liability purposes.

32 *Be it enacted by the Legislature of the state of Utah:*

33 Section 1. Section **53A-18-107** is enacted to read:

34 **53A-18-107. Requirement to conduct seismic safety evaluations when issuing a**
35 **bond.**

36 (1) As used in this section:

37 (a) "Federal guidelines" means guidelines and procedures specified in "Rapid Visual
38 Screening of Buildings for Potential Seismic Hazards: A Handbook, 2nd Edition" published by
39 the United States Federal Emergency Management Agency.

40 (b) "Qualifying general obligation bond" means a bond:

41 (i) issued pursuant to Title 11, Chapter 14, Local Government Bonding Act; and

42 (ii) authorized by an election held on or after July 1, 2013.

43 (c) "Seismic safety evaluation" means a seismic safety rapid visual screening evaluated
44 in accordance with federal guidelines or a more detailed seismic structural evaluation.

45 (2) If a school district issues a qualifying general obligation bond, the school district
46 shall:

47 (a) except as provided in Subsection (4), conduct or update a seismic safety evaluation
48 of each school district building:

49 (i) constructed before 1975; and

50 (ii) used by the school district as a school; and

51 (b) provide a copy of a seismic safety evaluation prepared under Subsection (2)(a) to
52 the Utah Seismic Safety Commission created in Section 63C-6-101.

53 (3) A seismic safety evaluation conducted under Subsection (2) shall be conducted by a
54 licensed structural engineer familiar with seismic codes.

55 (4) A school district is not required to conduct or update a seismic safety evaluation of
56 a building as required in Subsection (2)(a) if:

57 (a) a seismic safety evaluation was performed on the building within the 25-year period

58 before the school district issues the qualifying general obligation bond; and

59 (b) the school district provides a copy of the school district's seismic safety evaluation
60 described in Subsection (4)(a) to the Utah Seismic Safety Commission.

61 (5) Creation of a seismic safety evaluation of a school, or a list of schools needing
62 seismic upgrades, shall not be construed as expanding or changing the state's or a school
63 district's common law duty of care for liability purposes.
