55 Section 1. Section **17-20-5** is amended to read:

56 **17-20-5. Report of election and appointment of officers.**

57 Within 10 days after the day on which a county clerk issues a certificate of election or a
58 certificate of appointment made to fill vacancies in elective county offices, the county clerk

59 shall ~~[prepare and forward to]~~ notify the lieutenant governor ~~[a certified report showing]~~ of the
60 following:

- 61 (1) the name of the county;
- 62 (2) the name of the county office to which the ~~[person]~~ individual was elected or
63 appointed;
- 64 (3) the date of the election or appointment of the ~~[person]~~ individual;
- 65 (4) the date of the expiration of the term for which the ~~[person]~~ individual was elected
66 or appointed;
- 67 (5) the date of the certificate of election or appointment; and
- 68 (6) the date of the qualification of the ~~[person]~~ individual elected or appointed.

69 Section 2. Section **17B-1-306** is amended to read:

70 **17B-1-306. Local district board -- Election procedures.**

71 (1) Except as provided in Subsection (12), each elected board member shall be selected
72 as provided in this section.

73 (2) (a) Each election of a local district board member shall be held:

74 (i) at the same time as the municipal general election or the regular general election, as
75 applicable; and

76 (ii) at polling places designated by the local district board in consultation with the
77 county clerk for each county in which the local district is located, which polling places shall
78 coincide with municipal general election or regular general election polling places, as
79 applicable, whenever feasible.

80 (b) The local district board, in consultation with the county clerk, may consolidate two
81 or more polling places to enable voters from more than one district to vote at one consolidated
82 polling place.

83 (c) (i) Subject to Subsections (5)(h) and (i), the number of polling places under
84 Subsection (2)(a)(ii) in an election of board members of an irrigation district shall be one
85 polling place per division of the district, designated by the district board.

86 (ii) Each polling place designated by an irrigation district board under Subsection
87 (2)(c)(i) shall coincide with a polling place designated by the county clerk under Subsection
88 (2)(a)(ii).

89 (3) The clerk of each local district with a board member position to be filled at the next

90 municipal general election or regular general election, as applicable, shall provide notice of:

91 (a) each elective position of the local district to be filled at the next municipal general
92 election or regular general election, as applicable;

93 (b) the constitutional and statutory qualifications for each position; and

94 (c) the dates and times for filing a declaration of candidacy.

95 (4) The clerk of the local district shall publish the notice described in Subsection (3):

96 (a) by posting the notice on the Utah Public Notice Website created in Section
97 63A-16-601, for 10 days before the first day for filing a declaration of candidacy; [~~and~~]

98 (b) by posting the notice in at least five public places within the local district at least 10
99 days before the first day for filing a declaration of candidacy; and

100 (c) if the local district has a website, on the local district's website for 10 days before
101 the first day for filing a declaration of candidacy.

102 (5) (a) Except as provided in Subsection (5)(c), to become a candidate for an elective
103 local district board position, an individual shall file a declaration of candidacy in person with
104 an official designated by the local district, during office hours, within the candidate filing
105 period for the applicable election year in which the election for the local district board is held.

106 (b) When the candidate filing deadline falls on a Saturday, Sunday, or holiday, the
107 filing time shall be extended until the close of normal office hours on the following regular
108 business day.

109 (c) Subject to Subsection (5)(f), an individual may designate an agent to file a
110 declaration of candidacy with the official designated by the local district if:

111 (i) the individual is located outside of the state during the entire filing period;

112 (ii) the designated agent appears in person before the official designated by the local
113 district; and

114 (iii) the individual communicates with the official designated by the local district using
115 an electronic device that allows the individual and official to see and hear each other.

116 (d) (i) Before the filing officer may accept any declaration of candidacy from an
117 individual, the filing officer shall:

118 (A) read to the individual the constitutional and statutory qualification requirements for
119 the office that the individual is seeking; and

120 (B) require the individual to state whether the individual meets those requirements.

121 (ii) If the individual does not meet the qualification requirements for the office, the
122 filing officer may not accept the individual's declaration of candidacy.

123 (iii) If it appears that the individual meets the requirements of candidacy, the filing
124 officer shall accept the individual's declaration of candidacy.

125 (e) The declaration of candidacy shall be in substantially the following form:

126 "I, (print name) _____, being first duly sworn, say that I reside at (Street)
127 _____, City of _____, County of _____, state of Utah, (Zip
128 Code) _____, (Telephone Number, if any) _____; that I meet the qualifications for the
129 office of board of trustees member for _____ (state the name of the local
130 district); that I am a candidate for that office to be voted upon at the next election; and that, if
131 filing via a designated agent, I will be out of the state of Utah during the entire candidate filing
132 period, and I hereby request that my name be printed upon the official ballot for that election.

138 (f) An agent designated under Subsection (5)(c) may not sign the form described in
139 Subsection (5)(e).

140 (g) Each individual wishing to become a valid write-in candidate for an elective local
141 district board position is governed by Section 20A-9-601.

142 (h) If at least one individual does not file a declaration of candidacy as required by this
143 section, an individual shall be appointed to fill that board position in accordance with the
144 appointment provisions of Section 20A-1-512.

145 (i) If only one candidate files a declaration of candidacy and there is no write-in
146 candidate who complies with Section 20A-9-601, the board, in accordance with Section
147 20A-1-206, may:

- 148 (i) consider the candidate to be elected to the position; and
- 149 (ii) cancel the election.

150 (6) (a) A primary election may be held if:

- 151 (i) the election is authorized by the local district board; and

152 (ii) the number of candidates for a particular local board position or office exceeds
153 twice the number of persons needed to fill that position or office.

154 (b) The primary election shall be conducted:

155 (i) on the same date as the municipal primary election or the regular primary election,
156 as applicable; and

157 (ii) according to the procedures for primary elections provided under Title 20A,
158 Election Code.

159 (7) (a) Except as provided in Subsection (7)(c), within one business day after the
160 deadline for filing a declaration of candidacy, the local district clerk shall certify the candidate
161 names to the clerk of each county in which the local district is located.

162 (b) (i) Except as provided in Subsection (7)(c) and in accordance with Section
163 20A-6-305, the clerk of each county in which the local district is located and the local district
164 clerk shall coordinate the placement of the name of each candidate for local district office in
165 the nonpartisan section of the ballot with the appropriate election officer.

166 (ii) If consolidation of the local district election ballot with the municipal general
167 election ballot or the regular general election ballot, as applicable, is not feasible, the local
168 district board of trustees, in consultation with the county clerk, shall provide for a separate
169 local district election ballot to be administered by poll workers at polling ~~[locations]~~ places
170 designated under Subsection (2).

171 (c) (i) Subsections (7)(a) and (b) do not apply to an election of a member of the board
172 of an irrigation district established under Chapter 2a, Part 5, Irrigation District Act.

173 (ii) (A) Subject to Subsection (7)(c)(ii)(B), the board of each irrigation district shall
174 prescribe the form of the ballot for each board member election.

175 (B) Each ballot for an election of an irrigation district board member shall be in a
176 nonpartisan format.

177 (C) The name of each candidate shall be placed on the ballot in the order specified
178 under Section 20A-6-305.

179 (8) (a) Each voter at an election for a board of trustees member of a local district shall:

180 (i) be a registered voter within the district, except for an election of:

181 (A) an irrigation district board of trustees member; or

182 (B) a basic local district board of trustees member who is elected by property owners;

183 and

184 (ii) meet the requirements to vote established by the district.

185 (b) Each voter may vote for as many candidates as there are offices to be filled.

186 (c) The candidates who receive the highest number of votes are elected.

187 (9) Except as otherwise provided by this section, the election of local district board
188 members is governed by Title 20A, Election Code.

189 (10) (a) Except as provided in Subsection 17B-1-303(8), a person elected to serve on a
190 local district board shall serve a four-year term, beginning at noon on the January 1 after the
191 person's election.

192 (b) A person elected shall be sworn in as soon as practical after January 1.

193 (11) (a) Except as provided in Subsection (11)(b), each local district shall reimburse
194 the county or municipality holding an election under this section for the costs of the election
195 attributable to that local district.

196 (b) Each irrigation district shall bear the district's own costs of each election the district
197 holds under this section.

198 (12) This section does not apply to an improvement district that provides electric or gas
199 service.

200 (13) Except as provided in Subsection 20A-3a-605(1)(b), the provisions of Title 20A,
201 Chapter 3a, Part 6, Early Voting, do not apply to an election under this section.

202 (14) (a) As used in this Subsection (14), "board" means:

203 (i) a local district board; or

204 (ii) the administrative control board of a special service district that has elected
205 members on the board.

206 (b) A board may hold elections for membership on the board at a regular general
207 election instead of a municipal general election if the board submits an application to the
208 lieutenant governor that:

209 (i) requests permission to hold elections for membership on the board at a regular
210 general election instead of a municipal general election; and

211 (ii) indicates that holding elections at the time of the regular general election is
212 beneficial, based on potential cost savings, a potential increase in voter turnout, or another
213 material reason.

214 (c) Upon receipt of an application described in Subsection (14)(b), the lieutenant
215 governor may approve the application if the lieutenant governor concludes that holding the
216 elections at the regular general election is beneficial based on the criteria described in
217 Subsection (14)(b)(ii).

218 (d) If the lieutenant governor approves a board's application described in this section:

219 (i) all future elections for membership on the board shall be held at the time of the
220 regular general election; and

221 (ii) the board may not hold elections at the time of a municipal general election unless
222 the board receives permission from the lieutenant governor to hold all future elections for
223 membership on the board at a municipal general election instead of a regular general election,
224 under the same procedure, and by applying the same criteria, described in this Subsection (14).

225 (15) (a) This Subsection (15) applies to a local district if:

226 (i) the local district's board members are elected by the owners of real property, as
227 provided in Subsection 17B-1-1402(1)(b); and

228 (ii) the local district was created before January 1, 2020.

229 (b) The board of a local district described in Subsection (15)(a) may conduct an
230 election:

231 (i) to fill a board member position that expires at the end of the term for that board
232 member's position; and

233 (ii) notwithstanding Subsection 20A-1-512(1)(a)(i), to fill a vacancy in an unexpired
234 term of a board member.

235 (c) An election under Subsection (15)(b) may be conducted as determined by the local
236 district board, subject to Subsection (15)(d).

237 (d) (i) The local district board shall provide to property owners eligible to vote at the
238 local district election:

239 (A) notice of the election; and

240 (B) a form to nominate an eligible individual to be elected as a board member.

241 (ii) (A) The local district board may establish a deadline for a property owner to submit
242 a nomination form.

243 (B) A deadline under Subsection (15)(d)(ii)(A) may not be earlier than 15 days after
244 the board provides the notice and nomination form under Subsection (15)(d)(i).

245 (iii) (A) After the deadline for submitting nomination forms, the local district board
246 shall provide a ballot to all property owners eligible to vote at the local district election.

247 (B) A local district board shall allow at least five days for ballots to be returned.

248 (iv) A local district board shall certify the results of an election under this Subsection
249 (15) during an open meeting of the board.

250 Section 3. Section **20A-1-102** is amended to read:

251 **20A-1-102. Definitions.**

252 As used in this title:

253 (1) "Active voter" means a registered voter who has not been classified as an inactive
254 voter by the county clerk.

255 (2) "Automatic tabulating equipment" means apparatus that automatically examines
256 and counts votes recorded on ballots and tabulates the results.

257 (3) (a) "Ballot" means the storage medium, including a paper, mechanical, or electronic
258 storage medium, that records an individual voter's vote.

259 (b) "Ballot" does not include a record to tally multiple votes.

260 (4) "Ballot proposition" means a question, issue, or proposal that is submitted to voters
261 on the ballot for their approval or rejection including:

262 (a) an opinion question specifically authorized by the Legislature;

263 (b) a constitutional amendment;

264 (c) an initiative;

265 (d) a referendum;

266 (e) a bond proposition;

267 (f) a judicial retention question;

268 (g) an incorporation of a city or town; or

269 (h) any other ballot question specifically authorized by the Legislature.

270 (5) "Bind," "binding," or "bound" means securing more than one piece of paper
271 together using staples or another means in at least three places across the top of the paper in the
272 blank space reserved for securing the paper.

273 (6) "Board of canvassers" means the entities established by Sections [20A-4-301](#) and
274 [20A-4-306](#) to canvass election returns.

275 (7) "Bond election" means an election held for the purpose of approving or rejecting

276 the proposed issuance of bonds by a government entity.

277 (8) "Business reply mail envelope" means an envelope that may be mailed free of
278 charge by the sender.

279 (9) "Canvass" means the review of election returns and the official declaration of
280 election results by the board of canvassers.

281 (10) "Canvassing judge" means a poll worker designated to assist in counting ballots at
282 the canvass.

283 (11) "Contracting election officer" means an election officer who enters into a contract
284 or interlocal agreement with a provider election officer.

285 (12) "Convention" means the political party convention at which party officers and
286 delegates are selected.

287 (13) "Counting center" means one or more locations selected by the election officer in
288 charge of the election for the automatic counting of ballots.

289 (14) "Counting judge" means a poll worker designated to count the ballots during
290 election day.

291 (15) "Counting room" means a suitable and convenient private place or room for use
292 by the poll workers and counting judges to count ballots.

293 (16) "County officers" means those county officers that are required by law to be
294 elected.

295 (17) "Date of the election" or "election day" or "day of the election":

296 (a) means the day that is specified in the calendar year as the day that the election
297 occurs; and

298 (b) does not include:

299 (i) deadlines established for voting by mail, military-overseas voting, or emergency
300 voting; or

301 (ii) any early voting or early voting period as provided under Chapter 3a, Part 6, Early
302 Voting.

303 (18) "Elected official" means:

304 (a) a person elected to an office under Section [20A-1-303](#) or Chapter 4, Part 6,
305 Municipal Alternate Voting Methods Pilot Project;

306 (b) a person who is considered to be elected to a municipal office in accordance with

307 Subsection 20A-1-206(1)(c)(ii); or

308 (c) a person who is considered to be elected to a local district office in accordance with

309 Subsection 20A-1-206(3)(c)(ii).

310 (19) "Election" means a regular general election, a municipal general election, a
311 statewide special election, a local special election, a regular primary election, a municipal
312 primary election, and a local district election.

313 (20) "Election Assistance Commission" means the commission established by the Help
314 America Vote Act of 2002, Pub. L. No. 107-252.

315 (21) "Election cycle" means the period beginning on the first day persons are eligible to
316 file declarations of candidacy and ending when the canvass is completed.

317 (22) "Election judge" means a poll worker that is assigned to:

318 (a) preside over other poll workers at a polling place;

319 (b) act as the presiding election judge; or

320 (c) serve as a canvassing judge, counting judge, or receiving judge.

321 (23) "Election officer" means:

322 (a) the lieutenant governor, for all statewide ballots and elections;

323 (b) the county clerk for:

324 (i) a county ballot and election; and

325 (ii) a ballot and election as a provider election officer as provided in Section
326 20A-5-400.1 or 20A-5-400.5;

327 (c) the municipal clerk for:

328 (i) a municipal ballot and election; and

329 (ii) a ballot and election as a provider election officer as provided in Section
330 20A-5-400.1 or 20A-5-400.5;

331 (d) the local district clerk or chief executive officer for:

332 (i) a local district ballot and election; and

333 (ii) a ballot and election as a provider election officer as provided in Section
334 20A-5-400.1 or 20A-5-400.5; or

335 (e) the business administrator or superintendent of a school district for:

336 (i) a school district ballot and election; and

337 (ii) a ballot and election as a provider election officer as provided in Section

338 [20A-5-400.1](#) or [20A-5-400.5](#).

339 (24) "Election official" means any election officer, election judge, or poll worker.

340 (25) "Election results" means:

341 (a) for an election other than a bond election, the count of votes cast in the election and
342 the election returns requested by the board of canvassers; or

343 (b) for bond elections, the count of those votes cast for and against the bond
344 proposition plus any or all of the election returns that the board of canvassers may request.

345 (26) "Election returns" includes the pollbook, the military and overseas absentee voter
346 registration and voting certificates, one of the tally sheets, any unprocessed ballots, all counted
347 ballots, all excess ballots, all unused ballots, all spoiled ballots, the ballot disposition form, and
348 the total votes cast form.

349 (27) "Electronic signature" means an electronic sound, symbol, or process attached to
350 or logically associated with a record and executed or adopted by a person with the intent to sign
351 the record.

352 (28) "Inactive voter" means a registered voter who is listed as inactive by a county
353 clerk under Subsection [20A-2-306\(4\)\(c\)\(i\)](#) or (ii).

354 (29) "Judicial office" means the office filled by any judicial officer.

355 (30) "Judicial officer" means any justice or judge of a court of record or any county
356 court judge.

357 (31) "Local district" means a local government entity under Title 17B, Limited Purpose
358 Local Government Entities - Local Districts, and includes a special service district under Title
359 17D, Chapter 1, Special Service District Act.

360 (32) "Local district officers" means those local district board members that are required
361 by law to be elected.

362 (33) "Local election" means a regular county election, a regular municipal election, a
363 municipal primary election, a local special election, a local district election, and a bond
364 election.

365 (34) "Local political subdivision" means a county, a municipality, a local district, or a
366 local school district.

367 (35) "Local special election" means a special election called by the governing body of a
368 local political subdivision in which all registered voters of the local political subdivision may

369 vote.

370 (36) "Manual ballot" means a paper document produced by an election officer on
371 which an individual records an individual's vote by directly placing a mark on the paper
372 document using a pen or other marking instrument.

373 (37) "Mechanical ballot" means a record, including a paper record, electronic record, or
374 mechanical record, that:

375 (a) is created via electronic or mechanical means; and

376 (b) records an individual voter's vote cast via a method other than an individual directly
377 placing a mark, using a pen or other marking instrument, to record an individual voter's vote.

378 (38) "Municipal executive" means:

379 (a) the mayor in the council-mayor form of government defined in Section 10-3b-102;

380 (b) the mayor in the council-manager form of government defined in Subsection

381 10-3b-103(7); or

382 (c) the chair of a metro township form of government defined in Section 10-3b-102.

383 (39) "Municipal general election" means the election held in municipalities and, as

384 applicable, local districts on the first Tuesday after the first Monday in November of each

385 odd-numbered year for the purposes established in Section 20A-1-202.

386 (40) "Municipal legislative body" means:

387 (a) the council of the city or town in any form of municipal government; or

388 (b) the council of a metro township.

389 (41) "Municipal office" means an elective office in a municipality.

390 (42) "Municipal officers" means those municipal officers that are required by law to be
391 elected.

392 (43) "Municipal primary election" means an election held to nominate candidates for
393 municipal office.

394 (44) "Municipality" means a city, town, or metro township.

395 (45) "Official ballot" means the ballots distributed by the election officer for voters to
396 record their votes.

397 (46) "Official endorsement" means the information on the ballot that identifies:

398 (a) the ballot as an official ballot;

399 (b) the date of the election; and

- 400 (c) (i) for a ballot prepared by an election officer other than a county clerk, the
401 facsimile signature required by Subsection 20A-6-401(1)(a)(iii); or
- 402 (ii) for a ballot prepared by a county clerk, the words required by Subsection
403 20A-6-301(1)(b)(iii).
- 404 (47) "Official register" means the official record furnished to election officials by the
405 election officer that contains the information required by Section 20A-5-401.
- 406 (48) "Political party" means an organization of registered voters that has qualified to
407 participate in an election by meeting the requirements of Chapter 8, Political Party Formation
408 and Procedures.
- 409 (49) (a) "Poll worker" means a person assigned by an election official to assist with an
410 election, voting, or counting votes.
- 411 (b) "Poll worker" includes election judges.
- 412 (c) "Poll worker" does not include a watcher.
- 413 (50) "Pollbook" means a record of the names of voters in the order that they appear to
414 cast votes.
- 415 (51) "Polling place" means a building where voting is conducted.
- 416 (52) "Position" means a square, circle, rectangle, or other geometric shape on a ballot
417 in which the voter marks the voter's choice.
- 418 (53) "Presidential Primary Election" means the election established in Chapter 9, Part
419 8, Presidential Primary Election.
- 420 (54) "Primary convention" means the political party conventions held during the year
421 of the regular general election.
- 422 (55) "Protective counter" means a separate counter, which cannot be reset, that:
- 423 (a) is built into a voting machine; and
- 424 (b) records the total number of movements of the operating lever.
- 425 (56) "Provider election officer" means an election officer who enters into a contract or
426 interlocal agreement with a contracting election officer to conduct an election for the
427 contracting election officer's local political subdivision in accordance with Section
428 20A-5-400.1.
- 429 (57) "Provisional ballot" means a ballot voted provisionally by a person:
- 430 (a) whose name is not listed on the official register at the polling place;

431 (b) whose legal right to vote is challenged as provided in this title; or

432 (c) whose identity was not sufficiently established by a poll worker.

433 (58) "Provisional ballot envelope" means an envelope printed in the form required by
434 Section 20A-6-105 that is used to identify provisional ballots and to provide information to
435 verify a person's legal right to vote.

436 (59) (a) "Public figure" means an individual who, due to the individual being
437 considered for, holding, or having held a position of prominence in a public or private capacity,
438 or due to the individual's celebrity status, has an increased risk to the individual's safety.

439 (b) "Public figure" does not include an individual:

440 (i) elected to public office; or

441 (ii) appointed to fill a vacancy in an elected public office.

442 (60) "Qualify" or "qualified" means to take the oath of office and begin performing the
443 duties of the position for which the individual was elected.

1280 (i) informs the lieutenant governor that the state office candidate's personal campaign
1281 committee has been selected; and

1282 (ii) provides the name and address of each member and the secretary of the committee.

1283 (b) A state office candidate or the candidate's personal campaign committee may not
1284 make any expenditures on behalf of the candidate until the statement has been filed.

1285 (c) A state office candidate may revoke the selection of any member of the campaign
1286 committee by:

1287 (i) revoking that ~~person's~~ individual's appointment or election in writing;

1288 (ii) personally serving the written revocation on the member whose selection is
1289 revoked; and

1290 (iii) filing a copy of the written revocation with the lieutenant governor.

1291 (d) (i) The state office candidate may select a replacement to fill any vacancy on the
1292 campaign committee.

1293 (ii) The state office candidate shall file that replacement's name and address with the
1294 lieutenant governor.

1295 (3) A member of a state office candidate's personal campaign committee may not make
1296 an expenditure of more than \$1,000 unless the state office candidate or the secretary of the
1297 personal campaign committee authorizes the expenditure in writing.

1298 (4) A state office candidate or the candidate's personal campaign committee may not

1299 make any expenditures prohibited by law.

1301 **20A-11-901. Political advertisements -- Requirement that ads designate**
1302 **responsibility and authorization -- Report to lieutenant governor -- Unauthorized use of**

1304 (1) (a) Whenever any person makes an expenditure for the purpose of financing an
1305 advertisement expressly advocating for the election or defeat of a clearly identified candidate,
1306 or solicits any contribution through any broadcasting station, newspaper, magazine, outdoor
1307 advertising facility, direct mailing, or any other type of general public political advertising, the
1308 advertisement:

1309 (i) if paid for and authorized by a candidate or the candidate's campaign committee,
1310 shall clearly state that the advertisement has been paid for by the candidate or the campaign
1311 committee;

1312 (ii) if paid for by another person but authorized by a candidate or the candidate's
1313 campaign committee, shall clearly state who paid for the advertisement and that the candidate
1314 or the campaign committee authorized the advertisement; or

1315 (iii) if not authorized by a candidate or a candidate's campaign committee, shall clearly
1316 state the name of the person who paid for the advertisement and state that the advertisement is
1317 not authorized by any candidate or candidate's committee.

1318 (2) (a) A person that makes an expenditure for the purpose of financing an
1319 advertisement related to a ballot proposition shall ensure that the advertisement complies with
1320 Subsection (2)(b) if the advertisement expressly advocates:

1321 (i) for placing a ballot proposition on the ballot;

1322 (ii) for keeping a ballot proposition off the ballot;

1323 (iii) that a voter refrain from voting on a ballot proposition; or

1324 (iv) that a voter vote for or against a ballot proposition.

1325 (b) An advertisement described in Subsection (2)(a) shall:

1326 (i) if paid for by a political issues committee, clearly state that the advertisement was
1327 paid for by the political issues committee;

1328 (ii) if paid for by another person but authorized by a political issues committee, clearly
1329 state who paid for the advertisement and that the political issues committee authorized the

1330 advertisement; or

1331 (iii) if not authorized by a political issues committee, clearly state the name of the
1332 person who paid for the advertisement and state that the advertisement is not authorized by any
1333 political issues committee.

1334 (3) The requirements of Subsections (1) and (2) do not apply to:

1352 include or cause to be included the name of any person as endorser or supporter in any political
1353 advertisement, circular, poster, or publication without the express consent of that person.

1354 (6) (a) It is unlawful for a person to pay the owner, editor, publisher, or agent of any
1355 newspaper or other periodical to induce him the owner, editor, publisher, or agent to advocate
1356 or oppose editorially any candidate for nomination or election.

1357 (b) It is unlawful for any owner, editor, publisher, or agent to accept any payment to
1358 advocate or oppose editorially any candidate for nomination or election.

1359 Section 22. Section **20A-15-104** is amended to read:

1360 **20A-15-104. Ballot -- Form -- Manner of marking and voting.**

1361 (1) The requirements of this section govern the form of the ballot and the specific
1362 procedures for electing delegates to the ratification convention.

1363 (2) Each county clerk shall ensure that the ballot to select delegates to the ratification
1364 convention:

1365 (a) is separate from and printed on different color stock than any other ballot to be used
1366 at the same election;

1367 (b) contains the following information in this order:

1368 (i) the text of the proposed amendment;

1369 (ii) instructions to the voter;

1370 (iii) three perpendicular columns of equal width;

1371 (iv) at the head of the first perpendicular column, in plain type, the words "For
1372 Ratification of Proposed Change in Constitution of the United States";

1373 (v) at the head of the second perpendicular column, in plain type, the words "Against
1374 Ratification of Proposed Change in Constitution of the United States";

1375 (vi) no heading or names at the head of the third perpendicular column;

1382 (c) is arranged so that the voter may, by making a single mark, vote for the entire group
1383 of nominees whose names are contained in any column.

1384 (3) Each county clerk shall ensure that the ballot to select delegates to the ratification
1385 convention is in substantially the following form:

1386 "OFFICIAL BALLOT for delegates to convention to ratify or reject proposed
1387 amendment to the Constitution of the United States. The Congress has proposed an amendment
1388 to the Constitution of the United States that provides: (insert here the text of the proposed
1389 amendment).

1390 The Congress has also directed that the proposed amendment be ratified by conventions in the
1391 states.

1398 adjacent to the name.

1405 (4) If the election of delegates to the ratification convention is held at the same time as

1410 (i) hand to each voter the general election ballot and the ratification convention ballot
