9 **General Description:**

10 This bill modifies provisions of the Legislative Oversight and Sunset Act.

11 **Highlighted Provisions:**

12 This bill:

- 13 ▶ extends the sunset date of statutory provisions related to the reporting requirements
- 14 of certain adverse anesthesia events; and
- 15 ▶ extends the sunset date of statutory provisions related to what constitutes
- 16 unprofessional conduct when administering anesthesia in an outpatient setting.
