29	(1) "Aggregate daily expenditures" means:			
30	(a) for a single lobbyist, principal, or government officer, the total of all expenditures			
31	made within a calendar day by the lobbyist, principal, or government officer for the benefit of			
32	an individual public official;			
33	(b) for an expenditure made by a member of a lobbyist group, the total of all			
34	expenditures made within a calendar day by every member of the lobbyist group for the benefit			
35	of an individual public official; or			
36	(c) for a multiclient lobbyist, the total of all expenditures made by the multiclient			
37	lobbyist within a calendar day for the benefit of an individual public official, regardless of			
38	whether the expenditures were attributed to different clients.			
39	(2) "Approved meeting or activity" means a meeting or activity:			
40	(a) (i) to which a legislator is invited; and			
41	(ii) attendance at which is approved by:			
42	(A) the speaker of the House of Representatives, if the public official is a member of			
43	the House of Representatives; or			
44	(B) the president of the Senate, if the public official is a member of the Senate; or			
45	(b) (i) to which a public official who holds a position in the executive branch of state			
46	government is invited; and			
47	(ii) attendance at which is approved by the governor or the lieutenant governor.			
48	(3) "Capitol hill complex" is as defined in Section 63C-9-102.			
49	(4) (a) "Compensation" means anything of economic value, however designated, that is			
50	paid, loaned, granted, given, donated, or transferred to an individual for the provision of			
51	services or ownership before any withholding required by federal or state law.			
52	(b) "Compensation" includes:			
53	(i) a salary or commission;			
54	(ii) a bonus;			
55	(iii) a benefit;			
56	(iv) a contribution to a retirement program or account;			
57	(v) a payment includable in gross income, as defined in Section 62, Internal Revenue			
58	Code, and subject to Social Security deductions, including a payment in excess of the

59	maximum amount subject to deduction under Social Security law;
60	(vi) an amount that the individual authorizes to be deducted or reduced for salary
61	deferral or other benefits authorized by federal law; or
62	(vii) income based on an individual's ownership interest.
63	(5) "Compensation payor" means a person who pays compensation to a public official
64	in the ordinary course of business:
65	(a) because of the public official's ownership interest in the compensation payor; or
66	(b) for services rendered by the public official on behalf of the compensation payor.
67	(6) "Executive action" means:
68	(a) a nomination or appointment by the governor;
69	(b) the proposal, drafting, amendment, enactment, or defeat by a state agency of a rule
70	made in accordance with Title 63G, Chapter 3, Utah Administrative Rulemaking Act;
71	(c) agency ratemaking proceedings; or
72	(d) an adjudicative proceeding of a state agency.
73	(7) (a) "Expenditure" means any of the items listed in this Subsection (7)(a) when
74	given to or for the benefit of a public official unless consideration of equal or greater value is
75	received:
76	(i) a purchase, payment, or distribution;
77	(ii) a loan, gift, or advance;
78	(iii) a deposit, subscription, or forbearance;
79	(iv) services or goods;
80	(v) money;
81	(vi) real property;
82	(vii) a ticket or admission to a sporting, recreational, or artistic event; or
83	(viii) a contract, promise, or agreement, whether or not legally enforceable, to provide
84	any item listed in Subsections (7)(a)(i) through (vii).
85	(b) "Expenditure" does not mean:
86	(i) a commercially reasonable loan made in the ordinary course of business;
87	(ii) a campaign contribution reported in accordance with Title 20A, Chapter 11,
88	Campaign and Financial Reporting Requirements;
89	(iii) printed informational material that is related to the performance of the recipient's

121	(x) travel to, lodging at, food or beverage served at, and admission to an approved

123	(xi) sponsorship of an official event or official entertainment of an approved meeting

126	(A) that is sponsored by a governmental entity; or
127	(B) that is widely attended and related to a governmental duty of a public official; or
128	(xiii) travel to a widely attended event related to a governmental duty of a public
129	official if that travel results in a financial savings to the state.
130	(8) (a) "Government officer" means:
131	(i) an individual elected to a position in state or local government, when acting within
132	the government officer's official capacity; or

135	(b) "Government officer" does not mean a member of the legislative branch of state
136	government.
137	(9) "Immediate family" means:
138	(a) a spouse;
139	(b) a child residing in the household; or
140	(c) an individual claimed as a dependent for tax purposes.
141	(10) "Legislative action" means:
142	(a) a bill, resolution, amendment, nomination, veto override, or other matter pending or
143	proposed in either house of the Legislature or its committees or requested by a legislator; and
144	(b) the action of the governor in approving or vetoing legislation.
145	(11) "Lobbying" means communicating with a public official for the purpose of
146	influencing the passage, defeat, amendment, or postponement of legislative or executive action.
147	(12) (a) "Lobbyist" means:
148	(i) an individual who is employed by a principal; or
149	(ii) an individual who contracts for economic consideration, other than reimbursement
150	for reasonable travel expenses, with a principal to lobby a public official.
151	(b) "Lobbyist" does not include:

- (ii) a member or employee of the legislative branch of state government;
- (iii) a person while appearing at, or providing written comments to, a hearing
 conducted in accordance with Title 63G, Chapter 3, Utah Administrative Rulemaking Act or
 Title 63G, Chapter 4, Administrative Procedures Act;
 - (iv) a person participating on or appearing before an advisory or study task force, commission, board, or committee, constituted by the Legislature or any agency or department of state government, except legislative standing, appropriation, or interim committees;
 - (v) a representative of a political party;
 - (vi) an individual representing a bona fide church solely for the purpose of protecting the right to practice the religious doctrines of the church, unless the individual or church makes an expenditure that confers a benefit on a public official;
 - (vii) a newspaper, television station or network, radio station or network, periodical of general circulation, or book publisher for the purpose of publishing news items, editorials, other comments, or paid advertisements that directly or indirectly urge legislative or executive action; or
 - (viii) an individual who appears on the individual's own behalf before a committee of the Legislature or an agency of the executive branch of state government solely for the purpose of testifying in support of or in opposition to legislative or executive action.
 - (13) "Lobbyist group" means two or more lobbyists, principals, government officers, or any combination of lobbyists, principals, and officers who each contribute a portion of an expenditure made to benefit a public official or member of the public official's immediate family.
 - (14) "Multiclient lobbyist" means a single lobbyist, principal, or government officer who represents two or more clients and divides the aggregate daily expenditure made to benefit a public official or member of the public official's immediate family between two or more of those clients.
 - (15) "Principal" means a person that employs an individual to perform lobbying, either as an employee or as an independent contractor.
 - (16) "Public official" means:
- (a) (i) a member of the Legislature;
