LONG TITLE
General Description:
This bill modifies the Utah Revised Nonprofit Corporation Act to permit the transfer of
water shares, in certain circumstances, and clarifies the rights of a shareholder in a
water company.
Highlighted Provisions:
This bill:
<ul><li>modifies definitions;</li></ul>
<ul> <li>states that ownership of shares in a water company is transferrable, unless otherwise</li> </ul>
provided in the articles of incorporation or bylaws;
<ul> <li>authorizes a water company to purchase the shares of a shareholder who is</li> </ul>
delinquent in payment of shareholder assessments;
<ul> <li>states that a shareholder in a water company has an equitable, beneficial interest in</li> </ul>
the use of the water supply of the water company, proportionate to the shareholder's
shares, which interest is in the nature of real property;
<ul> <li>clarifies the process for distribution to a shareholder of a water company; and</li> </ul>
<ul><li>makes technical changes.</li></ul>

343	(1) [Unless] Except as provided in Subsection (3), and unless otherwise provided [by]
344	in the articles of incorporation or the bylaws, a member of a nonprofit corporation may not
345	transfer:
346	(a) a membership; or
347	(b) any right arising from a membership.
348	(2) [Where] Except as provided in Subsection (3), where transfer rights have been
349	provided in the articles of incorporation or the bylaws of a nonprofit corporation, a restriction
350	on transfer rights may not be binding with respect to a member holding a membership issued
351	[prior to] before the adoption of the restriction, unless the restriction is approved by the
352	affected member.
353	(3) For a water company, unless otherwise provided by the articles of incorporation or
354	bylaws, ownership of shares is transferrable.

358	nonprofit corporation may not purchase the membership of a member:
359	(a) who resigns; or
360	(b) whose membership is terminated.
361	(2) (a) If so authorized, a nonprofit corporation may purchase the membership of a
362	member who resigns or whose membership is terminated for the amount and pursuant to the
363	conditions set forth in or authorized by:
364	(i) its <u>articles of incorporation or its</u> bylaws; or
365	(ii) agreement with the affected member.
366	(b) A payment permitted under Subsection (2)(a) may not violate:
367	(i) Section 16-6a-1301; or

379	(1) A member [does not have any vested property right including any] has no right
380	relating to management, control, purpose, or duration of the nonprofit corporation, except as
381	provided by:
382	[(1)] (a) the articles of incorporation or the bylaws of a mutual benefit corporation; or
383	$\left[\frac{(2)}{(b)}\right]$ other applicable law.
384	(2) Unless otherwise provided by agreement, articles of incorporation, or the bylaws of
385	a water company, and subject to the general liabilities and obligations of the water company, a
386	shareholder in a water company has:
387	(a) an equitable, beneficial interest in the use of the water supply of the water company,
388	proportionate to the shareholder's shares in the water company, which interest is in the nature
389	of real property; and
390	(b) the right to have the shareholder's proportionate share of the water delivered
391	through a diversion structure, ditch, canal, storage and distribution facility, or other
392	appurtenance of the water company, in accordance with the distribution method of the water
393	company.

395	16-6a-1302. Authorized distributions.
396	(1) A nonprofit corporation may:
397	(a) make distributions or distribute the nonprofit corporation's assets to a [member]:
398	(i) member that is a domestic or foreign nonprofit corporation;
399	(ii) <u>member</u> of a mutual benefit corporation, not inconsistent with its bylaws; [or]

400	(iii) shareholder of a water company in a manner consistent with its articles of
401	incorporation, bylaws, or the provisions of this chapter; or
402	[ <del>(iii) that is a</del> ]
403	(iv) governmental entity;
404	(b) pay compensation in a reasonable amount to its members, directors, or officers for
405	services rendered;

419	dissolution if the election, hiring, or other selection after dissolution is not inconsistent with the
420	articles of incorporation and bylaws existing at the time of dissolution.
