**LONG TITLE**

**General Description:**

This bill amends provisions regarding the number of judges in each judicial district.

**Highlighted Provisions:**

This bill:

- ▶ increases the number of district court judges in the Third Judicial District, Fourth Judicial District, and Fifth Judicial District;
- ▶ increases the number of juvenile court judges in the Third Judicial District and the Fourth Judicial District; and
- ▶ makes technical and conforming changes.

Section 1. Section **78A-1-103** is amended to read:
