9    **LONG TITLE**

10   **General Description:**

11            This bill designates Navajo Code Talker Day, and designates certain highways as  
12    Navajo Code Talker Highway.

13   **Highlighted Provisions:**

- 14            This bill:
- 15            ▶ designates Navajo Code Talker Day;
  - 16            ▶ designates portions of Highways 162, 163, and 191 in San Juan County as the  
17    Navajo Code Talker Highway;
  - 18            ▶ requires the Department of Transportation to install signs to indicate the designation  
19    of the Navajo Code Talker Highway; and
  - 20            ▶ makes technical changes.

21   **Money Appropriated in this Bill:**

- 22            This bill appropriates in fiscal year 2020:
- 23            ▶ to the Department of Transportation -- Operations/Maintenance Management --  
24    Maintenance Administration, as a one-time appropriation:
    - 25            • from the General Fund, One-time, \$9,000.

35 Section 1. Section **63G-1-401** is amended to read:

37 (1) The following days shall be commemorated annually:

72 (2) The Department of Veterans and Military Affairs shall coordinate activities, special  
73 programs, and promotional information to heighten public awareness and involvement relating  
74 to Subsections ~~[(1)(c) and (d)]~~ (1)(d) and (j).

75 ~~[(3) The month of October shall be commemorated annually as Italian-American~~  
76 ~~Heritage Month.]~~

83 prescription and over-the-counter medications; and

84 (b) educate citizens about the permanent medication disposal sites in Utah listed on

85 useonlyasdirected.org that allow disposal throughout the year.

86 (4) The second full week of April shall be commemorated annually as Animal Care  
87 and Control Appreciation Week to recognize and increase awareness within the community of  
88 the services that animal care and control professionals provide.

89 (5) The third full week of June shall be commemorated annually as Workplace Safety  
90 Week to heighten public awareness regarding the importance of safety in the workplace.

91 (6) The first full week of May shall be commemorated annually as State Water Week  
92 to recognize the importance of water conservation, quality, and supply in the state.

93 (7) The second Friday and Saturday in August shall be commemorated annually as  
94 Utah Fallen Heroes Days to:

95 (a) honor fallen heroes who, during service in the military or public safety, have  
96 sacrificed their lives to protect the country and the citizens of the state; and

97 (b) encourage political subdivisions to acknowledge and honor fallen heroes.

98 (8) The third full week in August shall be commemorated annually as Drowsy Driving  
99 Awareness Week to:

100 (a) educate the public about the relationship between fatigue and driving performance;  
101 and

102 (b) encourage the Department of Public Safety and the Department of Transportation to  
103 recognize and promote educational efforts on the dangers of drowsy driving.

113 Section 2. Section **72-4-218** is enacted to read:

114 **72-4-218. Navajo Code Talker Highway.**

115 (1) There is established the Navajo Code Talker Highway composed of the existing  
116 Highway 162 in San Juan County from the Utah-Colorado border near Aneth to Bluff, then  
117 Highway 191 and Highway 163 southwest through Mexican Hat to the Utah-Arizona border  
118 near Monument Valley.

119 (2) In addition to other official designations, the Department of Transportation shall  
120 designate the portions of the highway identified in Subsection (1) as the Navajo Code Talker  
121 Highway on future state highway maps.

122 (3) As soon as practicable, the Department of Transportation shall install appropriate  
123 signs along portions of highway indicating the designation as the Navajo Code Talker Highway  
124 as described in Subsection (1).

125 Section 3. **Appropriation.**

126 The following sums of money are appropriated for the fiscal year beginning July 1,  
127 2019, and ending June 30, 2020. These are additions to amounts previously appropriated for  
128 fiscal year 2020. Under the terms and conditions of Title 63J, Chapter 1, Budgetary Procedures  
129 Act, the Legislature appropriates the following sums of money from the funds or accounts  
130 indicated for the use and support of the government of the state of Utah.

132 To Department of Transportation - Operations/Maintenance Management

133 From General Fund, One-time \$9,000

134 Schedule of Programs:

135 Maintenance Administration \$9,000

136 The Legislature intends that the use of these funds is limited to the costs of procuring  
137 and installing road signs for the Navajo Code Talker Highway.
