

Senator Todd D. Weiler proposes the following substitute bill:

SEX OFFENDER REGISTRY REVISIONS

2021 GENERAL SESSION

STATE OF UTAH

LONG TITLE

General Description:

This bill makes changes to the process and requirements for individuals who petition for removal from the Sex and Kidnap Offender Registry.

Highlighted Provisions:

This bill:

- ▶ requires that the Department of Corrections automatically remove individuals from the Sex and Kidnap Offender Registry who qualify;
- ▶ provides that the department shall notify an individual who is removed that the individual has been removed;
- ▶ allows for an individual who has not been automatically removed from the registry by the Department of Corrections but believes their offense is no longer registrable to request removal;
- ▶ removes the authority of the Department of Corrections to charge a fee to process a request for removal;
- ▶ removes the requirement that registrants must comply with all registration requirements in order to be eligible for removal through petition; and
- ▶ makes technical and conforming changes.

35 Section 1. Section **77-41-112** is amended to read:

36 **77-41-112. Removal from registry -- Requirements -- Procedure.**

37 (1) An offender who is required to register with the Sex and Kidnap Offender Registry
38 may petition the court for an order removing the offender from the Sex and Kidnap Offender
39 Registry if:

40 (a) (i) the offender [~~is~~] was convicted of an offense described in Subsection (2);

41 (ii) at least five years have passed after the day on which the offender's sentence for the
42 offense [~~terminates~~] terminated;

43 (iii) the offense is the only offense for which the offender [~~is~~] was required to register;

44 (iv) the offender [~~is~~] has not been convicted of another offense, excluding a traffic
45 offense, [~~after~~] since the day on which the offender [~~is~~] was convicted of the offense for which
46 the offender is required to register, as evidenced by a certificate of eligibility issued by the
47 bureau;

48 (v) the offender successfully [~~completes~~] completed all treatment ordered by the court

- 74 (2) The offenses referred to in Subsection (1)(a)(i) are:
- 75 (a) Section 76-4-401, enticing a minor, if the offense is a class A misdemeanor;
- 76 (b) Section 76-5-301, kidnapping;
- 77 (c) Section 76-5-304, unlawful detention, if the conviction of violating Section
- 78 76-5-304 is the only conviction for which the offender is required to register;
- 79 (d) Section 76-5-401, unlawful sexual activity with a minor if, at the time of the
- 80 offense, the offender is not more than 10 years older than the victim;
- 81 (e) Section 76-5-401.1, sexual abuse of a minor, if, at the time of the offense, the
- 82 offender is not more than 10 years older than the victim;
- 83 (f) Section 76-5-401.2, unlawful sexual conduct with a 16 or 17 year old, and at the
- 84 time of the offense, the offender is not more than 15 years older than the victim; or
- 85 (g) Section 76-9-702.7, voyeurism, if the offense is a class A misdemeanor.
- 86 (3) (a) (i) An offender seeking removal from the Sex and Kidnap Offender Registry
- 87 under this section shall apply for a certificate of eligibility from the bureau.

88 (ii) An offender who intentionally or knowingly provides false or misleading
89 information to the bureau when applying for a certificate of eligibility is guilty of a class B
90 misdemeanor and subject to prosecution under Section 76-8-504.6.

91 (iii) Regardless of whether the offender is prosecuted, the bureau may deny a certificate
92 of eligibility to an offender who provides false information on an application.

93 (b) (i) The bureau shall perform a check of records of governmental agencies,
94 including national criminal databases, to determine whether an offender is eligible to receive a
95 certificate of eligibility.

96 (ii) If the offender meets the requirements described in Subsection (1)(a) or (b), the
97 bureau shall issue a certificate of eligibility to the offender, which is valid for a period of 90
98 days after the day on which the bureau issues the certificate.

99 (iii) The bureau shall request information from the department regarding whether the
100 offender meets the requirements.

101 (iv) (A) Upon request from the bureau under Subsection (3)(b)(iii), the department
102 shall issue a document [~~that states whether the offender meets the requirements described in~~
103 ~~Subsection (1)(a) or (b), which may be used by the bureau to determine if a certificate of~~
104 ~~eligibility is appropriate]~~ on whether the offender meets the requirements described in
105 Subsection (1)(a) or (b), which shall be used by the bureau to determine if a certificate of
106 eligibility is appropriate.

107 (B) The document from the department shall also include a statement regarding the
108 offender's compliance with all registration requirements under this chapter.

109 (v) The bureau shall provide a copy of the document provided to the bureau under
110 Subsection (3)(b)(iv) to the offender upon issuance of a certificate of eligibility.

111 (4) (a) (i) The bureau shall charge application and issuance fees for a certificate of
112 eligibility in accordance with the process in Section 63J-1-504.

113 (ii) The application fee shall be paid at the time the offender submits an application for
114 a certificate of eligibility to the bureau.

115 (iii) If the bureau determines that the issuance of a certificate of eligibility is
116 appropriate, the offender will be charged an additional fee for the issuance of a certificate of
117 eligibility.

118 (b) Funds generated under this Subsection (4) shall be deposited into the General Fund

119 as a dedicated credit by the department to cover the costs incurred in determining eligibility.

120 (5) (a) The offender shall file the petition, including original information, the court
121 docket, the certificate of eligibility from the bureau, and the document from the department
122 described in Subsection (3)(b)(iv) with the court, and deliver a copy of the petition to the office
123 of the prosecutor.

124 (b) Upon receipt of a petition for removal from the Sex and Kidnap Offender Registry,
125 the office of the prosecutor shall provide notice of the petition by first-class mail to the victim
126 at the most recent address of record on file or, if the victim is still a minor under 18 years of
127 age, to the parent or guardian of the victim.

128 (c) The notice described in Subsection (5)(b) shall include a copy of the petition, state
129 that the victim has a right to object to the removal of the offender from the registry, and
130 provide instructions for registering an objection with the court.

131 (d) The office of the prosecutor shall provide the following, if available, to the court
132 within 30 days after the day on which the office receives the petition:

133 (i) presentencing report;

134 (ii) an evaluation done as part of sentencing; and

135 (iii) any other information the office of the prosecutor feels the court should consider.

136 (e) The victim, or the victim's parent or guardian if the victim is a minor under 18 years
137 of age, may respond to the petition by filing a recommendation or objection with the court
138 within 45 days after the day on which the petition is mailed to the victim.

139 (6) (a) The court shall:

140 (i) review the petition and all documents submitted with the petition; and

141 (ii) hold a hearing if requested by the prosecutor or the victim.

142 (b) The court may grant the petition and order removal of the offender from the registry
143 if the court determines that the offender has met the requirements described in Subsection
144 (1)(a) or (b) and removal is not contrary to the interests of the public.

145 (c) In determining whether removal is contrary to the interests of the public, the court
146 may not consider removal unless the offender has substantially complied with all registration
147 requirements under this chapter at all times.

148 [~~(c)~~] (d) If the court grants the petition, the court shall forward a copy of the order
149 directing removal of the offender from the registry to the department and the office of the

150 prosecutor.

151 ~~[(4)]~~ (e) If the court denies the petition, the offender may not submit another petition
152 for three years.

153 (7) The court shall notify the victim and the Sex and Kidnap Offender Registry office
154 in the department of the court's decision within three days after the day on which the court
155 issues the court's decision in the same manner described in Subsection (5).

157 **77-41-113. Removal for offenses for which registration is no longer required.**

158 (1) An individual who is currently on the Sex and Kidnap Offender Registry because of
159 a conviction for any of the following offenses ~~[may contact the department and request~~
160 ~~removal]~~ shall be automatically removed from the registry by the department if the only offense
161 or offenses for which the individual is on the registry is listed in Subsection (2).

162 (2) This section applies to a conviction for the following offenses:

163 (a) a class B or class C misdemeanor for enticing a minor, Section [76-4-401](#);

164 (b) kidnapping, based upon Subsection [76-5-301\(1\)\(a\)](#) or (b);

165 (c) child kidnapping, Section [76-5-301.1](#), if the offender was the natural parent of the
166 child victim;

167 (d) unlawful detention, Section [76-5-304](#);

168 (e) a third degree felony for unlawful sexual intercourse before 1986, or a class B
169 misdemeanor for unlawful sexual intercourse, Section [76-5-401](#); or

170 (f) sodomy, but not forcible sodomy, Section [76-5-403](#).

171 (3) The department shall notify any individual who has been removed from the registry
172 in accordance with Subsection (1). The notice shall include a statement that the individual is no
173 longer required to register as a sex offender.

174 (4) An individual who is currently on the Sex and Kidnap Offender Registry may
175 submit a request to the department to be removed from the registry.

176 ~~[(3)]~~ (5) The department, upon receipt of a request for removal from the registry shall:

177 (a) check the registry for the individual's current status;

178 (b) determine whether the individual qualifies for removal based upon this section; and

179 (c) notify the individual in writing of the department's determination and whether the
180 individual:

181 (i) qualifies for removal from the registry; or

182 (ii) does not qualify for removal.

183 [~~(4)~~] (6) If the department determines that the individual qualifies for removal from the
184 registry, the department shall remove the offender from the registry.

185 [~~(5)~~] (7) If the department determines that the individual does not qualify for removal
186 from the registry, the department shall provide an explanation in writing for the department's
187 determination. The department's determination is final and not subject to administrative review.

188 [~~(6)~~] (8) Neither the department nor any employee may be civilly liable for a
189 determination made in good faith in accordance with this section.

190 [~~(7)~~] (9) The department shall provide a response to a request for removal within 30
191 days of receipt of the request [~~and payment of the fee~~]. If the response cannot be provided
192 within 30 days, the department shall notify the individual that the response may be delayed up
193 to 30 additional days.

194 [~~(8) The department may charge a fee, not to exceed \$25, for a request for removal.~~]
