Estimate of Local Fiscal Impact

In accordance with the provisions of 30-19.03 of the Code of Virginia, the staff of the Commission on Local Government offers the following analysis of legislation impacting local governments.

HB 532: Transportation project; prohibits initiation of project in an established school crossing zone, etc. (Patron: Del. Holly M. Seibold)

Bill Summary: Prohibits the initiation of any transportation project in an established school crossing zone unless a pedestrian safety-focused road safety audit is conducted and its recommendations are incorporated into the project plan. The bill requires the Commonwealth Transportation Board, in administering the Virginia Highway Safety Improvement Program, to prioritize infrastructure projects that address a hazardous road location or feature or address an identified highway safety problem located in a school crossing zone.

Number of Localities Responding: 4 Cities, 6 Counties, 3 Towns, 1 Other

Localities estimated a negative fiscal impact ranging from \$0 to \$ 10,000 over the biennium.

Some counties indicated that this bill will have no fiscal impact on counties.

While most other localities did not identify an immediate impact over the biennium, many indicated this is because they do not have any pending construction projects that would be affected by this bill. Estimates for the cost of a study required by the bill localities were described as "significant". One city estimated \$50,000 per study and \$10,000 to \$10 million per recommended improvement.

City of Alexandria	This bill would result in no code changes or fiscal impact, but if future studies are required there could be an impact but that specific amount is unquantifiable at this time.
	The City of Richmond anticipates a recurring expenditure increase. Currently without further information an estimate for the fiscal impact amount cannot be determined. The city can state that for each required Roadway Safety Audit, it will cost \$50,000. Each recommended improvement it could cost between \$10,000 to \$10 million depending on the type of improvement that is mandated from the RSA. Less work may be occurring in school crossing zones as a result. School crossing zone definitions are proposed to change under other General Assembly action that is ongoing which may potentially expand the potential locations where this legislation would be applicable.
