9	Statement of purpose of bill as introduced: This bill proposes to require health
10	care providers, except in an emergency, to disclose to a patient or other health
11	care consumer the cost of a health care service prior to the patient or consumer
12	incurring any charges. It would also require hospital bills to list each service
13	provided using language commonly understood by patients.

18	CHAPTER 44. HEALTH CARE COST DISCLOSURE
19	§ 1951. DEFINITIONS
20	As used in this chapter:

1	(1) "Health care provider" means a hospital as defined in section 1902
2	of this title, a physician licensed pursuant to 26 V.S.A. chapter 23 or 33, a
3	nurse licensed pursuant to 26 V.S.A. chapter 28, a physician assistant licensed
4	pursuant to 26 V.S.A. chapter 31, a radiologist licensed pursuant to 26 V.S.A.
5	chapter 51, a chiropractor licensed pursuant to 26 V.S.A. chapter 10, or a
6	podiatrist licensed pursuant to 26 V.S.A. chapter 7.
7	(2) "Health insurance plan" means any health insurance policy or health
8	benefit plan offered by a health insurer, as defined in section 9402 of this title,
9	as well as Medicaid or any other public health care assistance program offered
10	or administered by the State or by any subdivision or instrumentality of the
11	State. The term includes policies or plans providing coverage for specific
12	disease or other limited benefit coverage.
13	§ 1952. DISCLOSURE OF COST OF HEALTH CARE SERVICES
14	(a) Except in an emergency, prior to the patient or consumer incurring any
15	charge, a health care provider shall disclose to a patient or other prospective
16	health care consumer:
17	(1) the actual cost of a procedure, surgery, treatment, or other health
18	care service;
19	(2) the amount the health care provider will bill the patient or consumer
20	or his or her health insurance plan for the procedure, surgery, treatment, or
21	other health care service, if different from the actual cost;

1	(3) the portion of the billed amount, if any, that the health insurance plan
2	is expected to pay; and
3	(4) the portion of the billed amount, if any, and any additional
4	cost-sharing amounts that the patient or consumer is expected to pay.
5	(b) A health care provider shall obtain a written acknowledgment from the
6	patient or consumer of the costs disclosed pursuant to subsection (a) of this
7	section prior to engaging in any procedure, surgery, treatment, or other health
8	care service for which the patient or consumer will incur a charge. A health
9	care provider that engages any a procedure, surgery, treatment, or other health
10	care service without obtaining a written acknowledgment of the costs from the
11	patient or consumer may be subject to discipline by the appropriate licensing
12	authority. A parent or guardian shall provide the written acknowledgment for
13	a patient or consumer who is a minor. For a patient or consumer who is not a
14	minor but who lacks the capacity to make medical decisions, a guardian or
15	agent under an advance directive shall provide the written acknowledgment.
16	§ 1953. CLARITY IN HOSPITAL BILLING
17	All bills for health care services and related charges sent from a hospital to a
18	patient or other responsible party other than a health insurance plan shall list a
19	separate charge for each service provided and shall describe the services using
20	language commonly understood by patients.

2	§ 1852. PATIENTS' BILL OF RIGHTS; ADOPTION
3	(a) The General Assembly hereby adopts the "Bill of Rights for Hospital
4	Patients" as follows:

6	(12) The patient has the right to be informed, in advance, of the cost of
7	all services to be performed and to receive an itemized, detailed, and
8	understandable explanation of all charges regardless of the source of payment
9	* * *
