7	equal weekly or biweekly sums beginning at the end of the school year.
8	(C)(i) The school district or supervisory union shall disburse funds
9	from the account in any sum as requested by the employee and, at the end of
10	the school year or at the employee's option over the course of the period

1	(A) The employer provides the employee written disclosure in plain
2	language, in at least 10-point type of both the following:
3	(i) All all the employee's wage payment options-; and
4	(ii) The the terms and conditions of the payroll card account
5	option, including a complete list of all known fees that may be deducted from
6	the employee's payroll card account by the employer or the card issuer and
7	whether third parties may assess fees in addition to the fees assessed by the
8	employer or issuer.
9	(B) Copies of the written disclosures required by subdivisions (A)
10	and (F) of this subdivision (c)(2) and by subsection (d) of this section shall be
11	provided to the employee in the employee's primary language or in a language
12	the employee understands.
13	$(\mathbf{C})$ The employee voluntarily consents in writing to payment of
14	wages by payroll card account after receiving the disclosures described in
15	subdivision (A) of this subdivision (c)(2), and this the employee's consent is
16	not a condition of hire or continued employment.

18	that during each pay period, the employee has at least three free withdrawals
19	from the payroll card, one of which permits withdrawal of the full amount of

2	account are passed on to the employee, and the employer shall does not receive
3	any financial remuneration for using the pay card at the employee's expense.
4	(F)(E)(i) At least 21 days before any change takes effect, the

6	least 10-point type, of the following:
7	(I) any change to any of the terms and conditions of the payroll
8	card account, including any changes in the itemized list of fees; and
9	(II) the employee's right to discontinue receipt of wages by a

1	(H) (H) The employer ensures that the payroll card account provides
2	one free replacement payroll card per year at no cost to the employee before
3	the card's expiration date. A replacement card need not be provided if the card
4	has been inactive for a period of at least 12 months or the employee is no
5	longer employed by the employer.
6	(J)(I) A nonbranded payroll card may be issued for temporary
7	purposes and shall be valid for no more than 60 days.
8	(K)(J) The payroll card account shall not be linked to any form of
9	credit, including a loan against future pay or a cash advance on future pay.
10	(L)(K) The employer shall not charge the employee an initiation,
11	loading, or other participatory fee to receive wages payable in an electronic
12	fund transfer to a payroll card account, with the exception of the cost required
13	to replace a lost, stolen, or damaged payroll card.

15	provides to the employee, upon the employee's written or oral request, one free
16	written transaction history each month which that includes all deposits,
17	withdrawals, deductions, or charges by any entity from or to the employee's
18	payroll card account for the preceding 60 days. The employer shall also ensure
19	that the account allows the employee to elect to receive the monthly
20	transaction history by <u>regular mail</u> , electronic mail, or in another digital
21	<u>format</u> .

1	(d)(1) If a payroll card account is established with a financial institution as
2	an account that is individually owned by the employee, the employer's
3	obligations and the protections afforded under subsection (c) of this section
4	shall cease 30 days after the employer-employee relationship ends and the
5	employee has been paid his or her final wages.
6	(2) Upon the termination of the relationship between the employer and
7	the employee who owns the individual payroll card account:
8	(A) the employer shall notify the financial institution of any changes
9	in the relationship between the employer and employee; and
10	(B) the financial institution holding the individually owned payroll
11	card account shall provide the employee with a written statement in plain
12	language describing a full list of the fees and obligations the employee might
13	incur by continuing a relationship with the financial institution.
