11	Statement of purpose of bill as introduced: This bill proposes to require movie
12	theaters to provide showings of motion pictures with open movie captioning.
13	An act relating to open movie captioning in movie theaters
14	It is hereby enacted by the General Assembly of the State of Vermont:
15	Sec. 1. 9 V.S.A. § 4509 is added to read:
16	§ 4509. MOVIE THEATERS; OPEN CAPTIONING
17	(a) As used in this section:
18	(1) "Movie theater" means an entity in the business of providing
19	showings of motion pictures to the general public.

1	(2) "Open movie captioning" means the written, on-screen display of a
2	motion picture's dialogue and nonspeech information, such as music, the
3	identity of the character who is speaking, and other sounds and sound effects.
4	(3) "Peak movie attendance hours" means the hours after 6:00 p.m. on
5	Friday, or the hours after 12:00 noon on Saturday and Sunday.
6	(b)(1) A movie theater with four or more screens shall provide open movie
7	captioning during at least four scheduled showings per week of each motion
8	picture that is produced and offered with open movie captioning, provided that:
9	(A) at least two of the showings required by this subdivision shall be
10	provided during peak movie attendance hours; and
11	(B) at least one of the showings required by this subdivision shall be
12	provided outside of peak movie attendance hours and shall start after 6:00 p.m.
13	but before 11:00 p.m. on Monday, Tuesday, Wednesday, or Thursday.
14	(2) A movie theater with two or three screens shall provide open movie
15	captioning during at least two scheduled showings per week of each motion
16	picture that is produced and offered with open movie captioning. At least one
17	showing with open movie captioning shall be provided during peak movie
18	attendance hours.
19	(3) A movie theater with one screen shall provide a screening of a
20	motion picture produced with open movie captioning at least once per month.

1	(c) A violation of subsection (b) of this section shall be an unlawful
2	discriminatory practice pursuant to section 4506 of this chapter.
3	(d)(1) A movie theater shall advertise the date and time of motion picture
4	showings required pursuant to subsection (b) of this section in the same
5	manner as the movie theater advertises all other motion picture showings.
6	(2) A movie theater shall provide, through radio, television, social
7	media, or print media advertising, and by posting inside the movie theater,
8	notice to all customers of the following:
9	(A) the availability of showings of motion pictures with open movie
10	captioning; and
11	(B) whether each motion picture shown by the movie theater is
12	available with or without open movie captioning.
13	(e) Nothing in this section shall prohibit the showing of a motion picture
14	that is produced and distributed without open movie captioning, provided that
15	the movie theater shall issue notice to the public of which motion pictures
16	offered by the movie theater are produced and distributed without open movie
17	captioning.
