7	Statement of purpose of bill as introduced: This bill proposes to designate
8	Election Day as a State holiday.
9	An act relating to designating Election Day as a State holiday
10	It is hereby enacted by the General Assembly of the State of Vermont:
11	Sec. 1. LEGISLATIVE FINDINGS
12	(a) Voting is a fundamental right enshrined in Amendment XV to the
13	United States Constitution and protected in the Voting Rights Act of 1965
14	(Pub. L No. 89-10) and its amendments.
15	(b) Chapter II, Section 43 of the Vermont Constitution provides that
16	statewide officers, members of the General Assembly, and various county
17	officers "shall be elected biennially on the first Tuesday next after the first
18	Monday of November."
19	(c) Although the 55 to 58 percent of registered Vermont voters who voted
20	in the 2018 general election was possibly a nonpresidential election year State

1	record, over 40 percent of registered voters failed to vote, and this figure does
2	not account for those persons who never registered to vote.
3	(d) Same-day voter registration and extensive early voting time periods
4	facilitate greater access to voting for Vermonters than for voters in most states,
5	but more efforts are needed to raise the percentage of Vermonters who exercise
6	their right to vote.
7	(e) Designation of Election Day as an official holiday, as is Town Meeting
8	Day in Vermont, could encourage and facilitate more Vermonters exercising
9	their right to vote.
