10	2018 Acts and Resolves No. 173 made substantial changes to the funding of
11	special education services and directed the Agency of Education to assist
12	supervisory unions in adopting best practices for the delivery of special
13	education services. This act makes certain minor amendments to the special
14	education laws that are proposed by the Agency of Education to clarify some
15	of the changes made in Act 173.

10	(b) On or before November 1, 2019, a supervisory union shall submit to the
11	Secretary such information as required:
12	(1) by the Secretary to estimate the supervisory union's projected fiscal
13	year 2021 extraordinary special education reimbursement under Sec. 5 of this
14	act; and
15	(2) for IDEA reporting in a format specified by the Secretary.
16	(c) The Agency of Education shall assist supervisory unions as they
17	transition to the census-based funding model in satisfying their maintenance of
18	effort requirements under federal law.
