11	Statement of purpose: This bill proposes to: 1) require a genuine progress
12	indicator committee to develop an economic indicator, to be named "the
13	genuine progress indicator," to replace the gross domestic product as a
14	measure of Vermont's economic health; and 2) require the governor to use the
15	genuine progress indicator developed by the committee as a factor in preparing
16	the state budget.

1	It is hereby enacted by the General Assembly of the State of Vermont:
2	Sec. 1. GENUINE PROGRESS INDICATOR
3	(a) Creation of committee. There is created a genuine progress indicator
4	committee to develop an economic indicator which shall be named "the
5	genuine progress indicator."
6	(b) Membership. The genuine progress indicator committee shall be
7	composed of:
8	(1) the secretary of administration;
9	(2) the secretary of agriculture, food and markets or his or her designee;
10	(3) the commissioner of banking, insurance, securities, and health care
11	administration or his or her designee;
12	(4) the secretary of commerce and community development or his or her
13	designee;
14	(5) the commissioner of fish and wildlife or his or her designee;
15	(6) the commissioner of forest, parks and recreation or his or her
16	designee;
17	(7) the commissioner of health or his or her designee
18	(8) the commissioner of labor or his or her designee;
19	(9) the commissioner of public safety or his or her designee;

9	(c) Powers and duties of committee; purpose of indicator.
10	(1) By November 1, 2012, the committee shall develop a genuine
11	progress indicator to replace the gross domestic product as a measure of
12	Vermont's economic health.
13	(2) The genuine progress indicator shall be one that adds in positive
14	factors and subtracts negative factors which are not counted by standard gross
15	domestic product accounting practices.
16	(3) The genuine progress indicator shall be based upon and be at least as
17	comprehensive as the framework designed by the Gund Institute for Ecological
18	Economics of the University of Vermont; shall incorporate basic human rights
19	principles; and shall include at least the following measures:
20	(A) access to livable wages;
21	(B) access to affordable housing;

18	(1) By November 1, 2012, the governor shall ensure that the genuine
19	progress indicator developed by the committee is posted online on his or her
20	official gubernatorial website.
