3	It is hereby enacted by the General Assembly of the State of Vermont:
4	Sec. 1. IRENE HOUSING FUND
5	(a) There is established a special fund to be called the "Irene housing fund"
6	for the purpose of providing money to Vermont citizens who have lost their
7	home or had their home damaged as a result of Tropical Storm Irene. The fund
8	shall exist from the first day of fiscal year 2013 to the last day of fiscal year
9	2013. The fund shall be comprised of 50 percent of the revenue from the
10	property transfer tax under 32 V.S.A. chapter 231 and any moneys
11	appropriated to the fund by the general assembly or received from any other
12	source. The fund shall be administered by the agency of commerce and
13	community development which shall develop rules and procedures for
14	disbursing money to help Vermont citizens who have lost their home or had
