I	§ 4500. AUDIOLOGY AND SPEECH-LANGUAGE PATHOLOGY
2	INTERSTATE COMPACT; ADOPTION
3	This subchapter is the Vermont adoption of the Audiology and Speech-
4	Language Pathology Interstate Compact. The form, format, and text of the
5	Compact have been conformed to the conventions of the Vermont Statutes
6	Annotated. It is the intent of the General Assembly that this subchapter be
7	interpreted as substantively the same as the Audiology and Speech-Language
8	Pathology Interstate Compact that is enacted by other Compact party states.
9	<u>§ 4501. PURPOSE</u>
10	(a) The purpose of this Compact is to facilitate interstate practice of
11	audiology and speech-language pathology with the goal of improving public
12	access to audiology and speech-language pathology services. The practice of
13	audiology and speech-language pathology occurs in the state where the
14	patient/client/student is located at the time of the patient/client/student
15	encounter. The Compact preserves the regulatory authority of states to protect
16	public health and safety through the current system of state licensure.
17	(b) This Compact is designed to achieve the following objectives:
18	(1) increase public access to audiology and speech-language pathology
19	services by providing for the mutual recognition of other member state
20	licenses;
21	(2) enhance the states' ability to protect the public's health and safety;

1	(3) encourage the cooperation of member states in regulating multistate
2	audiology and speech-language pathology practice;
3	(4) support spouses of relocating active duty military personnel;
4	(5) enhance the exchange of licensure, investigative and disciplinary
5	information between member states;
6	(6) allow a remote state to hold a provider of services with a compact
7	privilege in that state accountable to that state's practice standards; and
8	(7) allow for the use of telehealth technology to facilitate increased
9	access to audiology and speech-language pathology services.
10	§ 4502. DEFINITIONS
11	As used in this Compact, and except as otherwise provided, the following
12	definitions shall apply:
13	(1) "Active duty military" means full-time duty status in the active
14	uniformed service of the United States, including members of the National
15	Guard and Reserve on active duty orders pursuant to 10 U.S.C. Chapter 1209
16	and 1211.
17	(2) "Adverse action" means any administrative, civil, equitable or
18	criminal action permitted by a state's laws that is imposed by a licensing board
19	or other authority against an audiologist or speech-language pathologist,
20	including actions against an individual's license or privilege to practice such as

1	revocation, suspension, probation, monitoring of the licensee, or restriction on
2	the licensee's practice.
3	(3) "Alternative program" means a nondisciplinary monitoring process
4	approved by an audiology or speech-language pathology licensing board to
5	address impaired practitioners.
6	(4) "Audiologist" means an individual who is licensed by a state to
7	practice audiology.
8	(5) "Audiology" means the care and services provided by a licensed
9	audiologist as set forth in the member state's statutes and rules.
10	(6) "Audiology and Speech-Language Pathology Compact
11	Commission" or "Commission" means the national administrative body whose
12	membership consists of all states that have enacted the Compact.
13	(7) "Audiology and speech-language pathology licensing board,"
14	"audiology licensing board," "speech-language pathology licensing board," or
15	"licensing board" means the agency of a state that is responsible for the
16	licensing and regulation of audiologists or speech-language pathologists, or
17	both.
18	(8) "Compact privilege" means the authorization granted by a remote
19	state to allow a licensee from another member state to practice as an
20	audiologist or speech-language pathologist in the remote state under its laws
21	and rules. The practice of audiology or speech-language pathology occurs in

1	the member state where the patient/client/student is located at the time of the
2	patient/client/student encounter.
3	(9) "Current significant investigative information" means investigative
4	information that a licensing board, after an inquiry or investigation that
5	includes notification and an opportunity for the audiologist or speech-language
6	pathologist to respond, if required by state law, has reason to believe is not
7	groundless and, if proved true, would indicate more than a minor infraction.
8	(10) "Data system" means a repository of information about licensees,
9	including, but not limited to, continuing education, examination, licensure,
10	investigative, compact privilege, and adverse action.
11	(11) "Encumbered license" means a license in which an adverse action
12	restricts the practice of audiology or speech-language pathology by the
13	licensee and said adverse action has been reported to the National Practitioners
14	Data Bank (NPDB).
15	(12) "Executive Committee" means a group of directors elected or
16	appointed to act on behalf of, and within the powers granted to them by, the
17	Commission.
18	(13) "Home state" means the member state that is the licensee's primary
19	state of residence.

1	(14) "Impaired practitioner" means individuals whose professional
2	practice is adversely affected by substance abuse, addiction, or other health-
3	related conditions.
4	(15) "Licensee" means an individual who currently holds an
5	authorization from the state licensing board to practice as an audiologist or
6	speech-language pathologist.
7	(16) "Member state" means a state that has enacted the Compact.
8	(17) "Privilege to practice" means a legal authorization permitting the
9	practice of audiology or speech-language pathology in a remote state.
10	(18) "Remote state" means a member state other than the home state
11	where a licensee is exercising or seeking to exercise the compact privilege.
12	(19) "Rule" means a regulation, principle or directive promulgated by
13	the Commission that has the force of law.
14	(20) "Single-state license" means an audiology or speech-language
15	pathology license issued by a member state that authorizes practice only within
16	the issuing state and does not include a privilege to practice in any other
17	member state.
18	(21) "Speech-language pathologist" means an individual who is licensed
19	by a state to practice speech-language pathology.

1	(22) "Speech-language pathology" means the care and services provided
2	by a licensed speech-language pathologist as set forth in the member state's
3	statutes and rules.
4	(23) "State" means any state, commonwealth, district or territory of the
5	United States of America that regulates the practice of audiology and speech-
6	language pathology.
7	(24) "State practice laws" means a member state's laws, rules, and
8	regulations that govern the practice of audiology or speech-language
9	pathology, define the scope of audiology or speech-language pathology
10	practice, and create the methods and grounds for imposing discipline.
11	(25) "Telehealth" means the application of telecommunication
12	technology to deliver audiology or speech-language pathology services at a
13	distance for assessment, intervention and/or consultation.
14	§ 4503. STATE PARTICIPATION IN THE COMPACT
15	(a) A license issued to an audiologist or speech-language pathologist by a
16	home state to a resident in that state shall be recognized by each member state
17	as authorizing an audiologist or speech-language pathologist to practice
18	audiology or speech-language pathology, under a privilege to practice, in each
19	member state.
20	(b) A state must implement or utilize procedures for considering the
21	criminal history records of applicants for initial privilege to practice. These

procedures shall include the submission of fingerprints or other biometric-
based information by applicants for the purpose of obtaining an applicant's
criminal history record information from the Federal Bureau of Investigation
and the agency responsible for retaining that state's criminal records.
(1) A member state must fully implement a criminal background check
requirement, within a time frame established by rule, by receiving the results
of the Federal Bureau of Investigation record search on criminal background
checks and use the results in making licensure decisions.
(2) Communication between a member state, the Commission, and
among member states regarding the verification of eligibility for licensure
through the Compact shall not include any information received from the
Federal Bureau of Investigation relating to a federal criminal records check
performed by a member state under Pub. L. No. 92-544.
(c) Upon application for a privilege to practice, the licensing board in the
issuing remote state shall ascertain, through the data system, whether the
applicant has ever held, or is the holder of, a license issued by any other state;
whether there are any encumbrances on any license or privilege to practice
held by the applicant; and whether any adverse action has been taken against
any license or privilege to practice held by the applicant.

1	(d) Each member state shall require an applicant to obtain or retain a
2	license in the home state and meet the home state's qualifications for licensure
3	or renewal of licensure as well as all other applicable state laws.
4	(e) For an audiologist:
5	(1) must meet one of the following educational requirements:
6	(A) on or before December 31, 2007, has graduated with a master's
7	degree or doctorate in audiology, or equivalent degree regardless of degree
8	name, from a program that is accredited by an accrediting agency recognized
9	by the Council for Higher Education Accreditation, or its successor, or by the
10	U.S. Department of Education and operated by a college or university
11	accredited by a regional or national accrediting organization recognized by the
12	board; or
13	(B) on or after January 1, 2008, has graduated with a Doctoral degree
14	in audiology, or equivalent degree, regardless of degree name, from a program
15	that is accredited by an accrediting agency recognized by the Council for
16	Higher Education Accreditation, or its successor, or by the U.S. Department of
17	Education and operated by a college or university accredited by a regional or
18	national accrediting organization recognized by the board; or
19	(C) has graduated from an audiology program that is housed in an
20	institution of higher education outside of the United States:

1	(i) for which the program and institution have been approved by
2	the authorized accrediting body in the applicable country; and
3	(ii) the degree program has been verified by an independent
4	credentials review agency to be comparable to a state licensing board-approved
5	program;
6	(2) has completed a supervised clinical practicum experience from an
7	accredited educational institution or its cooperating programs as required by
8	the Commission;
9	(3) has successfully passed a national examination approved by the
10	Commission;
11	(4) holds an active, unencumbered license;
12	(5) has not been convicted or found guilty, and has not entered into an
13	agreed disposition, of a felony related to the practice of audiology, under
14	applicable state or federal criminal law; and
15	(6) has a valid U.S. Social Security or National Practitioner
16	Identification number.
17	(f) For a speech-language pathologist:
18	(1) must meet one of the following educational requirements:
19	(A) has graduated with a master's degree from a speech-language
20	pathology program that is accredited by an organization recognized by the
21	U.S. Department of Education and operated by a college or university

1	accredited by a regional or national accrediting organization recognized by the
2	board; or
3	(B) has graduated from a speech-language pathology program that is
4	housed in an institution of higher education outside of the United States:
5	(i) for which the program and institution have been approved by
6	the authorized accrediting body in the applicable country; and
7	(ii) the degree program has been verified by an independent
8	credentials review agency to be comparable to a state licensing board-approved
9	program;
10	(2) has completed a supervised clinical practicum experience from an
11	educational institution or its cooperating programs as required by the
12	Commission;
13	(3) has completed a supervised postgraduate professional experience as
14	required by the Commission;
15	(4) has successfully passed a national examination approved by the
16	Commission;
17	(5) holds an active, unencumbered license;
18	(6) has not been convicted or found guilty, and has not entered into an
19	agreed disposition, of a felony related to the practice of speech-language
20	pathology, under applicable state or federal criminal law; and

1	(7) has a valid U.S. Social Security or National Practitioner
2	Identification number.
3	(g) The privilege to practice is derived from the home state license.
4	(h) An audiologist or speech-language pathologist practicing in a member
5	state must comply with the state practice laws of the state in which the client is
6	located at the time service is provided. The practice of audiology and speech-
7	language pathology shall include all audiology and speech-language pathology
8	practice as defined by the state practice laws of the member state in which the
9	client is located. The practice of audiology and speech-language pathology in
10	a member state under a privilege to practice shall subject an audiologist or
11	speech-language pathologist to the jurisdiction of the licensing board, the
12	courts and the laws of the member state in which the client is located at the
13	time service is provided.
14	(i) Individuals not residing in a member state shall continue to be able to
15	apply for a member state's single-state license as provided under the laws of
16	each member state. However, the single-state license granted to these
17	individuals shall not be recognized as granting the privilege to practice
18	audiology or speech-language pathology in any other member state. Nothing
19	in this Compact shall affect the requirements established by a member state for
20	the issuance of a single-state license.
21	(j) Member states may charge a fee for granting a compact privilege.

1	(k) Member states must comply with the bylaws and rules and regulations
2	of the Commission.
3	§ 4504. COMPACT PRIVILEGE
4	(a) To exercise the compact privilege under the terms and provisions of the
5	Compact, the audiologist or speech-language pathologist shall:
6	(1) hold an active license in the home state;
7	(2) have no encumbrance on any state license;
8	(3) be eligible for a compact privilege in any member state in
9	accordance with section 4503 of this subchapter;
10	(4) have not had any adverse action against any license or compact
11	privilege within the previous two years from date of application;
12	(5) notify the Commission that the licensee is seeking the compact
13	privilege within a remote state or states;
14	(6) pay any applicable fees, including any state fee, for the compact
15	privilege; and
16	(7) report to the Commission adverse action taken by any nonmember
17	state within 30 days from the date the adverse action is taken.
18	(b) For the purposes of the compact privilege, an audiologist or speech-
19	language pathologist shall only hold one home state license at a time.
20	(c) Except as provided in section 4506 of this subchapter, if an audiologist
21	or speech-language pathologist changes primary state of residence by moving

1	between two member states, the audiologist or speech-language pathologist
2	must apply for licensure in the new home state, and the license issued by the
3	prior home state shall be deactivated in accordance with applicable rules
4	adopted by the Commission.
5	(d) The audiologist or speech-language pathologist may apply for licensure
6	in advance of a change in primary state of residence.
7	(e) A license shall not be issued by the new home state until the audiologist
8	or speech-language pathologist provides satisfactory evidence of a change in
9	primary state of residence to the new home state and satisfies all applicable
10	requirements to obtain a license from the new home state.
11	(f) If an audiologist or speech-language pathologist changes primary state
12	of residence by moving from a member state to a nonmember state, the license
13	issued by the prior home state shall convert to a single-state license, valid only
14	in the former home state.
15	(g) The compact privilege is valid until the expiration date of the home
16	state license. The licensee must comply with the requirements of subsection
17	4504(a) of this subchapter to maintain the compact privilege in the remote
18	state.
19	(h) A licensee providing audiology or speech-language pathology services
20	in a remote state under the compact privilege shall function within the laws and
21	regulations of the remote state.

1	(1) A licensee providing audiology or speech-language pathology services
2	in a remote state is subject to that state's regulatory authority. A remote state
3	may, in accordance with due process and that state's laws, remove a licensee's
4	compact privilege in the remote state for a specific period of time, impose
5	fines, and/or take any other necessary actions to protect the health and safety of
6	its citizens.
7	(j) If a home state license is encumbered, the licensee shall lose the
8	compact privilege in any remote state until the following occur:
9	(1) The home state license is no longer encumbered.
10	(2) Two years have elapsed from the date of the adverse action.
11	(k) Once an encumbered license in the home state is restored to good
12	standing, the licensee must meet the requirements of subsection 4504(a) of this
13	subchapter to obtain a compact privilege in any remote state.
14	(l) Once the requirements of subsection 4504(j) of this subchapter have
15	been met, the licensee must meet the requirements in subsection 4504(a) to
16	obtain a compact privilege in a remote state.
17	§ 4505. COMPACT PRIVILEGE TO PRACTICE TELEHEALTH
18	Member states shall recognize the right of an audiologist or speech-
19	language pathologist, licensed by a home state in accordance with section 4503
20	of this subchapter and under rules promulgated by the Commission, to practice
21	audiology or speech-language pathology in any member state via telehealth

1	under a privilege to practice as provided in the Compact and rules promulgated
2	by the Commission.
3	§ 4506. ACTIVE DUTY MILITARY PERSONNEL OR THEIR SPOUSES
4	Active duty military personnel, or their spouse, shall designate a home state
5	where the individual has a current license in good standing. The individual
6	may retain the home state designation during the period the service member is
7	on active duty. Subsequent to designating a home state, the individual shall
8	only change the individual's home state through application for licensure in the
9	new state.
10	§ 4507. ADVERSE ACTIONS
11	(a) In addition to the other powers conferred by state law, a remote state
12	shall have the authority, in accordance with existing state due process law, to:
13	(1) Take adverse action against an audiologist's or speech-language
14	pathologist's privilege to practice within that member state.
15	(2) Issue subpoenas for both hearings and investigations that require the
16	attendance and testimony of witnesses as well as the production of evidence.
17	Subpoenas issued by a licensing board in a member state for the attendance
18	and testimony of witnesses or the production of evidence from another member
19	state shall be enforced in the latter state by any court of competent jurisdiction,
20	according to the practice and procedure of that court applicable to subpoenas
21	issued in proceedings pending before it. The issuing authority shall pay any

1	witness fees, travel expenses, mileage and other fees required by the service
2	statutes of the state in which the witnesses or evidence are located.
3	(3) Only the home state shall have the power to take adverse action
4	against a audiologist's or speech-language pathologist's license issued by the
5	home state.
6	(b) For purposes of taking adverse action, the home state shall give the
7	same priority and effect to reported conduct received from a member state as it
8	would if the conduct had occurred within the home state. In so doing, the
9	home state shall apply its own state laws to determine appropriate action.
10	(c) The home state shall complete any pending investigations of an
11	audiologist or speech-language pathologist who changes primary state of
12	residence during the course of the investigations. The home state shall also
13	have the authority to take appropriate action or actions and shall promptly
14	report the conclusions of the investigations to the administrator of the data
15	system. The administrator of the coordinated licensure information system
16	shall promptly notify the new home state of any adverse actions.
17	(d) If otherwise permitted by state law, the member state may recover from
18	the affected audiologist or speech-language pathologist the costs of
19	investigations and disposition of cases resulting from any adverse action taken
20	against that audiologist or speech-language pathologist.

1	(e) The member state may take adverse action based on the factual findings
2	of the remote state, provided that the member state follows the member state's
3	own procedures for taking the adverse action.
4	(f) Joint Investigations.
5	(1) In addition to the authority granted to a member state by its
6	respective audiology or speech-language pathology practice act or other
7	applicable state law, any member state may participate with other member
8	states in joint investigations of licensees.
9	(2) Member states shall share any investigative, litigation, or compliance
10	materials in furtherance of any joint or individual investigation initiated under
11	the Compact.
12	(g) If adverse action is taken by the home state against an audiologist's or
13	speech-language pathologist's license, the audiologist's or speech-language
14	pathologist's privilege to practice in all other member states shall be
15	deactivated until all encumbrances have been removed from the state license.
16	All home state disciplinary orders that impose adverse action against an
17	audiologist's or speech-language pathologist's license shall include a statement
18	that the audiologist's or speech-language pathologist's privilege to practice is
19	deactivated in all member states during the pendency of the order.

2	administrator of the data system. The administrator of the data system shall
3	promptly notify the home state of any adverse actions by remote states.
4	(i) Nothing in this Compact shall override a member state's decision that
5	participation in an alternative program may be used in lieu of adverse action.
6	§ 4508. ESTABLISHMENT OF THE AUDIOLOGY AND SPEECH-
7	LANGUAGE PATHOLOGY COMPACT COMMISSION
8	(a) The Compact member states hereby create and establish a joint public
9	agency known as the Audiology and Speech-Language Pathology Compact
10	Commission:
11	(1) The Commission is an instrumentality of the Compact states.
12	(2) Venue is proper and judicial proceedings by or against the
13	Commission shall be brought solely and exclusively in a court of competent
14	jurisdiction where the principal office of the Commission is located. The
15	Commission may waive venue and jurisdictional defenses to the extent it
16	adopts or consents to participate in alternative dispute resolution proceedings.
17	(3) Nothing in this Compact shall be construed to be a waiver of
18	sovereign immunity.
19	(b) Membership, Voting, and Meetings.
20	(1) Each member state shall have two delegates selected by that member
21	state's licensing board. The delegates shall be current members of the

(h) If a member state takes adverse action, it shall promptly notify the

1	licensing board. One shall be an audiologist and one shall be a speech-
2	language pathologist.
3	(2) An additional five delegates, who are either a public member or
4	board administrator from a state licensing board, shall be chosen by the
5	Executive Committee from a pool of nominees provided by the Commission at
6	Large.
7	(3) Any delegate may be removed or suspended from office as provided
8	by the law of the state from which the delegate is appointed.
9	(4) The member state board shall fill any vacancy occurring on the
10	Commission within 90 days.
11	(5) Each delegate shall be entitled to one vote with regard to the
12	promulgation of rules and creation of bylaws and shall otherwise have an
13	opportunity to participate in the business and affairs of the Commission.
14	(6) A delegate shall vote in person or by other means as provided in the
15	bylaws. The bylaws may provide for delegates' participation in meetings by
16	telephone or other means of communication.
17	(7) The Commission shall meet at least once during each calendar year.
18	Additional meetings shall be held as set forth in the bylaws.
19	(c) The Commission shall have the following powers and duties:
20	(1) Establish the fiscal year of the Commission.
21	(2) Establish bylaws.

1	(3) Establish a Code of Ethics.
2	(4) Maintain its financial records in accordance with the bylaws.
3	(5) Meet and take actions as are consistent with the provisions of this
4	Compact and the bylaws.
5	(6) Promulgate uniform rules to facilitate and coordinate
6	implementation and administration of this Compact. The rules shall have the
7	force and effect of law and shall be binding in all member states.
8	(7) Bring and prosecute legal proceedings or actions in the name of the
9	Commission, provided that the standing of any state audiology or speech-
10	language pathology licensing board to sue or be sued under applicable law
11	shall not be affected.
12	(8) Purchase and maintain insurance and bonds.
13	(9) Borrow, accept, or contract for services of personnel, including, but
14	not limited to, employees of a member state.
15	(10) Hire employees, elect or appoint officers, fix compensation, define
16	duties, grant individuals appropriate authority to carry out the purposes of the
17	Compact, and to establish the Commission's personnel policies and programs
18	relating to conflicts of interest, qualifications of personnel, and other related
19	personnel matters.
20	(11) Accept any and all appropriate donations and grants of money,
21	equipment, supplies, materials and services, and to receive, utilize, and dispose

1	of the same, provided that at all times the Commission shall avoid any
2	appearance of impropriety or conflict of interest or both.
3	(12) Lease, purchase, accept appropriate gifts or donations of, or
4	otherwise to own, hold, improve or use, any property, real, personal or mixed
5	provided that at all times the Commission shall avoid any appearance of
6	impropriety.
7	(13) Sell, convey, mortgage, pledge, lease, exchange, abandon, or
8	otherwise dispose of any property real, personal, or mixed.
9	(14) Establish a budget and make expenditures.
10	(15) Borrow money.
11	(16) Appoint committees, including standing committees composed of
12	members and other interested persons as may be designated in this Compact
13	and the bylaws.
14	(17) Provide and receive information from, and cooperate with, law
15	enforcement agencies.
16	(18) Establish and elect an Executive Committee.
17	(19) Perform other functions as may be necessary or appropriate to
18	achieve the purposes of this Compact consistent with the state regulation of
19	audiology and speech-language pathology licensure and practice.

1	(d) The Executive Committee. The Executive Committee shall have the
2	power to act on behalf of the Commission according to the terms of this
3	Compact.
4	(1) The Executive Committee shall be composed of 10 members:
5	(A) seven voting members who are elected by the Commission from
6	the current membership of the Commission;
7	(B) two ex-officios, consisting of one nonvoting member from a
8	recognized national audiology professional association and one nonvoting
9	member from a recognized national speech-language pathology association;
10	<u>and</u>
11	(C) one ex-officio, nonvoting member from the recognized
12	membership organization of the audiology and speech-language pathology
13	licensing boards.
14	(e) The ex-officio members shall be selected by their respective
15	organizations.
16	(1) The Commission may remove any member of the Executive
17	Committee as provided in bylaws.
18	(2) The Executive Committee shall meet at least annually.
19	(3) The Executive Committee shall have the following duties and
20	responsibilities:

1	(A) recommend to the entire Commission changes to the rules or
2	bylaws, changes to this Compact legislation, fees paid by Compact member
3	states such as annual dues and any commission Compact fee charged to
4	licensees for the compact privilege;
5	(B) ensure Compact administration services are appropriately
6	provided, contractual or otherwise;
7	(C) prepare and recommend the budget;
8	(D) maintain financial records on behalf of the Commission;
9	(E) monitor Compact compliance of member states and provide
10	compliance reports to the Commission;
11	(F) establish additional committees as necessary; and
12	(G) other duties as provided in rules or bylaws.
13	(4) Meetings of the Commission. All meetings shall be open to the
14	public, and public notice of meetings shall be given in the same manner as
15	required under the rulemaking provisions in section 4510 of this subchapter.
16	(5) The Commission or the Executive Committee or other committees of
17	the Commission may convene in a closed, nonpublic meeting if the
18	Commission or Executive Committee or other committees of the Commission
19	must discuss:
20	(A) noncompliance of a member state with its obligations under the
21	Compact;

1	(B) the employment, compensation, discipline or other matters,
2	practices or procedures related to specific employees or other matters related to
3	the Commission's internal personnel practices and procedures;
4	(C) current, threatened, or reasonably anticipated litigation;
5	(D) negotiation of contracts for the purchase, lease, or sale of goods,
6	services, or real estate;
7	(E) accusing any person of a crime or formally censuring any person;
8	(F) disclosure of trade secrets or commercial or financial information
9	that is privileged or confidential;
10	(G) disclosure of information of a personal nature where disclosure
11	would constitute a clearly unwarranted invasion of personal privacy;
12	(H) disclosure of investigative records compiled for law enforcement
13	<u>purposes;</u>
14	(I) disclosure of information related to any investigative reports
15	prepared by or on behalf of or for use of the Commission or other committee
16	charged with responsibility of investigation or determination of compliance
17	issues pursuant to the Compact; or
18	(J) matters specifically exempted from disclosure by federal or
19	member state statute.

1	(6) If a meeting, or portion of a meeting, is closed pursuant to this
2	provision, the Commission's legal counsel or designee shall certify that the
3	meeting may be closed and shall reference each relevant exempting provision.
4	(7) The Commission shall keep minutes that fully and clearly describe
5	all matters discussed in a meeting and shall provide a full and accurate
6	summary of actions taken, and the reasons therefore, including a description of
7	the views expressed. All documents considered in connection with an action
8	shall be identified in minutes. All minutes and documents of a closed meeting
9	shall remain under seal, subject to release by a majority vote of the
10	Commission or order of a court of competent jurisdiction.
11	(8) Financing of the Commission.
12	(A) The Commission shall pay, or provide for the payment of, the
13	reasonable expenses of its establishment, organization, and ongoing activities.
14	(B) The Commission may accept any and all appropriate revenue
15	sources, donations, and grants of money, equipment, supplies, materials, and
16	services.
17	(C) The Commission may levy on and collect an annual assessment
18	from each member state or impose fees on other parties to cover the cost of the
19	operations and activities of the Commission and its staff, which must be in a
20	total amount sufficient to cover its annual budget as approved each year for
21	which revenue is not provided by other sources. The aggregate annual

1	assessment amount shall be allocated based upon a formula to be determined
2	by the Commission, which shall promulgate a rule binding upon all member
3	states.
4	(9) The Commission shall not incur obligations of any kind prior to
5	securing the funds adequate to meet the same nor shall the Commission pledge
6	the credit of any of the member states, except by and with the authority of the
7	member state.
8	(10) The Commission shall keep accurate accounts of all receipts and
9	disbursements. The receipts and disbursements of the Commission shall be
10	subject to the audit and accounting procedures established under its bylaws.
11	However, all receipts and disbursements of funds handled by the Commission
12	shall be audited yearly by a certified or licensed public accountant, and the
13	report of the audit shall be included in and become part of the annual report of
14	the Commission.
15	(f) Qualified Immunity, Defense, and Indemnification.
16	(1) The members, officers, executive director, employees and
17	representatives of the Commission shall be immune from suit and liability,
18	either personally or in their official capacity, for any claim for damage to or
19	loss of property or personal injury or other civil liability caused by or arising
20	out of any actual or alleged act, error or omission that occurred, or that the

person against whom the claim is made had a reasonable basis for believing

21

1	occurred within the scope of Commission employment, duties, or
2	responsibilities, provided that nothing in this paragraph shall be construed to
3	protect any person from suit or liability, or both, for any damage, loss, injury,
4	or liability caused by the intentional or willful or wanton misconduct of that
5	person.
6	(2) The Commission shall defend any member, officer, executive
7	director, employee, or representative of the Commission in any civil action
8	seeking to impose liability arising out of any actual or alleged act, error, or
9	omission that occurred within the scope of Commission employment, duties, or
10	responsibilities or that the person against whom the claim is made had a
11	reasonable basis for believing occurred within the scope of Commission
12	employment, duties, or responsibilities, provided that nothing herein shall be
13	construed to prohibit that person from retaining his or her own counsel, and
14	provided further, that the actual or alleged act, error, or omission did not result
15	from that person's intentional, willful, or wanton misconduct.
16	(3) The Commission shall indemnify and hold harmless any member,
17	officer, executive director, employee, or representative of the Commission for
18	the amount of any settlement or judgment obtained against that person arising
19	out of any actual or alleged act, error, or omission that occurred within the
20	scope of Commission employment, duties, or responsibilities or that person
21	had a reasonable basis for believing occurred within the scope of Commission

1	employment, duties, or responsibilities, provided that the actual or alleged act,
2	error, or omission did not result from the intentional, willful, or wanton
3	misconduct of that person.
4	§ 4509. DATA SYSTEM
5	(a) The Commission shall provide for the development, maintenance, and
6	utilization of a coordinated database and reporting system containing licensure
7	adverse action, and investigative information on all licensed individuals in
8	member states.
9	(b) Notwithstanding any other provision of state law to the contrary, a
10	member state shall submit a uniform data set to the data system on all
11	individuals to whom this Compact is applicable as required by the rules of the
12	Commission, including:
13	(1) identifying information;
14	(2) licensure data;
15	(3) adverse actions against a license or compact privilege;
16	(4) nonconfidential information related to alternative program
17	participation;
18	(5) any denial of application for licensure, and the reason or reasons for
19	denial; and
20	(6) other information that may facilitate the administration of this
21	Compact as determined by the rules of the Commission.

1	(c) Investigative information pertaining to a licensee in any member state
2	shall only be available to other member states.
3	(d) The Commission shall promptly notify all member states of any adverse
4	action taken against a licensee or an individual applying for a license. Adverse
5	action information pertaining to a licensee in any member state shall be
6	available to any other member state.
7	(e) Member states contributing information to the data system may
8	designate information that may not be shared with the public without the
9	express permission of the contributing state.
10	(f) Any information submitted to the data system that is subsequently
11	required to be expunged by the laws of the member state contributing the
12	information shall be removed from the data system.
13	§ 4510. RULEMAKING
14	(a) The Commission shall exercise its rulemaking powers pursuant to the
15	criteria set forth in this section and the rules adopted thereunder. Rules and
16	amendments shall become binding as of the date specified in each rule or
17	amendment.
18	(b) If a majority of the legislatures of the member states rejects a rule, by
19	enactment of a statute or resolution in the same manner used to adopt the
20	Compact within four years of the date of adoption of the rule, the rule shall
21	have no further force and effect in any member state.

1	(c) Rules or amendments to the rules shall be adopted at a regular or special
2	meeting of the Commission.
3	(d) Prior to promulgation and adoption of a final rule or rules by the
4	Commission, and at least 30 days in advance of the meeting at which the rule
5	shall be considered and voted upon, the Commission shall file a Notice of
6	Proposed Rulemaking:
7	(1) on the website of the Commission or other publicly accessible
8	platform; and
9	(2) on the website of each member state audiology or speech-language
10	pathology licensing board or other publicly accessible platform or the
11	publication in which each state would otherwise publish proposed rules.
12	(e) The Notice of Proposed Rulemaking shall include:
13	(1) the proposed time, date, and location of the meeting in which the
14	rule shall be considered and voted upon;
15	(2) the text of the proposed rule or amendment and the reason for the
16	proposed rule;
17	(3) a request for comments on the proposed rule from any interested
18	person; and
19	(4) the manner in which interested persons may submit notice to the
20	Commission of their intention to attend the public hearing and any written
21	comments.

1	(f) Prior to the adoption of a proposed rule, the Commission shall allow
2	persons to submit written data, facts, opinions, and arguments, which shall be
3	made available to the public.
4	(g) The Commission shall grant an opportunity for a public hearing before
5	it adopts a rule or amendment if a hearing is requested by:
6	(1) at least 25 persons;
7	(2) a state or federal governmental subdivision or agency; or
8	(3) an association having at least 25 members.
9	(h) If a hearing is held on the proposed rule or amendment, the
10	Commission shall publish the place, time, and date of the scheduled public
11	hearing. If the hearing is held via electronic means, the Commission shall
12	publish the mechanism for access to the electronic hearing.
13	(1) All persons wishing to be heard at the hearing shall notify the
14	executive director of the Commission or other designated member in writing of
15	their desire to appear and testify at the hearing not less than five business days
16	before the scheduled date of the hearing.
17	(2) Hearings shall be conducted in a manner providing each person who
18	wishes to comment a fair and reasonable opportunity to comment orally or in
19	writing.
20	(3) All hearings shall be recorded. A copy of the recording shall be
21	made available on request.

1	(4) Nothing in this section shall be construed as requiring a separate
2	hearing on each rule. Rules may be grouped for the convenience of the
3	Commission at hearings required by this section.
4	(i) Following the scheduled hearing date, or by the close of business on the
5	scheduled hearing date if the hearing was not held, the Commission shall
6	consider all written and oral comments received.
7	(j) If no written notice of intent to attend the public hearing by interested
8	parties is received, the Commission may proceed with promulgation of the
9	proposed rule without a public hearing.
10	(k) The Commission shall, by majority vote of all members, take final
11	action on the proposed rule and shall determine the effective date of the rule, if
12	any, based on the rulemaking record and the full text of the rule.
13	(l) Upon determination that an emergency exists, the Commission may
14	consider and adopt an emergency rule without prior notice, opportunity for
15	comment, or hearing, provided that the usual rulemaking procedures provided
16	in the Compact and in this section shall be retroactively applied to the rule as
17	soon as reasonably possible, in no event later than 90 days after the effective
18	date of the rule. For the purposes of this provision, an emergency rule is one
19	that must be adopted immediately in order to:
20	(1) meet an imminent threat to public health, safety, or welfare;
21	(2) prevent a loss of Commission or member state funds; or

1	(3) meet a deadline for the promulgation of an administrative rule that is
2	established by federal law or rule.
3	(m) The Commission or an authorized committee of the Commission may
4	direct revisions to a previously adopted rule or amendment for purposes of
5	correcting typographical errors, errors in format, errors in consistency, or
6	grammatical errors. Public notice of any revisions shall be posted on the
7	website of the Commission. The revision shall be subject to challenge by any
8	person for a period of 30 days after posting. The revision may be challenged
9	only on grounds that the revision results in a material change to a rule. A
10	challenge shall be made in writing and delivered to the chair of the
11	Commission prior to the end of the notice period. If no challenge is made, the
12	revision shall take effect without further action. If the revision is challenged,
13	the revision may not take effect without the approval of the Commission.
14	§ 4511. OVERSIGHT, DISPUTE RESOLUTION, AND ENFORCEMENT
15	(a) Dispute Resolution.
16	(1) Upon request by a member state, the Commission shall attempt to
17	resolve disputes related to the Compact that arise among member states and
18	between member and nonmember states.
19	(2) The Commission shall promulgate a rule providing for both
20	mediation and binding dispute resolution for disputes as appropriate.
21	(b) Enforcement.

1	(1) The Commission, in the reasonable exercise of its discretion, shall
2	enforce the provisions and rules of this Compact.
3	(2) By majority vote, the Commission may initiate legal action in the
4	United States District Court for the District of Columbia or the federal district
5	where the Commission has its principal offices against a member state in
6	default to enforce compliance with the provisions of the Compact and its
7	promulgated rules and bylaws. The relief sought may include both injunctive
8	relief and damages. In the event judicial enforcement is necessary, the
9	prevailing member shall be awarded all costs of litigation, including reasonable
10	attorney's fees.
11	(3) The remedies herein shall not be the exclusive remedies of the
12	Commission. The Commission may pursue any other remedies available under
13	federal or state law.
14	§ 4512. DATE OF IMPLEMENTATION OF THE INTERSTATE
15	COMMISSION FOR AUDIOLOGY AND SPEECH-LANGUAGE
16	PATHOLOGY PRACTICE AND ASSOCIATED RULES,
17	WITHDRAWAL, AND AMENDMENT
18	(a) The Compact shall come into effect on the date on which the Compact
19	statute is enacted into law in the 10th member state. The provisions, which
20	become effective at that time, shall be limited to the powers granted to the
21	Commission relating to assembly and the promulgation of rules. Thereafter,

1	the Commission shall meet and exercise rulemaking powers necessary to the
2	implementation and administration of the Compact.
3	(b) Any state that joins the Compact subsequent to the Commission's initial
4	adoption of the rules shall be subject to the rules as they exist on the date on
5	which the Compact becomes law in that state. Any rule that has been
6	previously adopted by the Commission shall have the full force and effect of
7	law on the day the Compact becomes law in that state.
8	(c) Any member state may withdraw from this Compact by enacting a
9	statute repealing the same.
10	(1) A member state's withdrawal shall not take effect until six months
11	after enactment of the repealing statute.
12	(2) Withdrawal shall not affect the continuing requirement of the
13	withdrawing state's audiology or speech-language pathology licensing board to
14	comply with the investigative and adverse action reporting requirements of this
15	act prior to the effective date of withdrawal.
16	(d) Nothing contained in this Compact shall be construed to invalidate or
17	prevent any audiology or speech-language pathology licensure agreement or
18	other cooperative arrangement between a member state and a nonmember state
19	that does not conflict with the provisions of this Compact.

1	(e) This Compact may be amended by the member states. No amendment
2	to this Compact shall become effective and binding upon any member state
3	until it is enacted into the laws of all member states.
4	§ 4513. CONSTRUCTION AND SEVERABILITY
5	This Compact shall be liberally construed so as to effectuate the purposes
6	thereof. The provisions of this Compact shall be severable and if any phrase,
7	clause, sentence or provision of this Compact is declared to be contrary to the
8	constitution of any member state or of the United States or the applicability
9	thereof to any government, agency, person or circumstance is held invalid, the
10	validity of the remainder of this Compact and the applicability thereof to any
11	government, agency, person, or circumstance shall not be affected thereby. If
12	this Compact shall be held contrary to the constitution of any member state, the
13	Compact shall remain in full force and effect as to the remaining member
14	states and in full force and effect as to the member state affected as to all
15	severable matters.
16	§ 4514. BINDING EFFECT OF COMPACT AND OTHER LAWS
17	(a) Nothing herein prevents the enforcement of any other law of a member
18	state that is not inconsistent with the Compact.
19	(b) All laws in a member state in conflict with the Compact are superseded
20	to the extent of the conflict.

1	(c) All lawful actions of the Commission, including all rules and bylaws
2	promulgated by the Commission, are binding upon the member states.
3	(d) All agreements between the Commission and the member states are
4	binding in accordance with their terms.
5	(e) In the event any provision of the Compact exceeds the constitutional
6	limits imposed on the legislature of any member state, the provision shall be
7	ineffective to the extent of the conflict with the constitutional provision in
8	question in that member state.
9	§ 4515. ADMINISTRATION OF THE COMPACT
10	(a) The Office of Professional Regulation shall have the power to:
11	(1) oversee the administration and enforcement of the Compact within
12	the State of Vermont;
13	(2) recover from the affected audiologist or speech-language pathologist
14	the costs of investigations and disposition of cases resulting from any adverse
15	action taken against that audiologist or speech-language pathologist; and
16	(3) conduct a background check, prior to issuing a multistate license
17	under the provisions of the Compact, that includes a fingerprint-based check of
18	State and federal criminal history databases, as authorized by 28 C.F.R.
19	<u>§ 20.33.</u>

1	(b) The Director of the Office of Professional Regulation shall designate
2	the two delegates of the Compact for the State of Vermont pursuant to section
3	4508(b) of this subchapter.
4	(c) The Office of Professional Regulation may:
5	(1) adopt rules necessary to implement and enforce the provisions of this
6	subchapter within the State of Vermont; and
7	(2) take disciplinary action against the practice privilege of an
8	audiologist or speech-language pathologist practicing within the State of
9	Vermont under the provisions of the Compact, which may include disciplinary
10	action based on disciplinary action taken against the audiologist's or speech-
11	language pathologist's license by another party state to the Compact.
12	(d) Nothing in this subchapter shall supersede or abridge State labor laws.

14	Subchapter 5. Multistate License; Audiology and Speech-Language Pathology
15	Interstate Compact
16	§ 3305. AUDIOLOGISTS; MULTISTATE LICENSE
17	(a) Vermont is a member state of the Audiology and Speech-Language
18	Pathology Interstate Compact. Applicants for a multistate license to practice
19	audiology shall be subject to the requirements prescribed under 26 V.S.A.
20	chapter 87, subchapter 2.

1	(b) Individuals with a multistate license issued by a member state of the
2	Audiology and Speech-Language Pathology Interstate Compact may practice
3	audiology in the State subject to the requirements of 26 V.S.A. chapter 87,
4	subchapter 2.
5	Sec. 4. EFFECTIVE DATE
6	This act shall take effect on July 1, 2023.
