15	(a) Except as authorized under section 1035 of this title, beginning
16	January 1, 2013, no person shall propagate, transplant, import, barter, sell, or
17	offer for sale one or more of the following plant species, including their
18	cultivars, and varieties in the state of Vermont:
19	(1) Japanese barberry (Berberis thunbergii);
20	(2) Common barberry (Berberis vulgaris);

1	(3) Norway maple (Acer platanoides);
2	(4) Amur maple (Acer ginnala);
3	(5) Winged euonymus (Euonymus alatus);
4	(6) European naiad (Najas minor);
5	(7) Yellow flag iris (Iris pseudacorus); and
6	(8) A plant identified by the secretary by rule under subsection (b) of
7	this section.
8	(b) The secretary may establish and maintain quarantines and adopt other
9	orders and rules pursuant to 3 V.S.A. chapter 25 concerning the planting,
10	exposing, sale, importation, cultivation, and transportation of all plants and
11	plant products, including invasive species, and regulated articles capable of
12	carrying plant pests of an injurious nature in any living stage within the state.

14	§ 1035. PERMITS
15	(a) No person may sell, offer for sale, barter, expose, move, transport,
16	deliver, ship, or offer for shipment into or within this state any plant pest or
17	biological control agent in any living stage without first obtaining either a
18	federal permit, where applicable, and a state permit from the secretary. A state
19	permit may only be issued after it has been determined by the secretary that the
20	plant pests or biological control agents are not injurious, are generally present
21	already, or are for scientific purposes subject to specified safeguards.

1	(b) The secretary may issue a permit for the propagation, transplantation, or
2	importation of a plant listed under subsection 1034(a) of this title if the plant
3	species is to be used for scientific or educational purposes. A permit issued
4	under this subsection shall include permit conditions to prevent the spread or
5	harmful effect of the permitted plant species.
