9	buyer, in writing, of the permit requirement.
10	§ 4423. DOCUMENTS PROVIDED BEFORE SALE
11	(a) Before the point of sale, a seller of prefabricated buildings shall provide
12	the buyer with a list of the drawings, plans, or certifications required in a
13	permit application. The Commissioner of Public Safety shall create this list,
14	which shall explain generally the required documents and their method of
15	preparation.
16	(b) At the point of sale, a seller of prefabricated buildings shall provide, if
17	available to him or her, the drawings, plans, and certifications listed on the
18	permit application document list. If any of these documents are not readily
19	available to the seller, the seller shall so inform the buyer, in writing and prior
