17	(a)(1) Notwithstanding any provision of law to the contrary, prior to		
18	January 1, 2016, health insurers may offer health insurance plans through or

4	(2) Health insurers may make Exchange plans available to an employer
5	described in subdivision (1) of this subsection if the employer:

9	(B) elects to provide coverage through the Vermont Health Benefit

3	(2) An employer of the size described in subdivision (1) of this
4	subsection may purchase coverage for its employees through the Vermont
