7	Statement of purpose of bill as introduced: This bill proposes to clarify that a
8	farm may accept food residuals for management but shall not be required to
9	obtain a solid waste management facility certification or a solid waste
10	commercial hauler permit for the purposes of managing or transporting food
11	residuals. In addition, the bill would provide that a solid waste management
12	entity that consists of only one town shall be required to hold only one
13	household hazardous waste collection event per year.

15	It is hereby enacted by the General Assembly of the State of Vermont:
16	Sec. 1. 10 V.S.A. § 6605k is amended to read:
17	§ 6605k. FOOD RESIDUALS; MANAGEMENT HIERARCHY
18	(a) It is the policy of the State that food residuals collected under the
19	requirements of this chapter shall be managed according to the following order
20	of priority uses:

1	(1) reduction of the amount generated at the source;
2	(2) diversion for food consumption by humans;
3	(3) diversion for agricultural use, including consumption by animals;
4	(4) composting, land application, and digestion; and
5	(5) energy recovery.
6	(b) A person who produces more than an amount identified under
7	subsection (c) of this section in food residuals and is located within 20 miles of
8	a certified organics management facility or a farm that has available capacity
9	and that is willing to accept the food residuals shall:
10	(1) Separate separate food residuals from other solid waste, provided
11	that a de minimis amount of food residuals may be disposed of in solid waste
12	when a person has established a program to separate food residuals and the
13	program includes a component for the education of program users regarding
14	the need to separate food residuals; and
15	(2) Arrange <u>arrange</u> for the transfer of food residuals to a location that
16	manages food residuals in a manner consistent with the priority uses
17	established under subdivisions (a)(2)-(5) of this section or shall manage food
18	residuals on site.

20	(d) As used in this section, "farm" means a parcel or parcels of land
21	owned, leased, or managed by a person and devoted primarily to farming as

1	that term is defined in section 6001 of this title. A farm accepting food
2	residuals under this section shall not be required to obtain a solid waste facility
3	certification under section 6605 of this title or a commercial hauler permit
4	under section 6607a of this title for the purposes of managing food residuals.

6	(c)(1) On or before July 1, 1988, each municipality, as defined in
7	subdivision 4303(12) of this title, shall join or participate in a solid waste

10	effort for purposes of solid waste implementation planning, as implementation
11	planning is defined in 10 V.S.A. § 6602.
