#### S.158

An act relating to marriage records

It is hereby enacted by the General Assembly of the State of Vermont:

Sec. 1. 18 V.S.A. § 5131(a)(2) is amended to read:

(2) The department shall prescribe forms that allow each party to a

marriage to be designated "bride," "groom," or "spouse," as he or she chooses, and the application shall be in substantially the following form:
