9 plastic containers for which a producer annually demonstrates to the
10 department by December 31st of a given year that the achievement of
11 postconsumer recycled content requirements in the container material
12 is not technically feasible in order to comply with health or safety
13 requirements of federal law, including the federal laws specified in
14 subsection (7)(b)(v) of this section. A producer must continue to
15 register and report consistent with the requirements of this chapter
16 for covered products temporarily excluded from minimum postconsumer
17 recycled content requirements under this subsection.

EFFECT: Requires the Department of Ecology to temporarily exclude from minimum postconsumer recycled content requirements any types of plastic containers for which a producer annually demonstrates it is not technically feasible to meet minimum postconsumer recycled content requirements as a result of health or safety requirements in federal law. Authorizes the Department of Ecology to consider the manufacture date of a covered product or covered product container for compliance purposes. Clarifies that restrictions on void-filling packaging products apply only to expanded polystyrene void-filling packaging products. Adds consumer electronics and personal care products representatives to the stakeholder advisory committee. Makes technical corrections.
