- Information that is otherwise disclosable under this chapter cannot be disclosed for a future voter until the person reaches 18 years of age, or until the person is eligible to participate in the next presidential primary, primary, or election. This information is exempt from public inspection and copying under chapter 42.56 RCW.

- 20 (1) A person may sign up to register to vote if he or she is 21 sixteen or seventeen years of age, as part of the future voter 22 program.
- (2) A person who signs up to register to vote may not vote until reaching eighteen years of age unless the person is seventeen years of age at the primary election or presidential primary election and will be eighteen years of age by the general election.
- 27 (3) A person who signs up to register to vote may not be added to 28 the statewide voter registration ((database)) list of voters until 29 such time as he or she will be eligible to vote in the next election.

Sec. 4. RCW 29A.08.174 and 2020 c 208 s 17 are each amended to read as follows:

- (1) A person who has attained sixteen years of age and has a valid Washington state driver's license or identicard may sign up to register to vote as part of the future voter program, by submitting a voter registration application electronically on the secretary of state($(\frac{1}{5})$) website.
- (2) The applicant must attest to the truth of the information provided on the application by affirmatively accepting the information as true.
 - (3) If signing up to register electronically, the applicant must affirmatively assent to the use of his or her driver's license or identicard signature for voter registration purposes.
 - (4) The applicant must affirmatively acknowledge that he or she will not vote in a special or general election until his or her eighteenth birthday, and will only vote in a primary election or presidential primary election if he or she will be eighteen years of age by the general election.
- (5) For each electronic registration application, the secretary of state must obtain a digital copy of the applicant's driver's license or identicard signature from the department of licensing.
- 22 (6) The secretary of state may employ additional security 23 measures to ensure the accuracy and integrity of voter 24 preregistration applications submitted electronically.
- **Sec. 5.** RCW 29A.08.330 and 2020 c 208 s 5 are each amended to 26 read as follows:
 - (1) The secretary of state shall prescribe the method of voter registration for each designated agency. The agency shall use either the state voter registration by mail form with a separate declination form for the applicant to indicate that he or she declines to register at this time, or the agency may use a separate form approved for use by the secretary of state.
 - (2) The person providing service at the agency shall offer voter registration services to every client whenever he or she applies for service or assistance and with each renewal, recertification, or change of address. The person providing service shall give the applicant the same level of assistance with the voter registration application as is offered to fill out the agency's forms and

 - If the applicant answers in the affirmative to both questions, the agent shall then provide the applicant with a voter registration form and instructions and shall record that the applicant has requested to sign up to vote, register to vote, or update a voter registration. If the applicant answers in the negative to either question, the agent shall not provide the applicant with a voter registration application.
 - (4) If an agency uses a computerized application process, it may, in consultation with the secretary of state, develop methods to capture simultaneously the information required for voter registration during a person's computerized application process.
 - (5) Each designated agency shall transmit the applications to the secretary of state or appropriate county auditor within three business days and must be received by the election official by the required voter registration deadline.
 - (6) ((Information that is otherwise disclosable under this chapter cannot be disclosed on the future voter until the person reaches eighteen years of age, except for the purpose of processing and delivering ballots.)) Disclosure of information on individuals under the age of 18 is subject to section 1 of this act.

- (2) Disclosure of information on individuals under the age of 18 is subject to section 1 of this act.
- (3) (a) Subject to the restrictions of RCW 29A.08.710 and 40.24.060, and (b) of this subsection, precinct lists and current lists of registered voters are public records and must be made available for public inspection and copying under such reasonable rules and regulations as the county auditor or secretary of state may prescribe. The county auditor or secretary of state shall promptly furnish current lists of registered voters in his or her possession, actual reproduction cost, to any person requesting information. The secretary of state shall provide a duplicate copy of the master statewide computer file or electronic data file of registered voters to the consolidated technology services agency for purposes of creating the jury source list without cost. The information contained in a voter registration application is exempt from inclusion until the applicant reaches age eighteen. ((Information that is otherwise disclosable under this chapter cannot be disclosed on the future voter until the person reaches eighteen years of age, except for the purpose of processing and delivering ballots.)) - (6) Investigative records compiled by an employing agency in 5 6 connection with an investigation of a possible unfair practice under chapter 49.60 RCW or of a possible violation of other federal, state, 7 or local laws or an employing agency's internal policies prohibiting 8 discrimination or harassment in employment. Records are exempt in 9 their entirety while the investigation is active and ongoing. EFFECT: Specifies that information about a future voter may be disclosed when they are eligible to vote in the next presidential primary, primary, or election, rather than "a" primary or election. Removes language exempting "persons voting in primaries pursuant to" the statutory definition of "elector" from the crime of illegal voter registration, which currently does not apply to 16- and 17-year-olds who register to vote under the future voter program.
