Part II: Narrative Explanation

II. A - Brief Description Of What The Measure Does That Has Fiscal Impact

Significant provisions of the bill and any related workload or policy assumptions that have revenue or expenditure impact on the responding agency by section number.

Section 1 - Amends RCW 43.10.230. Changes purpose with respect to granting concurrent authority with the Attorney General and county prosecutors to cover incidences of deadly force by officers.

Section 2 - Amends RCW 43.10.232. Allows the Attorney General's Office (AGO) concurrent authority to investigate, initiate and conduct prosecutions of crimes involving the use of deadly force by police officers. Additionally allows prosecution of related offenses and defendants. The AGO is responsible for its expert witness fees and other costs of prosecution.

Section 3 - Amends RCW 43.10.234. Considerations court makes when designating prosecuting authority where an information or indictment is filed by both the AGO and the Prosecuting Attorney. Presumption that a county Prosecuting Attorney has an inherent conflict of interest in a matter investigated by the Office of Independent Investigations (OII). Presumption that the Attorney General has an inherent conflict of interest in a matter involving a state peace officer or state employee.

Section 4 - New section. Legislative findings.

Section 5 - New section. Establishment of the Office of Independent Prosecutions (OIP) within the AGO.

Section 6 - New section. Sets out authority and role of OIP and has the Attorney General appoint an Independent Counsel to lead unit.

Section 7 - New section. Creates OIP advisory board.

Section 8 - New section. Minimum criteria for Independent Counsel and term limit.

Section 9 - New section. Sets out powers of Independent Counsel.

Section 10 - New section. Personnel who Independent Counsel can contract with or employ.

Section 11 - New section. Independent Counsel may appoint Assistant Attorneys General (AAG) or Special Assistant Attorneys General (SAAG) to carry out certain functions.

Section 12 - New section. Nothing prevents law students from working as volunteer or paid interns in OIP.

Section 13 - New Section. Applies the Public Records Act (PRA), RCW 42.56, and provides rules for disclosure of OIP records.

Section 14 - New section. Provides that no action may be instituted against independent counsel for performing duties in good faith.

Section 15 - New section. Definitions in RCW 43.102.010 apply to Sections 4 through 14 of this act.

Section 16 - Amends RCW 36.27.020. Sets out procedures for a court to transfer case to independent unit when prosecutor has conflict of interest.

Section 17 - Amends RCW 36.27.030. Standard for court to order Independent Counsel to take over prosecution.

Section 18 - New section. Adds to chapter 36.27 RCW. If prosecutor declines to file it must refer case to the OIP.

Section 19 - Amends RCW 43.102.080. Requires an OII investigation to be sent to the county prosecuting attorney with jurisdiction and the OIP.

Section 20 - Amends RCW 41.80.400. Excludes Independent Counsel from collective bargaining unit.

Section 21 - Amends RCW 10.114.011. Investigatory reports are handled in accordance with RCW 43.102.080.

Section 22 - New section. Severability clause.

Section 23 - New section. If funding is not provided by June 30, 2023, the act is void.

Section 24 - New section. Sections 4 through 15 are added to chapter 43.10 RCW.

Section 25 - New section. Section 2, 3, 16, 17, 18, and 19 are effective July 1, 2024.

GF-S Account 001-1: The newly created Attorney General's Office Independent Prosecutions (OIP) activities would be funded with General Fund-State dollars. No cash receipt impact. There is no client agency to bill for legal services.

Attorney General's Office (AGO) Agency Assumptions:

Legal services associated with the enactment of this bill will begin on July 1, 2024 (FY 2025)

Location of staffing is assumed to be in a non-King County office building.

Total workload impact in this request includes standard assumption costs for goods & services, travel, and capital outlays for all FTE identified.

Agency administration support FTE are included in the tables. The Management Analyst 5 FTE (MA), is used as a representative classification. An example ratio is for every 1.0 Assistant Attorney General FTE (AAG), the AGO includes 0.5 Paralegal 1 FTE (PL1) and 0.4 MA.

Agency Administrative staff included in this request:

One Information Technology (IT) Support Technician 2 for support in wiring and networking, local area network (LAN) management, and ongoing technical support.

One IT Security-Senior Specialist to conduct and maintain data security of business systems used by this office, manage ongoing IT risk assessments, and ensure compliance with applicable laws, regulations and statewide security policies related to data sharing with local law enforcement.

Three MA to support for ongoing timekeeping, payroll, budgeting and projection of expenditures, accounting transactions and report generation.

A Contracts Specialist 2 (CS2) to help draft expert witness and other litigation related contracts, interpreter and potential Special Assistant Attorneys General (SAAG) contracts. This includes but is not limited to, contract preparation assistance, review, tracking, data entry, reporting and payment review.

One Policy Analyst (PA) Administrative support to create, convene, and maintain the Office of Independent Prosecution Advisory Board (OIPAB) in the performance of the duties outline in Section 7. Provide assistance and support for regular meetings. Administrative support to author and submit to the Legislature a report on the new Office of Independent Investigations (OII) by November 1, 2026.

1. Assumptions for a new AGO Office of Independent Prosecution Division (OIP):

Sections 5 and 8 of this bill would require the creation of a new division in the AGO called the OIP and headed by an “Independent Counsel” (IC) appointed by the Attorney General (AG). This note presumes the IC would be compensated at or near the compensation for a senior AAG - division chief. OIP would review cases of police use of deadly force for potential criminal charges. OIP would also handle a large volume of complex, controversial, high-profile, expensive, time-consuming cases. There is limited data available on the number of incidents per year where police use deadly force in Washington State because that is not information that is tracked or collected. It is difficult to estimate exactly how many cases would come to the AGO if this bill passed, and consequently difficult to estimate how many FTE the AGO would need to perform the work required. This fiscal note adopts the projections of the OII, which will be the primary investigating agency for these cases and estimates approximately 220 cases involving use of deadly force per year; and approximately 30 cases per year resulting in death.

Section 7 requires the formation of an advisory board that selects candidates for the IC for the AG to select from. If this bill were enacted, it would take time for this advisory board to be created, supported, and for the board to identify candidates. After the AG hires an IC, the AG by statute is essentially removed from the decision-making of the new division. Consequently, the new division cannot be formed until an IC is hired; and the new division cannot review or prosecute cases until the IC has had an opportunity to staff an entire division. This will take time and should be considered when determining when to fund this division and when to make it active. The board must also research the history of the candidates, including criminal history, disciplinary history, social media, etc. The Administrative Division (ADM) Policy Unit would be tasked with creating, maintaining, and supporting the advisory board, and providing a required report to the legislature in 2026.

Sections 1, 2 and 3 give the OIP authority or jurisdiction over officer use of deadly force cases. The fiscal note assumes that over time almost all, if not all, such cases will be reviewed by the AGO despite the concurrent jurisdiction of the county prosecutors. This presumption is based upon (a) the high bar set forth in the bill for county prosecutors to overcome a presumption of conflict, and (b) the perceived likelihood that understaffed prosecutors’ offices with high caseloads will want the AGO to handle these expensive and difficult cases at no cost to the county prosecutor, similar to what happened when the Legislature passed the Community Protection Act of 1990 and gave concurrent authority to the AGO and counties for expensive, time-consuming sexually violent predator (SVP) cases. The AGO now handles all SVP cases in 38 of the 39 counties at the request of the county prosecutors. 2SHB 1579 allows the county prosecutor to review use of deadly force cases if the prosecutor has no conflict of interest. Those cases where the county prosecutor recognizes a conflict, or that are reviewed but not charged by the county, then come to the AGO for review. This will likely be the vast majority of cases. If the county prosecutor determines they have no conflict and charge a case, the AGO still reviews the case and the AGO can also charge the case if it believes greater charges should have been filed (unlikely but possible). In short, every single case of officer use of deadly force will be reviewed by the AGO under 2SHB 1579 regardless of what the county prosecutor does. Many cases will be voluminous and require intense and lengthy review, others less so. Some will require years of litigation, others none. The AGO would be tasked by this bill with reviewing each case for potential criminal charges; and filing and litigating those cases that warrant criminal charges (as well as appeals and other post-conviction

litigation). The following needs are based upon best estimates considering all of these circumstances.

Handle 12-20 use of deadly force cases at any given time. 220 cases per year divided by 18 AAGs (three MAAG and 15 AAG) averages 12 cases per attorney. However, some cases may last years, especially those that are charged and tried, and over time caseloads would be expected to build for each AAG. The MAAGs and AAGs would also have other duties in addition to their cases (public records responses and reviews, administrative and supervisory tasks, internal team meetings, responding to constituent correspondence, training, meetings with stakeholders, bill analyses, etc.)

The AGO assumes the new division will be located in Thurston County and additional lease space will be necessary for staff. The AGO assumes \$550,000 per FY based on current lease contract rates in the Bristol Court Office Building.

Expert Witnesses: \$1 million per FY.

Some cases will require no paid expert consultation while other cases will require extensive use of experts (use of force experts, pathologists, medical experts, audio and video experts, etc.). The AGO may need to hire an independent attorney, or SAAG, for (a) conflict cases where a state agency client of the AGO is involved, or the AGO for whatever other reason has a conflict of interest, or (b) caseloads are more than projected or more than current staff can handle and hiring outside help becomes necessary.

Litigation Travel: \$250,000 per FY.

AAG Travel: \$220,000 per FY for potential crime scene response; attend autopsies; meetings with investigators; meetings with medical examiner and doctors; meetings with injured person or family of deceased; interviewing witnesses; attend defense interviews, court appearances, and trial.

CVA Travel: \$20,000 per FY;

PLs Travel for Trials: \$10,000 per FY.

Contract interpreter services: \$150,000 per FY (\$150 per hour x 1,000 estimated annual hours)

For witnesses, injured parties, or family of deceased where English is not their first language.

Data storage costs: \$250,000 per FY

For anticipated large volumes of video evidence (police body-worn camera video, police dash camera video, cell phone video, doorbell video, store security camera video).

Video Files (720p HD at 30 frames per sec) and 3.5 gigabyte (GB) per hour.

10 Videos per Case at 35 GB per case.

50 Cases per FY = 1,750 GB per FY.

Everlaw Cost (2023 estimated rate) totals \$9,960 per fiscal month.

\$119,520 annual cost is rounded up to \$120,000 per FY.

File retention from the previous FY is required as well as new electronic files for the current FY.

Statutorily required regular training (Section 10): \$50,000 per FY

AGO support for Advisory Board (Section 7): \$14,500 per FY for fiscal years 2025-2026.

Sec. 2. Amendment to RCW 43.10.232 (Attorney General - Concurrent authority to investigate crimes and initiate and conduct prosecutions). Renumbering (1) and adding (2) as follows:

(a) The Attorney General's Office of Independent Prosecutions shall have concurrent authority and power with the prosecuting attorneys to review investigations and initiate and conduct prosecutions of crimes involving the use of deadly force by involved officers as described in chapter 43.102 RCW. "Prosecution" includes appeals and requests for postconviction relief.

(b) In any investigation or prosecution pursuant to this subsection, the Office of the Attorney General may prosecute related offenses and defendants. Related offenses and defendants for purposes of this subsection are those offenses and defendants that may be joined as provided by law or by the criminal rules for the Superior Courts of the State of Washington. Related offenses also include any criminal activity related to, or discovered during, the investigation of the case under the jurisdiction of the incident that has a relationship to the investigation.

This section could require additional resources in the Office of Independent Investigations (OII) for staff time to communicate with both the AG staff and local prosecuting authority as conflicts of interest are being determined.

Sec. 19 (9)(a) upon the completion of an investigation authorized under this chapter, the office shall send its completed investigation and referral to both the county prosecuting attorney of the jurisdiction in which the offense occurred and the office of independent prosecutions in accordance with protocols established under RCW 43.102.050(2)(c)(viii), and include any information, if known, regarding the presence of a conflict of interest.

Requires OII to make a referral to both the AG Independent Prosecution as well as the local PA and if known, includes any information regarding the presence of a conflict of interest. This section could require additional resources in the Office of Independent Investigations (OII) for staff time to communicate with both the AG staff and local prosecuting authority.

(9)(b) All employees of the Office of Independent Investigations, and all members of an independent investigations team who participate in the investigation of a use of deadly force by an involved officer as defined in RCW 43.102.010, are encouraged to cooperate fully with requests for interviews or additional information from the office of independent prosecutions.

Encourages OII to cooperate fully with requests for interviews or additional information from the office of independent prosecution. OII has written this into their operating protocols and has already determined this work is standard work for the OII and assumes no fiscal impact.

(9)(c) The Office of Independent Investigations or a member of the independent investigations team that investigated an incident of use of deadly force that is the subject of a review for criminal charges are encouraged to, at the request of the office of independent prosecutions, transport evidence to and from any laboratory, medical examiner's office, or expert witness as directed by the office of independent prosecutions.

Encourages OII to transport evidence to the Office of Independent Prosecution. OII has adopted this as standard work in its protocols and assumes no fiscal impact.

(9)(d) The Office of Independent Investigations or a member of the independent investigations team that investigated an incident of use of deadly force that is the subject of criminal trial proceedings are encouraged to, at the request of the office of independent prosecutions, transport evidence to court as directed by the office of independent prosecutions.

Encourages OII transport evidence in the event there is a criminal trial. OII has adopted this as standard work in its protocols and assumes no fiscal impact.

Based on an average of 27 cases of use of deadly force incidents from 2020 - 2023 (39, 13, 32, and 21 cases, respectively), OII assumes an ongoing increase for AGO costs at \$144,000 per fiscal year starting in FY 2025.
