Part IV: Analysis

A. SUMMARY OF BILL

Description of the bill with an emphasis on how it impacts local government.

Section 1 adds a new section stating the legislature's intent to protect private property rights.

Section 2 amends RCW 7.28.050 to add a new subsection (2) which states that open and notorious possession claims cannot be used to divest the property owner of property in line boundary disputes by abutting or adjacent property owners

Section 3 amends RCW 7.28.083 to remove subsection (3) which assigns the right for a prevailing party in an adverse possession action to request that the court award costs and reasonable attorney's fees.

Section 4 is a new section that repeals RCW 7.28.100 which references RCW 7.28.050 through 7.28.100 related to adverse possession recovery rights and requirements.

This legislation takes effect 90 days after the legislative session in which the bill is passed.
