## HOUSE BILL 1129

State of Washington 65th Legislature 2017 Regular Session

- AN ACT Relating to providing associate degree education to 1 2 enhance education opportunities and public safety; amending RCW 72.09.460 and 72.09.465; adding a new section to chapter 28B.50 RCW; 3

- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON: 5
- 6 NEW SECTION. Sec. 1. (1) The legislature finds that studies 7 clearly and consistently demonstrate that incarcerated adults who obtain associate degree education and training are more likely to be 8 employed following release, which leads to a dramatic reduction in 9 10 recidivism rates, significant improvements in public safety, and a 11 major return on investment. The legislature finds that reducing 12 recidivism would decrease the financial burden to taxpayers and the emotional burden of victims. 13
  - (2) The legislature finds that research indicates that associate degree education and training is an effective evidence-based practice for reducing recidivism. An analysis commissioned by the United States department of justice determined that adults who received such education while incarcerated were forty-three percent less likely to recidivate.
- 20 (3) Ninety-five percent of incarcerated adults ultimately return 21 to their communities to obtain employment and contribute to society.

The legislature finds that according to the bureau of labor statistics, unemployment rates for people with only a high school education are twice that of those with an associate degree. Research has shown that adults who participated in such education while incarcerated were thirteen percent more likely to be employed.

- (4) The legislature further finds that correctional education is cost-effective. A 2014 study by the Washington state institute for public policy estimated that the state received a return on investment of twenty dollars for every dollar invested in correctional education.
- 11 (5) It is the intent of the legislature to enhance public safety 12 by reducing crime and increasing employment rates in a cost-effective 13 manner by authorizing associate degree education and training of 14 incarcerated adults through expanded partnerships between the 15 community and technical colleges and the department of corrections.
- NEW SECTION. Sec. 2. A new section is added to chapter 28B.50 RCW to read as follows:
- The college board may authorize any board of trustees within the system to promote and conduct associate degree education and training of incarcerated adults through new or expanded partnerships between the community and technical colleges and the department of corrections.
- 23 **Sec. 3.** RCW 72.09.460 and 2013 c 39 s 24 are each amended to 24 read as follows:
  - (1) Recognizing that there is a positive correlation between education opportunities and reduced recidivism, it is the intent of the legislature to offer appropriate associate degree opportunities to inmates.
- (2) The legislature intends that all inmates be required to 29 participate in department-approved education programs, work programs, 30 or both, unless exempted as specifically provided in this section. 31 Eligible inmates who refuse to participate in available education or 32 33 work programs available at no charge to the inmates shall lose 34 privileges according to the system established under RCW 72.09.130. Eligible inmates who are required to contribute financially to an 35 36 education or work program and refuse to contribute shall be placed in 37 another work program. Refusal to contribute shall not result in a loss of privileges. 38

 $((\frac{2}{2}))$  (3) The legislature recognizes more inmates may agree to participate in education and work programs than are available. The department must make every effort to achieve maximum public benefit by placing inmates in available and appropriate education and work programs.

- $((\frac{3}{3}))$  (4) (a) The department shall, to the extent possible and considering all available funds, prioritize its resources to meet the following goals for inmates in the order listed:
- (i) Achievement of basic academic skills through obtaining a high school diploma or a high school equivalency certificate as provided in RCW 28B.50.536;
- (ii) Achievement of vocational skills necessary for purposes of work programs and for an inmate to qualify for work upon release;
- (iii) Additional work and education programs necessary for compliance with an offender's individual reentry plan under RCW 72.09.270 ((with the exception of postsecondary education degree programs as provided in RCW 72.09.465)); and
- (iv) Other appropriate vocational, work, or education programs 18 that are not necessary for compliance with an offender's individual reentry plan under RCW 72.09.270 ((with the exception of 21 postsecondary)) including associate degree education ((degree)) programs ((as provided in RCW 72.09.465)). 22
  - (b) If programming is provided pursuant to (a)(i) through (iii) of this subsection, the department shall pay the cost of such programming, including but not limited to books, materials, and supplies((, and postage costs related to correspondence courses)).
  - (c) If programming is provided pursuant to (a)(iv) of this subsection, inmates shall be required to pay all or a portion of the costs, including books, fees, and tuition, for participation in any vocational, work, or education program as provided in department policies. Department policies shall include a formula for determining how much an offender shall be required to pay. The formula shall include steps which correlate to an offender average monthly income or average available balance in a personal inmate savings account and which are correlated to a prorated portion or percent of the per credit fee for tuition, books, or other ancillary costs. The formula shall be reviewed every two years. A third party may pay directly to the department all or a portion of costs and tuition for any programming provided pursuant to (a)(iv) of this subsection on behalf

p. 3 HB 1129 of an inmate. Such payments shall not be subject to any of the deductions as provided in this chapter.

- (d) The department may accept any and all donations and grants of money, equipment, supplies, materials, and services from any third party, including but not limited to nonprofit entities, and may receive, utilize, and dispose of same to complete the purposes of this section.
- (e) Any funds collected by the department under (c) and (d) of this subsection and subsections  $((\frac{8)}{\text{and}})$  (9) and (10) of this section shall be used solely for the creation, maintenance, or expansion of inmate educational and vocational programs.
- (((4+))) (5) The department shall provide access to a program of education to all offenders who are under the age of eighteen and who have not met high school graduation requirements or requirements to earn a high school equivalency certificate as provided in RCW 28B.50.536 in accordance with chapter 28A.193 RCW. The program of education established by the department and education provider under RCW 28A.193.020 for offenders under the age of eighteen must provide each offender a choice of curriculum that will assist the inmate in achieving a high school diploma or high school equivalency certificate. The program of education may include but not be limited to basic education, prevocational training, work ethic skills, conflict resolution counseling, substance abuse intervention, and anger management counseling. The curriculum may balance these and other rehabilitation, work, and training components.
- (((5))) (6)(a) In addition to the policies set forth in this section, the department shall consider the following factors in establishing criteria for assessing the inclusion of education and work programs in an inmate's individual reentry plan and in placing inmates in education and work programs:
- (i) An inmate's release date and custody level. An inmate shall not be precluded from participating in an education or work program solely on the basis of his or her release date, except that inmates with a release date of more than one hundred twenty months in the future shall not comprise more than ten percent of inmates participating in a new class I correctional industry not in existence on June 10, 2004;
  - (ii) An inmate's education history and basic academic skills;
  - (iii) An inmate's work history and vocational or work skills;

1 (iv) An inmate's economic circumstances, including but not 2 limited to an inmate's family support obligations; and

- (v) Where applicable, an inmate's prior performance in department-approved education or work programs;
- (b) The department shall establish, and periodically review, inmate behavior standards and program goals for all education and work programs. Inmates shall be notified of applicable behavior standards and program goals prior to placement in an education or work program and shall be removed from the education or work program if they consistently fail to meet the standards or goals.
- (((6))) (7) Eligible inmates who refuse to participate in available education or work programs available at no charge to the inmates shall lose privileges according to the system established under RCW 72.09.130. Eligible inmates who are required to contribute financially to an education or work program and refuse to contribute shall be placed in another work program. Refusal to contribute shall not result in a loss of privileges.
- (((+7))) (8) The department shall establish, by rule, objective medical standards to determine when an inmate is physically or mentally unable to participate in available education or work programs. When the department determines an inmate is permanently unable to participate in any available education or work program due to a health condition, the inmate is exempt from the requirement under subsection (((+1))) (2) of this section. When the department determines an inmate is temporarily unable to participate in an education or work program due to a medical condition, the inmate is exempt from the requirement of subsection (((+1))) (2) of this section for the period of time he or she is temporarily disabled. The department shall periodically review the medical condition of all inmates with temporary disabilities to ensure the earliest possible entry or reentry by inmates into available programming.
- ((\(\frac{(\(\frac{8}\)}\))) (9) The department shall establish policies requiring an offender to pay all or a portion of the costs and tuition for any vocational training or postsecondary education program if the offender previously abandoned coursework related to associate degree education or vocational training without excuse as defined in rule by the department. Department policies shall include a formula for determining how much an offender shall be required to pay. The formula shall include steps which correlate to an offender average monthly income or average available balance in a personal inmate

- savings account and which are correlated to a prorated portion or percent of the per credit fee for tuition, books, or other ancillary costs. The formula shall be reviewed every two years. A third party may pay directly to the department all or a portion of costs and tuition for any program on behalf of an inmate under this subsection. Such payments shall not be subject to any of the deductions as provided in this chapter.
- 8 ((<del>(9)</del>)) <u>(10)</u> Notwithstanding any other provision in this section, 9 an inmate sentenced to life without the possibility of release, 10 sentenced to death under chapter 10.95 RCW, or subject to the 11 provisions of 8 U.S.C. Sec. 1227:
- 12 (a) Shall not be required to participate in education programming 13 except as may be necessary for the maintenance of discipline and 14 security;
- 15 (b) May <u>not</u> receive ((<del>not more than one postsecondary</del>)) <u>an</u> 16 <u>associate</u> academic degree in a program offered by the department or 17 its contracted providers;
  - (c) May participate in prevocational or vocational training that may be necessary to participate in a work program;
- 20 (d) Shall be subject to the applicable provisions of this chapter 21 relating to inmate financial responsibility for programming.

- 22 **Sec. 4.** RCW 72.09.465 and 2016 sp.s. c 36 s 946 are each amended 23 to read as follows:
  - (1) The department ((shall, if funds are appropriated for the specific purpose,)) may implement ((postsecondary)) associate degree education ((degree)) programs ((within)) at state correctional institutions((, including the state correctional institution with the largest population of female inmates)).
